richard hakluyt and travel writing in early modern europe is an interdisciplinary collection of 24 essays which brings together leading international scholarship on hakluyt and his work best known as editor of the principal navigations 1589 expanded 1598 1600 hakluyt was a key figure in promoting english colonial and commercial expansion in the early modern period he also translated major european travel texts championed english settlement in north america and promoted global trade and exploration via a northeast and northwest passage his work spanned every area of english activity and aspiration from muscovy to america from africa to the near east and india to china and japan providing up to date information and establishing an ideological framework for english rivalries with spain portugal france and the netherlands this volume resituates hakluyt in the political economic and intellectual context of his time the genre of the travel collection to which he contributed emerged from continental humanist literary culture hakluyt adapted this tradition for nationalistic purposes by locating a purported history of english enterprise that stretched as far back as he could go in recovering antiquarian records the essays in this collection advance the study of hakluyt's literary and historical resources his international connections and his rhetorical and editorial practice the volume is divided into 5 sections hakluyt s contexts early modern travel writing collections editorial practice allegiances and ideologies politics religion nation and hakluyt rhetoric and writing the volume concludes with an account of the formation and ethos of the hakluyt society founded in 1846 which has continued his project to edit travel accounts of trade exploration and adventure

the period between 1917 and 1957 starting with the birth of the user and the american intervention in the first world war and ending with the treaty of rome is of the utmost importance for contextualizing and understanding the intellectual origins of the european community during this time of crisis many contemporaries especially intellectuals felt they faced a momentous decision which could bring about a radically different future the understanding of what europe was and what it should be was questioned in a profound way forcing europeans to react the idea of a specifically european unity finally became at least for some a feasible project not only to avoid another war but

to avoid the destruction of the idea of european unity this volume reassesses the relationship between ideas of europe and the european project and reconsiders the impact of long and short term political transformations on assumptions about the continent s scope nature role and significance

this festschrift was presented in electronic form to buchanan on the occasion of his eightieth birthday on october 3 1999 after dinner in fairfax virginia as one might have expected the response to our call for papers was vo luminous in looking over the many contributions we felt that a published festschrift was also possible and fitting for the eightieth birthday of so prodi gious and influential a scholar as professor buchanan to that end we have assembled the following volume in selecting the papers to be included here we have basically tried to choose those papers which in some way bear on buchanan's contributions perfectly good papers about issues not related to buchanan's research agenda or not referring directly to buchanan's work were not included space constraints did not allow universal coverage so choices had to be made it should be stated clearly that these were our choices based on the criterion that the contribution be relevant to buchanan s work buchanan had nothing whatsoever to do with the selection of papers for this volume once choices had been made we arranged the papers by subject matter ranging from various aspects of buchanan s work in economics political science philosophy and related areas to some more personal recollections of jim as a professor friend and colleague including the latter material was also our decision and this probably represents a choice with which jim would not have agreed we think however that the reader will find these pieces interesting and informative

the disparagement of multilingualism is a european development of the 18th and 19th centuries in which one national language and national literature were advocated established and institutionalised multilingual writers made use of the creative potential of several languages even then however they often adapted to an increasingly monolingual book market which made their individual multilingualism invisible this is evident in literary historiography which established a monolingual national canon researching hidden multilingualism is often difficult since multilingual texts by multilingual writers were often not published or were published in a monolingual version sources are scarce literary histories of the time often do not mention multilingualism furthermore many multilingual writers were members of minority groups women jewish non european and thus often neglected the volume offers methods and theories to systematically approach this hidden material as well as case studies on authors and national literatures in a multilingual context it thus contributes to the restructuring of a multilingual transnational literary history that is applicable to

different philologies

the european union entered into an economic crisis in late 2009 that was sparked by bank bailouts and led to large unsustainable sovereign debt the crisis was european in scale but hit some countries in the eurozone harder than others despite the plethora of writings devoted to the economic crisis in europe present understandings of how the political decisions would influence the integration project continue to remain vague what does it actually mean to be european is europe still a collection of peoples that rallied together during good times and then retreat to nationalism when challenges appear or has europe adopted a common identity that would foster solidarity during hard times this book provides its reader with a fresh perspective on the importance identity has on the functioning of the european union as exemplified in jürgen habermas seminal text the crisis of the european union a response rather than exploring the causes of the crisis the contributors examine the current state of european identity to determine the likelihood of implementing habermas suggestions the contributor s interdisciplinary approach is organized into four parts and examines the following key areas of concern habermas arguments placing them into their historical context to which degree do europeans share the ideals habermas describes as crucial to his program of reform influence of habermas cosmopolitanism through religious and literary lenses impact of habermas notions in the arenas of education national economies austerity and human rights jürgen habermas and the european economic crisis will be read by scholars in the fields of political theory and philosophy european politics and cultural studies

europe is struggling its challenges include weak economic growth demographic trends that undermine the sustainability of social and other programs migration brexit the unfinished euro architecture and much more this volume of research in political sociology seeks to adopt a longer view to make sense of europe s current malaise

despite or perhaps because of the rejection of the eu constitutional treaty eventually leading to the adoption of the lisbon treaty the debates concerning the european union s constitutional framework continue this book builds on the discourse in european union constitutionalism in order to offer a novel analysis of the eu s constitutional developments the book considers the constitutional trends of the process of eu integration before applying a transdisciplinary concept of complexity developed in the work of edgar morin to the eu in doing this giuseppe martinico sets out a unique account of eu constitutionalism which argues that the eu legal order is a complex entity which shares some features with complex natural systems the book then goes on to explore the methodological implications of such constitutional complexity for the study of eu law

these essays on war resistance and counter resistance represent an original approach to understanding how political constraints on human behavior and the resistance movements to which these restrictions give rise produce counter resistant forces which represent new constraints which in turn often generate new and innovative behaviors which sometimes create new crystallizations of cultural expression and occasionally influence institutions and traditions this new anthology offers a unique analysis of the important role political constraints play in the production of creative thinking and the development of systematic projects aimed at human liberation in the preface francis feeley clearly states the purpose of this book which is to demonstrate how resistance movements have often given birth to counter resistance measures employed mostly by state agencies aimed at stifling the self realization of certain groups and promoting the self realization of other organized interests the following essays are a composite of writings by political activists poets and academic scholars the introduction offers a brief description of major resistance movements in the united states this historical overview presents a context for the appearance of the 20th century resistance movements described in the following chapters we are alerted from the start that one of the unifying themes of these essays is the dialectical relationship between social movements and political institutions producing democracy within american institutions another theme will be how these social contradictions which generate the growth of democracy have proven time and again to operate beyond the control of capitalist interests both in france and within the united states thereby giving rise to many species of democratic expression gilles vachon s description of his childhood impressions of paris under the german occupation offers new insights into micro resistance at the level of alternative perceptions and subliminal communications george brown s contribution to the thesis of this book although first published in 1978 is his self conscious description of one man entering into a dialectical relationship with prison reforms which pushed him into a deeper understanding of the injustices that he had suffered as a child and young adult

growing up black in the united states in the third chapter of this book francis feeley uncovers the economic interests behind the production of political repression his analysis of the homeland security act and the growth of surveillance and security industry that it gave rise to supports the main thesis of this book namely that the contradictions which generate democracy exist beyond the control and very often beyond the apprehension of the society in which they are created patrick litsangou s essay in chapter 4 contributes to our understanding of the dialectical relationship between the mainstream media and the alternative media in the period of the u s military invasion of iraq he illustrates in this essay how the demise of mainstream medias independence gave rise to the extraordinary success of the alternative media as large numbers of people living within the united states vigorously struggled to stay informed in order to understand the palpable contradictions in their lives in the fifth chapter peterson nnajiofor recounts the histories of resistance and counter resistance around the aggressive activities of us petroleum companies in the niger delta where class warfare has produced strategies and counter tactics that have been evolving for decades in the relationships between the inhabitants of the region and the transnational corporations which control their political economy to the almost unimaginable detriment of the environment the last chapter of this book is an excerpt from professor anthony wilden s classic work man and woman war and peace the strategists companion new york 1987 despite having been published more than two decades ago this theoretical study stands as a contemporary statement on the epistemology of strategic thought the indirect approach described here by wilden complements professor feeley s thesis that the forces of resistance and the forces of counter resistance are intimately related that from this interrelationship new cultural expressions are created some of which have long term effects on the society in which they occur the formation of a revolutionary counterculture is but one example of the effects of this power interface as professor wilden notes no confrontation occurs without some structural modification taking place the forces of order are never the same after they successfully repress the forces of change and guerrilla warfare tactics are constantly evolving adapting to new conditions professor feeley concludes this anthology by attempting to synthesize the main ideas presented in the seven essays in this book the main thread running through these chapters is the idea that cultural order cannot be reduced to the natural order this idea is clearly expressed in each of the essays found in this book and the conclusion convincingly states the view that social science like all other cultural expressions exists beyond being in the realm of becoming

collecting in full for the first time the correspondence between ezra pound and members of leo frobenius forschungsinstitut für kulturmorphologie in frankfurt across a 30 year period this book sheds new light on an important but previously unexplored influence on pound s controversial intellectual development in the fascist era ezra pound s long term interest in anthropology and ethnography exerted a profound influence on early 20th century literary modernism these letters reveal the extent of the influence of frobenius concept of paideuma on pound s poetic and political writings during this period and his growing engagement with the culture of nazi germany annotated throughout the letters are supported by contextualising essays by leading modernist scholars as well as relevant contemporary published articles by pound himself and his leading correspondent at the institute the american douglas c fox

in recent scholarly work t s eliot has usually been associated with cultural elitism and political conservatism or even with proto fascism and anti semitism this book proposes a different view during the interbellum eliot and his review the criterion were part of an international network of intellectuals that shared an open minded europeanness authors like t mann benda ortega y gasset curtius and hofmannsthal emphasized their common european roots and shared cultural legacy their classicism stands in the european tradition of humanism and has remained highly relevant classicist ideas about literature education and human culture in general continue to inspire contemporary humanist thinkers as the second part of this book demonstrates by discussing the work of ferry todorov steiner scruton toulmin and others

this collection of articles devoted to europe was born from the urgent need to present the specificity of european culture both its unity and diversity and at the same time create a stimulating dialogue about european culture and its complexities european culture considered as all inherited beliefs and values behind social action has been treated in the past as a complex phenomenon of superior value as the result of a common past among european nations the permeation of various cultural elements between cultures and their absorption in different contexts in the past the process of shaping european identity was often fierce and dramatic influenced by the events taking place

within but also outside european borders now it has undergone various transformations as a result of new political economic and cultural challenges for this reason the authors and editors of this volume place emphasis on diachronic perspectives their approaches often consider local european issues against a global background

imagining europe essays on the past present and future of the european union examines the eu from a variety of perspectives the collection begins with the expectation that despite its challenges the european union is here to say but it also proceeds from the premise that imaginative thinking is necessary to guide the 27 member organization into the future the book offers nine chapters and a substantive introduction to examine the eu from the point of view of a commercial enterprise the writings of josé ortega y gasset immigration and public opinion its relationship with china its management of political populism the american federalist papers and more the first chapter is a summary of the history structure and processes of the european union for the convenience of those using this text in the classroom the last chapter considers this latest chapter of european development in light of the historical quest for a united europe the contributors to the volume are scholars residing in the u s poland france switzerland the czech republic and turkey
