the ideological origins of the british empire presents a comprehensive history of british conceptions of empire for more than half a century david armitage traces the emergence of british imperial identity from the mid sixteenth to the mid eighteenth centuries using a full range of manuscript and printed sources by linking the histories of england scotland and ireland with the history of the british empire he demonstrates the importance of ideology as an essential linking between the processes of state formation and empire building this book sheds light on major british political thinkers from sir thomas smith to david hume by providing fascinating accounts of the british problem in the early modern period of the relationship between protestantism and empire of theories of property liberty and political economy in imperial perspective and of the imperial contribution to the emergence of british identities in the atlantic world

the history of the european community european union s ec eu development is a narrative of crises generated and resolved to date the resolution of crises in community affairs has furthered european integration the characteristic

pattern of integration is dialectical two steps forward and one step back with crises both accounting for the steps backward and forward this book examines why the crises were constructively resolved rather than the often explored how of the resolutions this work contends that european myths which emerged from europe s cataclysmic experiences in world war i and ii cement the member states within the ec eu and lead to greater social economic and political integration with the ec eu during the periodic crises the european myths have eliminated every choice except the choice to move european integration forward professor sam sang jo s analysis argues that once the european myths weaken the tensions among eu member states are likely to escalate

this monograph holds that an aura of mythology has surrounded conventional academic and military perceptions of british performance in the realm of irregular warfare it identifies 10 myths regarding british counterinsurgency performance and seeks to puncture them by critically assessing the efficacy of the british way of counterinsurgency from the much vaunted yet over hyped malayan emergency to the withdrawal of combat troops from iraq in 2009 it challenges perceptions of the british military as an effective learning institution when it comes to irregular warfare and critically assesses traditional british counterinsurgency strategic maxims regarding hearts and minds and minimum force

this book is a study of british society it outlines the struggle for social change in britain today from a socialist and left

wing perspective it considers the role of ideas in british politics british history and british society it argues that if britain is to become a better society it needs to develop better ideas specifically the ideas of socialism

this detailed chronological analysis of british world war ii movies from 1939 until the present explores how films projected recognizable stereotypes of british national character and how the times in which a film was made shaped its perspectives several chapters look at films made during and immediately after the war in depictions of the home front characters display resolve as well as emotional restraint and present an image of an undivided society cooperating to fight evil by contrast duty and service are the paramount virtues of combat films while spy melodramas exemplify the british love of improvisation fifties war films are examined against the backdrop of alarm and uncertainty caused by the cold war such films reflect traditional national character stereotypes though the stiff upper lip begins to be questioned by the end of the decade the book then traces the radical effect of the 1960s revolution revealing how the fondness for skeptical antiwar movies went hand in hand with the questioning of britain s place in the world the book ends by looking at recent war films and asks whether these reflect the cult of narcissism so prevalent in modern britain

employing several historical case studies between 1940 2003 and marshalling a host of primary sources william d james argues that british politicians and officials have thought in grand strategic terms under american hegemony even if they do not realise or admit to this

enoch powell s explosive rhetoric against black immigration and anti discrimination law transformed the terrain of british race politics and cast a long shadow over british society using extensive archival research camilla schofield offers a radical reappraisal of powell s political career and insists that his historical significance is inseparable from the political generation he sought to represent enoch powell and the making of postcolonial britain follows powell s trajectory from an officer in the british raj to the centre of british politics and finally to his turn to ulster unionism she argues that powell and the mass movement against new commonwealth immigration that he inspired shed light on britain s war generation popular understandings of the welfare state and the significance of memories of war and empire in the making of postcolonial britain through powell schofield illuminates the complex relationship between british social democracy racism and the politics of imperial decline in britain

the british imperial century provides a concise but comprehensive overview of the formation and administration of the empire from its origins in the early nineteenth century to its climax at mid century and ultimate denouement on the eve of the first world war considering the impact of british imperial rule and influence on subject peoples timothy h parsons

explores the themes of cross cultural social and environmental interaction from a world history perspective he traces the transition from informal to formal empire which broadened and intensified britain s relations with asia africa and the western hemisphere the establishment of extensive colonies and protectorates in africa the occupation of egypt the declaration of the raj in india and increased economic and political intervention in latin america and in the chinese and ottoman empires brought ever larger numbers of non european peoples and cultures under either the influence or direct authority of the british crown by considering british imperialism through the lens of world history parsons moves beyond questions of britain s motives in acquiring more territory to ask how it was able to acquire such an empire as a global network of exchanges the british empire linked disparate regions in a series of distinct but overlapping exchanges by co opting and adapting the values and customs of their subjects imperial rulers strengthened their authority and legitimacy but in doing so produced a hybrid culture that was largely british in style but not entirely british in substance an ambitious and thoughtful contribution the british imperial century will be invaluable for courses on world history and european history and as a supplement for courses on african asian british and middle eastern history

How ideas and ideals of an imagined protean national middle ages have once again become a convergence point for anxieties about politics history and cultural identity in our time and why after a period of abeyance the link forged in the nineteenth century between the middle ages and national identity is increasingly being reclaimed with numerous groups and individuals mining an imagined medieval past to present ideas and ideals of modern nationhood today's national medievalism asserts itself at the interface of culture and politics in literature and television programming in journalism and heritage tourism and in the way political actors of various stripes use a deep past that supposedly proves the nation's steady exceptionalism in a hectic globalised world this book traces these ongoing developments in Switzerland and Britain two countries where the medieval past has recently been much invoked in negotiations of national identity independence and euroscepticism through comparative analysis it explores examples of reemerging stories of national exceptionalism stories that ironically echo those of other nations the author analyses depictions of Robert the Bruce and Wilhelm Tell medievalism in the discourse surrounding Brexit as well as at the Welsh Senedd novels like Paul Kingsnorth's *The Wake* community based art such as the Great Tapestry of Scotland and elaborate public commemorations of Swiss victories and defeats in battle basing his critical readings in current theories of cultural memory heritage and nationalism the author explores how the protean national middle ages have once again become a convergence point for anxieties about politics history and cultural identity in our time and why

In the context of renewed debates about diversity and cohesion this book interrogates contemporary claims about race and migration it demonstrates that many of the claims are myths presenting evidence in support of and in opposition to them in an accessible yet academically rigorous manner the book combines an easy to read overview of the subject with innovative new research it tackles head on questions about levels of immigration the contribution of immigrants minority self segregation ghettoisation and the future diversity of the population the authors argue that the myths of race and migration are the real threat to an integrated society and recommend that focus should return to problems of inequality and prejudice

Counterinsurgency has staked its claim in the new century as the new American way of war yet the wars in Afghanistan and Iraq have revived a historical debate about the costs monetary political and moral of operations designed to eliminate insurgents and build nations today's counterinsurgency proponents point to small wars past to support their view that the enemy is biddable if the correct tactical formulas are applied Douglas Porch's sweeping history of

counterinsurgency campaigns carried out by the three providential nations of france britain and the united states ranging from nineteenth century colonial conquests to general petraeus surge in iraq challenges the contemporary mythologising of counterinsurgency as a humane way of war the reality he reveals is that hearts and minds has never been a recipe for lasting stability and that past counterinsurgency campaigns have succeeded not through state building but by shattering and dividing societies while unsettling civil military relations

in the network of nazi camps across wartime europe prisoner of war institutions were often located next to the slave camps for jews and slavs so that british pows across occupied europe over 200 000 men were witnesses to the holocaust the majority of those incarcerated were aware of the camps but their testimony has never been fully published here using eye witness accounts held by the imperial war museum russell wallis rewrites the history of british prisoners and the holocaust during the second world war he uncovers the histories of men such as cyril rofe an anglo jewish pow who escaped from a work camp in upper silesia and fled eastwards towards the russian lines recounting his shattering experiences of the so called bloodlands of eastern poland wallis also shows how and why the knowledge of those in the armed forces was never fully publicised and how some pow accounts were later exaggerated or fictionalised british pows and the holocaust will be an essential new oral history of the holocaust and an extraordinary insight into what was known and when about the greatest crime of the 20th century
