winner of the 2022 James F. Sulzby Book Award from the Alabama Historical Association, *Alabama Quilts: Wilderness Through World War II, 1682-1950* is a look at the quilts of the state from before Alabama was part of the Mississippi Territory through the Second World War. A period of 268 years, the quilts are examined for their cultural context that is within the community and time in which they were made, the lives of the makers, and the events for which they were made, starting as far back as 1682 with a fragment that research indicates could possibly be the oldest quilt in America. The volume covers quilting in Alabama up through 1950. There are seven sections in the book to represent each time period of quilting in Alabama, and each section discusses the particular factors that influenced the appearance of the quilts, such as migration and population patterns, socioeconomic conditions, political climate, lifestyle, paradigms, and historic events. Interwoven in this narrative are the stories of individuals associated with certain quilts as recorded on quilt documentation forms. The book also includes over 265 beautiful photographs of the quilts and their intricate details. To make this book possible, authors Mary Elizabeth Johnson Huff and Carole Ann King worked with libraries, historic homes, museums, and quilt guilds around the state of Alabama, spending days on formal quilt documentation while also holding lectures across the state and informal quilt sharings. The efforts of the authors involved so many community people: from historians, preservationists, librarians, textile historians, local historians, museum curators, and genealogists to quilt guild members, quilt shop owners, and quilt owners. Making *Alabama Quilts* is not only a celebration of the quilting culture within the state but also the many enthusiasts who have played a role in creating and sustaining this important art.

Bill Traylor (ca. 1853-1949) is regarded today as one of the most important American artists of the twentieth century. A Black man born into slavery in Alabama, he was an eyewitness to history: the Civil War, emancipation, Reconstruction, Jim Crow segregation, the Great Migration, and the steady rise of African American urban culture in the South. Traylor would not live to see the Civil Rights Movement, but he was among those who laid its foundation. Starting around 1939, Traylor, by then in his late eighties and living on the streets of Montgomery, took up pencil and paintbrush to attest to his existence and point of view. In keeping with this radical step, the paintings and drawings he made are visually striking and politically assertive. They include simple yet powerful distillations of tales and memories as well as spare, vibrantly colored abstractions. When Traylor died, he left behind more than one thousand works of art. In *Between Worlds: The Art of Bill Traylor*, Leslie Umberger considers more than two hundred artworks to provide the most comprehensive and in-depth study of the artist to date. She examines his life, art, and powerful drive to bear witness through the only means he had: pictures. The author draws on a wealth of historical documents, including federal and state census records, birth and death certificates, slave schedules, and interviews with family members to clarify the record of Traylor's personal history and family life. The story of his art opens in the late 1930s when Traylor first received attention for his pencil drawings on found board and concludes with the posthumous success of his oeuvre.

Beloved by his soldiers and respected by his enemies, Robert E. Lee is undoubtedly the most popular general in American history to fight on the losing side. This book takes an in-depth look at this Southern gentleman as a strategist and a tactician, covering all of his most important victories and defeats. Although courted by Lincoln, Robert E. Lee could not fight against his native Virginia and joined the Confederacy after assuming command of the Army of Northern Virginia. Lee ran off a string of shocking victories that left the North reeling. However, on two separate occasions, Lee led invasions into the North, and both ended in defeat: first at Antietam and then

at gettysburg encompassing the huge body of research surrounding general lee and presenting it with numerous photographs and newly commissioned artwork this book provides a complete understanding of lee as a battlefield commander

the mississippi river played a decisive role in the american civil war the confederate fortifications that controlled the lower mississippi valley were put to the test in the lengthy federal campaign of 1862 63 vicksburg was a fortress city known as the gibraltar of the confederacy whose capture was seen as the key to victory in the war this book explores the fortifications of the river valley focusing on vicksburg and its defences which boasted a network of forts rifle pits and cannon embrasures surrounding the city as well as examining the strengths and weaknesses of the fortifications when under siege also examined are numerous other fortified strongholds including new orleans port hudson new madrid and forts henry and donelson all lavishly illustrated with full colour artwork and cutaways

martin luther king jr called birmingham alabama the most segregated city in america in 1963 he and other civil rights leaders believed it was time to change that with marches and protests throughout the city civil rights activists hoped the movement would draw national attention hundreds of young african americans joined the cause marching for equal rights angry segregationists reacted violently and it would play out in newspapers and on television screens across the country through dramatic primary source photographs author david aretha explores this crucial struggle of the civil rights movement

stephanie louise kwlek is an american chemist who invented poly paraphenylene terephthalamide better known as kevlar she was born in the pittsburgh suburb of new kensington pennsylvania in 1964 in anticipation of a gasoline shortage her group began searching for a lightweight yet strong fiber to be used in tires the polymers she had been working with at the time formed liquid crystal while in solution something unique to those polymers at the time however kwlek persuaded technician charles smullen to test her solution she was amazed to find that the new fiber would not break when nylon typically would

the civil rights act of 1964 was a momentous victory for civil rights activists but one major obstacle remained in the path toward equal rights for african americans the right to vote in the south segregationists prevented african americans from voting civil rights leaders believed it was time for strong action and chose selma alabama as the rallying point there the marches and protests captured the nation s attention through gripping primary source photographs author david aretha explores this important time in american history

Introductory and instructional videos describe and guide users on ways to access and utilize the remote sensing digital database and the digital image processing lab manual. Answer keys are available for instructors for questions in the text as well as the digital image processing lab manual.

The melting pot, the land of the free, the land of opportunity—these tropes or nicknames apparently reflect the freedom and open-armed welcome that the United States of America offers. However, the chronicles of history do not complement that image. These historical happenings have not often been brought into the focus of modernist literary criticism, though their existence in the record is clear. This book aims to discuss these chronicles, displaying in great detail the underpinnings and subtle references of racism and xenophobia embedded so deeply in both fictional and real personas, whether they are characters, writers, legislators, or the common people. In the main chapters, literary works are dissected so as to underline the intolerance hidden behind words of righteousness and blind trust, as if such is the norm. Though history is taught, it is not so thoroughly examined. To our misfortune, we naively think that bigoted ideas are not a thing we could become afflicted with; they are antiques from the past yet they possessed many hundreds of people, and they surround us still. Since we've experienced very little change, it seems discipline is necessary to truly attempt to be rid of these ideas.

This book argues for the importance of bringing women and gender more directly into the dynamic field of exposition studies, reclaiming women for the history of world fairs, 1876-1937. It also seeks to introduce new voices into these studies, dialoguing across disciplinary and national historiographies. From the outset, women participated not only as spectators but also as artists, writers, educators, artisans, and workers without figuring among the organizers of international exhibitions until the 20th century. Their presence became more pointedly acknowledged as feminist movements developed within the western world, and specific spaces dedicated to women's achievements emerged. International exhibitions emerged as showcases of modernity and progress but also as windows onto the foreign, the different, the unexpected, and the spectacular. As public rituals of celebration, they transposed national ceremonies and protests onto an international stage for spectators.

exhibitions brought the world home for organizers the entire world was a fair women were actors and writers of the fair narrative although acknowledgment of their contribution was uneven and often ephemeral uncovering such silence highlights how gendered the triumphant history of modernity was and reveals the ways women as a category engaged with modern life within that quintessential modern space the world fair
