a provocative exploration of how america s democratic crisis is rooted in a dangerous mismatch between our constitution and today s nationalized partisan politics the ground beneath american political institutions has moved with national politics subsuming and transforming the local as a result american democracy is in trouble in this paradigm shifting book political scientists paul pierson and eric schickler bring a sharp new perspective to today s challenges attentive to the different coalitions interests and incentives that define the democratic and republican parties they show how contemporary polarization emerged in a rapidly nationalizing country and how it differs from polarization in past eras in earlier periods three key features of the political landscape state parties interest groups and media varied locally and reinforced the nation s stark regional diversity but this began to change in the 1960s as the two parties assumed clearer ideological identities and the power of the national government expanded raising the stakes of conflict together with technological and economic change these developments have reconfigured state parties interest groups and media in self reinforcing ways the result is that today s

polarization is self perpetuating and intensifying partisan nation offers a powerful caution as a result of this polarization america s political system is distinctly and acutely vulnerable to an authoritarian movement emerging in the contemporary republican party which has both the motive and the means to exploit america s unusual constitutional design combining the precision and acuity characteristic of their earlier work pierson and schickler explain what these developments mean for american governance and democracy

in response to concerns that the educational system from public schools through colleges universities and apprenticeship programs cannot adequately prepare students for work in the new economy integrating school and workplace learning in canada proposes alternation a hybrid form of learning that by combining experiential and cognitive learning skills allows individuals to develop the relevant skills and intellectual capabilities to address and solve complex problems encountered in the workplace alternation involves not only a curricular balance between the theoretical and the practical but also two distinct venues for learning the classroom and the workplace the authors discuss cognitive and social learning its implementation in a variety of settings its role in smoothing the school work transition process and its potential to contribute to the knowledge and skills needed by the workforce they bring a wide range of disciplinary perspectives to bear in their analyses of the principles and practices of alternation providing historical theoretical and practical insights their analysis contributes to and extends the current debate and discussion surrounding necessary changes in our education and training practices

the past two decades of politics in washington have seen increased partisanship prolonged stalemates and numerous scandals for today s teenagers and young adults years of ineffective and inefficient political leadership have completely eroded any sense that politicians or government have the ability to do good or effect positive change worse the mean spirited dysfunctional political system that has come to characterize american politics has turned young people off to the idea of running for office with more than 500 000 elected positions in the united states what will happen when this generation is expected to take the reins of political power through an original national survey of more than 4 000 high school and college students as well as more than 100 in depth interviews jennifer l lawless and richard l fox find that young americans feel completely alienated from contemporary politics and express little ambition or aspiration to run for office in the future the overwhelming majority see nothing particularly noble about those currently in office viewing most as dishonest self interested and disinterested in helping their constituents these young people want to improve their communities and enact change in the world but they don t think politics is the way to achieve these goals in fact they look disdainfully upon the prospects of growing up to be a mayor governor senator or even president of the united states running from office explores young people s opinions about contemporary politics and their political ambition or lack of it the book paints a political profile of the next generation that should sound alarm bells about the long term deeply embedded damage contemporary politics has wrought on u s democracy and its youngest citizens as disheartening as their conclusions sound lawless and fox end with practical suggestions for how new technologies national service programs and well strategized public service campaigns could generate political ambition in young people today s high school and college students care deeply about improving the future and it s not too late to ensure that they view running for office as an effective way to do so
