an analysis of the production and consumption of the communications of make poverty history a high profile episode of social movement protest in the uk the book follows the campaign throughout its lifetime and explores how attitudes towards government and political opportunities influenced the negotiation of communications

this comparative study looks at the laws concerning the murder of slaves by their masters and at how these laws were implemented andrew t fede cites a wide range of cases across time place and circumstance to illuminate legal judicial and other complexities surrounding this regrettably common occurrence these laws had evolved to limit in different ways the masters rights to severely punish and even kill their slaves while protecting valuable enslaved people understood as property from wanton destruction by hirers overseers and poor whites who did not own slaves to explore the conflicts of masters rights with state and colonial laws fede shows how slave homicide law evolved and was enforced not only in the united states but also in ancient roman visigoth spanish portuguese french and british jurisdictions his comparative approach reveals how legal reforms regarding slave homicide in antebellum times like past reforms dictated by emperors and kings were the products of changing perceptions of the interests of the public of the individual slave owners and of the slave owners families heirs and creditors although some slave murders came to be regarded as capital offenses the laws consistently reinforced the second class status of slaves this influence fede concludes flowed over into the application of law to free african americans and would even make itself felt in the legal attitudes that underlay the jim crow era

reconstructing identities in higher education the rise of third space professionals draws on studies conducted in australia the united kingdom and the united states to explore the roles and identities of a growing number of staff associated with broadly based institutional projects such as student life and welfare widening participation learning support community partnership research and business partnership and institutional research thus at the same time as professional staff are acquiring academic credentials some academic staff are moving in a more project oriented direction this has effectively created a third space between professional and academic spheres in which lateral interactions involving teams and networks occur in parallel with formal institutional structures and processes and give rise to new forms of management and leadership yet such developments have tended to occur under the radar and have not been fully articulated the concept of third space is offered as a way of exploring the knowledges relationships legitimacies and languages that characterise those who work in less boundaried roles and the implications of these developments for both individuals and institutions the ability to problematise and accommodate a series of paradoxes and tensions for instance between formal and more open ended structures and relationships would appear to be at the heart of working in third space individuals also grapple with the fact that third space can at one and the same time be a safe haven for experimentation and creativity and also a risky space in which there is likely to be contestation and uncertainty the text is addressed to professional and academic staff who by design or default for long or short periods find themselves working in third space environments to those to whom

such staff may be responsible including senior management teams and also to researchers interested in changing identities in higher education

in a cogent detailed analysis the author reconstructs the legal order of the european union in a way that best gives meaning to the treaties the case law of the court of justice and the various underlying principles of integration that have emerged over the decades he focuses on instances or touchstones in relation to which eu law seems to be building and integrating an ordre public among these are the following international trade law and arbitration public international law the echr and ecthr public policy exceptions to the four freedoms european citizenship competition law national and eu procedural law and protection of social and labour standards in depth inquiry into questions which seem subject to very specific limitations such as when national or eu courts are under an obligation to raise issues of eu law of their own motion or norms from which private parties may not deviate captures the breadth of the eu ordre public greatly clarifying the concept and the variety of ways it operates seeking to reconcile numerous strands and processes of eu law in a principled manner the book reveals a significant potential for a deeper constitutional framework defining the eu ordre public and putting it into operation as a tool to help ensure unity in diversity it will be welcomed and read closely by jurists policymakers and interested academics in europe and wherever the matter of european integration is studied

offers a new perspective on the making of colonial education and the history of modern schooling in india
