Example: $\int_0^1 x dx$ calculates the area under the curve $y = x$ between $x = 0$ and $x = 1$. The result is a numerical value ($1/3$ in this case).

2.2 Indefinite Integrals: These integrals find a family of functions whose derivative is the original function $f(x)$. They represent the antiderivative and are written as: $\int f(x) dx = F(x) + C$ where: \int is the integral symbol. $f(x)$ is the function being integrated. $F(x)$ is the antiderivative of $f(x)$ (a function whose derivative is $f(x)$). C is the constant of integration, representing a family of functions, each differing by a constant. Example: $\int 2x dx = x^2 + C$. The derivative of $x^2 + C$ (for any constant C) is $2x$.

3. Visualizing Integration: Area Under a Curve

A common and intuitive way to visualize integration is by considering the area under a curve.
