inhaltsangabe problemstellung die beteiligungsfinanzierung durch aktienemissionen hat für deutsche unternehmen sukzessive an bedeutung gewonnen insbesondere die große und stetig anwachsende anzahl an initial public offerings ipos ist ein für den heimischen kapitalmarkt junges phänomen das bislang allenfalls an angelsächsischen börsen zu beobachten war dennoch waren ende 1997 von 4548 kapitalgesellschaften lediglich 817 unternehmen an einer deutschen aktienbörse notiert experten gehen davon aus dass in der deutschen unternehmenslandschaft mittelfristig weitere zweitausend firmen als geeignet anzusehen sind einen gang an die börse zu unternehmen um die vorteile einer börsennotiz objektiv beurteilen zu können ist es im einzelfall allerdings

notwendig eine tiefgehende kosten nutzen analyse durchzuführen dieses unterfangen scheitert jedoch oftmals an der tatsache dass keine verlässlichen daten über den finanziellen einmal und folgeaufwand eines going publics verfügbar sind die finanzierungsforschung die an dieser stelle gefordert ist hat die intention aus dem raum potentieller alternativen eine ziel optimale finanzierungsmöglichkeit zu finden ein erkenntnisobjekt stellen die mit der finanzierung verbundenen transferverluste in form von transaktionskosten dar für ein unternehmen mit kapitalnachfrage ist nur dann eine auswahl des effizienten finanzierungsmediums realisierbar wenn die preise und kosten sämtlicher alternativen bekannt sind die vorliegende arbeit setzt sich zum ziel die kosten erstmaliger börsengänge als eine form der beteiligungsfinanzierung in ihrer höhe und struktur für den deutschen kapitalmarkt zu analysieren gleichzeitig soll eruiert werden inwieweit die emissionskosten durch den emittenten beeinflussbar sind den schwerpunkt der untersuchung bildet eine empirische analyse der emissionskosten von ipos am deutschen kapitalmarkt im zeitraum zwischen 1993 und 1998 da bislang keine empirischen studien für den deutschen kapitalmarkt existieren will die vorliegende untersuchung einen beitrag leisten um diese lücke zu schließen anhand der durchgeführten empirischen untersuchung konnte der einfluss von vier wesentlichen faktoren auf die emissionskosten von ipos nachgewiesen werden demnach ist die emissionsgröße für einen überwiegenden teil des anfallenden emissionsaufwands verantwortlich gleichzeitig können beim going public beträchtliche economies of scale konstatiert werden daneben spielen

in the last quarter century the u s economy has been transformed by a large inflow of direct investment from abroad foreign companies mainly from europe and japan have built factories and acquired u s firms at an ever increasing rate jonathan crystal finds inconsistencies in how american businesses have responded to this globalization of production u s firms especially multinationals have conflicting interests regarding investment protection crystal shows many american firms under siege from overseas competitors have already expended considerable energy in obtaining trade protection but they are competing not only with foreign imports but also with locally established foreign owned firms american businesses may favor stricter regulation of foreign companies that threaten their bottom line but they also consider their own interests as global investors subject to retaliatory protection in other countries restrictions on foreign investment it seems are not so attractive when they are imposed by other countries unwanted company examines the different ways in which important u s industries including semiconductors automobiles steel consumer electronics telecommunications and airlines reacted to this new challenge it focuses on the political

responses of u s owned firms to how washington ought to regulate foreign direct investment and how it ought to treat foreign owned firms in the united states some industries welcomed or at least didn t oppose foreign investment whereas others sought restrictive and discriminatory policies crystal demonstrates how the nature of the domestic political environment shapes the translation of economic interests into policy preferences
