this book provides a comprehensive analysis of russian food policy food policy is defined as the way government policy influences food production and distribution russia's food policy is important for several reasons the first and most obvious reason is that a dysfunctional food policy is symptomatic of larger political and societal problems a failing food policy is often the precursor to political instability russian food policy is also important is due to the agricultural recovery since 2004 that has allowed russia to become self sufficient in grain production being food sufficient in grain means that russia is not drawing upon global grain supply even more important russia now produces surpluses and has become a global grain supplier moreover the agricultural recovery has made the country food secure traditionally defined as having enough food for a healthy life an analysis of food policy reveals that the structure of food production has changed with the emergence of mega farms called agroholdings that are horizontally and vertically integrated agroholdings represent a concentration of capital and land with a small number of farms producing large percentages of total food output the book explores alternatives to the industrial agricultural model by discussing different variants of sustainable agriculture a final importance of russian food policy concerns food trade russia has become more protectionist since 2012 the food embargo against western nations 2014 2017 is one example so too is import substitution that is a core component of food policy the book demonstrates the politicalization of external food trade food trade and denial of access to the russian market is used as an instrument of foreign policy to punish countries with whom russia has disagreements current russian policymakers have food resources to augment support and extend national interests abroad russia historically has cycled through periods of integration and isolation from the west this book raises the question whether a new normal has arisen that is characterized by the permanent withdrawal from integration as evidenced by its nationalist and protectionist food policy the book is entirely original rich in detail and broad in scope it is based on field work survey data a wide reading of primary sources and the secondary literature all of which are linked to important policy questions in development studies and food studies it is destined to become a classic book on russian food policy

following a remarkable transition from authoritarian rule to robust democracy taiwan has grown into a prosperous but widely unrecognized nation state for which no uncontested sovereign space exists increasingly vigorous assertions of taiwanese identity expose the fragility of relationships between the united states and other great powers that assume taiwan will eventually unite with china perhaps because of their precarious international position the taiwanese have embraced cosmopolitan culture and democratic institutions the 2014 sunflower movement thrust taiwan's politics into the global media spotlight as did the resounding electoral victory of the once illegal democratic progressive party in 2016 taiwan in dynamic transition provides an up to date assessment of contemporary taiwan highlighting taiwan's emergent nationhood and its significance for world politics taiwan's path has important implications for broader themes and preoccupations in contemporary thought such as consideration of why political transitions in the aftermath of the arab spring have sputtered or failed while taiwan has evolved into a stable and prosperous democratic society taiwan serves as a test case for nation and state building the formation of national identity and the emergence of democratic norms in real time

in the summer of 2020 china and india came near to war the nuclear armed adversaries

both massed troops and equipment along their disputed border in eastern ladakh the two sides slugged it out with fists stones and clubs next to a fast flowing himalayan stream resulting in dozens of deaths and injuries many from hypothermia the entire 4 000 kilometre sino indian boundary is disputed in 1962 the two countries fought a short and vicious war that went badly for india and from which nehru never recovered the border called the line of actual control is not marked on any map agreed upon by the two sides it runs through the largely unpopulated and inhospitable high mountains of the himalayas from the 1990s as beijing and new delhi sought to resolve their seemingly intractable border dispute an elaborate system of agreements kept the situation akin to a kettle on a slow boil but the kettle is now boiling over the two rising asian giants both led by strongly nationalistic regimes neither of which wishes to blink first are seeking geopolitical and strategic advantage this timely book explains what is happening on the roof of the world and why that matters for us all

the rohingya of myanmar are one of the world s most persecuted minority populations without citizenship after the latest exodus from myanmar in 2017 there are now more than half a million rohingya in bangladesh living in camps often in conditions of abject poverty malnutrition and without proper access to shelter or work permits some of them are now compelled to take to the seas in perilous journeys to the southeast asian countries in search of a better life they are now asked to go back to myanmar but without any promise of citizenship or an end to discrimination this book looks at the rohingya in the south asian region primarily india and bangladesh it explores the broader picture of the historical and political dimensions of the rohingya crisis and examines subjects of statelessness human rights and humanitarian protection of these victims of forced migration further it chronicles the actual process of emergence of a stateless community the transformation of a national group into a stateless existence without basic rights

russia s controversial annexation of crimea in 2014 and its involvement in the conflict in ukraine have left international audiences stunned russia now occupies a central place on the western security agenda and has been recast as an important area of scholarly inquiry the conflict has raised important questions about russia s understanding of conflict management and its approach to contemporary european security this book provides a timely and contextual exploration of russia s post soviet legacy of conflict management in the backdrop of its interaction with europe s system of security governance by exploring russia s approach from the early 1990s to the present day the book offers a comprehensive exploration into the evolution of russian behavior investigating whether russia s approach has developed in accordance with the policies and practices of security governance that have emerged in the european experience of conflict management together with extensive documentary analysis and elite interviews it employs the framework of security governance to examine moscow s behavior across a set of case studies situated in the european political and security environment it offers a timely contribution to our understanding of russia s response to intrastate conflict and russia s broader engagement with its contemporary security environment

world orders are increasingly contested as international institutions have taken on ever more ambitious tasks they have been challenged by rising powers dissatisfied with existing institutional inequalities by non governmental organizations worried about the direction of global governance and even by some established powers no longer content to lead the institutions they themselves created for the first time this volume examines these sources of contestation under a common and systematic institutionalist framework while the authority of institutions has deepened at the same time it has fuelled contestation and resistance in a series of rigorous and empirically revealing

chapters the authors of contested world orders examine systematically the demands of key actors in the contestation of international institutions ranging in scope from the world trade organization and the nuclear non proliferation regime to the kimberley process on conflict diamonds and the climate finance provisions of the unfccc the chapters deploy a variety of methods to reveal just to what extent and along which lines of conflict rising powers and ngos contest international institutions contested world orders seeks answers to the key questions of our time exactly how deeply are international institutions contested which actors seek the most fundamental changes which aspects of international institutions have generated the most transnational conflicts and what does this mean for the future of world order

the spread of market oriented reforms has been one of the major political and economic trends of the late twentieth and early twenty first centuries governments have to varying degrees adopted policies that have led to deregulation the liberalization of trade the privatization of state entities and low rate broad base taxes yet some countries embraced these policies more than others johan christensen examines one major contributor to this disparity the entrenchment of u s trained neoclassical economists in political institutions the world over while previous studies have highlighted the role of political parties and production regimes christensen uses comparative case studies of new zealand ireland norway and denmark to show how the influence of economists affected the extent to which each nation adopted market oriented tax policies he finds that in countries where economic experts held powerful positions neoclassical economics broke through with greater force drawing on revealing interviews with 80 policy elites he examines the specific ways in which economists shaped reforms relying on an activist approach to policymaking and the perceived utility of their science to drive change

climate change is the most significant moral and environmental issue of our time this project seeks to help deepen explicit ethical reflection around the world on national responses to climate change by developing a publicly available record on national compliance with ethical obligations for climate change similar to the reports that are now available on national compliance with human rights obligations

addressed in the three countries in all environmental pollution and the media political discourses of risk and responsibility in australia china and japan uncovers the dynamics of the triadic relationship among risk harm and climate change in australia china and japan by so doing the book makes an original and timely contribution to understanding comparative media discourse and political debates on climate change

the transition from the soviet to the post 1991 russian military is a fascinating story of decline and reinvention the soviet army suffered a slow demise dissolving in 2000 and only gradually reforming based on radically different principles the first chechnya war 1994 1996 was the lowest point for the soviet military but the second chechnya war 1999 2004 saw the initial stirrings of the new russian army the five day war with georgia in august 2008 was its first major success and marked russia s return to world power status lively accounts and maps describe the actions of these wars along with the crimea operation of 2014 the separatist struggles in eastern ukraine and the ongoing russian intervention in syria

development goals the rhetoric around social protection particularly when delivered in the form of cash transfers has sometimes reached hyperbolic proportions with advocates seeing it as a magic bullet that can tackle multi dimensional problems of poverty vulnerability and inequality and a southern led success story that challenges the unequal power relations inherent within international aid the politics of social protection in eastern and southern africa challenges the common conception that this phenomenon has been entirely driven by international development agencies instead focusing on the critical role of political dynamics within specific african countries it details how the power and politics at multiple levels of governance shapes the extent to which political elites are committed to social protection the form that this commitment takes and the implications that this has for future welfare regimes and state citizen relations in africa it reveals how international pressures only take hold when they become aligned with the incentives and ideas of ruling elites in particular contexts it shows how elections the politics of clientelism political ideologies and elite perceptions all play powerful roles in shaping when countries adopt social protection and at what levels which groups receive benefits and how programmes are delivered
