winner of the 2015 award for concept analysis in political science american political science has been widely but loosely identified as a liberal science robert adcock clarifies the place of american political science within the liberal tradition by situating its origins in relation to the transatlantic history of liberalism the pioneers of american political science participated in transatlantic networks of intellectual and political elites that connected them directly to the evolution of liberalism in europe this book shows how these figures adapted multiple european liberal arguments to speak to particular challenges of mass democratic politics and large scale industry as they developed in america political science s pioneers in the american academy were thus active agents of the americanization of liberalism in charting the emergence of american political science adcock shows how a distinct current of mid nineteenth century european liberalism was transformed into two alternative twentieth century american liberalisms when political science first secured a niche in america s antebellum academy it advanced a democratized classical liberal vision that overlapped with the contemporary european liberalism of tocqueville and john stuart mill as political science expanded during the dramatic growth of universities in the gilded age controversy and cleavage within liberalism came to the fore in the area of political economy during the late nineteenth century this cleavage was fleshed out into the alternative analyses of democracy and the administrative state advanced by two divergent liberal political visions progressive liberalism and disenchanted classical liberalism both visions found expression among the early leaders of the new american political science association founded in 1903 and in turn within the fierce contest over the meaning of liberalism as this term entered american political discourse from the mid 1910s on the history of american political science allows us to see how a distinct current of mid nineteenth century european liberalism was transformed into alternative twentieth century american liberalisms

this book is premised on the assumption that games and simulations provide welcome alternatives and supplements to traditional lectures and class discussions especially in political science classrooms where real world circumstances provide ideal applications of theory and policy prescriptions implementing such an active learning program however is sometimes daunting to overburdened professors and teaching assistants this book addresses the challenges of using games and simulations in the political science classroom both online and in person each chapter offers a game or simulation that politics teachers can use to teach course concepts and explains ways to execute it effectively in addition the authors in this volume make a proactive case for games and simulations each chapter offers research to evaluate the effectiveness of the activity and pedagogical design best practices thus the book not only serves as a game design resource but also offers demonstrable support for using games and simulations in the political science classroom aimed at teachers at all levels from high school through college the book may be especially appealing to graduate students entering teaching for the first time and open to new teaching and learning approaches

changes in the thinking of science are usually accompanied by lively intellectual conflicts between opposing or divergent points of view the clash of ideas is a major ingredient in the stimulation of the life of the mind in human culture such arguments and counter arguments of proofs and disproofs permit changes in the arts and sciences to take place political science is not exempt from these conflicts since the middle of the twentieth century the study of politics has been rocked by

disagreements over its scope theories and methods these disagreements were somewhat less frequent than in most sciences natural or behavioral but they have been at times bitter and persuasive the subject matter of political science politics and all that is involved in politics has a halo effect the stakes of politics make people fight and sometimes die for what they claim as their due political scientists seem to confuse academic with political stakes behaving as if the victories and defeats on the battleground of the intellect resemble those on the battleground of political life three issues seem critical to political science at the time this volume first appeared in the 1960s first disagreement over the nature of the knowledge of political things is a science of politics possible or is the study of politics a matter of philosophy second controversy over the place of values in the study of politics a controversy that makes for a great deal of confusion third disagreements over the basic units of analysis in the study of politics should the political scientist study individual and collective behavior or limit the work to the study of institutions and large scale processes this collection brings together the most persuasive writings on these topics in the mid 1960s

in this volume the study of legislatures has traditionally been a central preoccupation of political scientists legislatures provide good laboratories for testing theories and methodologies of significance in the discipline and more broadly for contributing to an understanding of how representative government works
