the focal challenge is whether the skepticism of postmodern thinkers can be answered in a way that preserves knowledge claims about the good considering the failures of modern thinkers to correctly articulate reason and the good and how postmodern thinkers are responding to these failures anderson argues that there are identifiable patterns of thinking about what is good some of which lead to false dichotomies the book concludes with a consideration of how a moral law might look if the good is correctly identified
