METHOD 2: BREAKING DOWN THE CONVERSION

1. FIND THE NUMBER OF FULL FEET: DIVIDE 103 BY 12. THE QUOTIENT (WHOLE NUMBER RESULT) REPRESENTS THE NUMBER OF COMPLETE FEET. $103 / 12 = 8$ WITH A REMAINDER OF 7. THIS MEANS WE HAVE 8 FULL FEET.
2. DETERMINE THE REMAINING INCHES: THE REMAINDER FROM THE PREVIOUS STEP (7) REPRESENTS THE INCHES LEFT OVER AFTER FORMING COMPLETE FEET. THEREFORE, WE HAVE 7 INCHES REMAINING.
3. EXPRESS THE FINAL RESULT: COMBINING THE FULL FEET AND THE REMAINING INCHES, WE CAN EXPRESS 103 INCHES AS 8 FEET AND 7 INCHES (8' 7").
