a brief and readable account of a major renaissance idea this book argues that throughout his career as a poet and playwright shakespeare consistently presents an image of human politics so idiosyncratic it could serve as his signature

celebrations of literary fictions as autonomous worlds appeared first in the renaissance and were occasioned paradoxically by their power to remedy the ills of history robert e stillman explores this paradox in relation to philip sidney s defence of poesy the first renaissance text to argue for the preeminence of poetry as an autonomous form of knowledge in the public domain offering a fresh interpretation of sidney s celebration of fiction making stillman locates the origins of his poetics inside a neglected historical community the intellectual elite associated with philip melanchthon leader of the german reformation after luther the so called philippists as a challenge to traditional anglo centric scholarship his study demonstrates how sidney s education by continental philippists enabled him to dignify fiction making as a compelling form of public discourse compelling because of its promotion of powerful new concepts about reading and writing its ecumenical piety and its political ambition to secure through natural law from universal ideas freedom from the tyranny of confessional warfare intellectually ambitious and wide ranging this study draws together various elements of contemporary scholarship in literary religious and political history in order to afford a broader understanding of the defence and the cultural context inside which sidney produced both his poetry and his poetics

exploring shakespeare s intellectual interest in placing both characters and audiences in a state of uncertainty mystery and doubt this book interrogates the use of paradox in shakespeare s plays and in performance by adopting this discourse one in which opposites can co exist and perspectives can be altered and one that asks accepted opinions beliefs and truths to be reconsidered shakespeare used paradox to question love gender knowledge and truth from multiple perspectives committed to situating literature within the larger culture peter platt begins by examining the renaissance culture of paradox in both the classical and christian traditions he then looks at selected plays in terms of paradox including the geographical site of venice in othello and the merchant of venice and equity law in the comedy of errors merchant and measure for measure platt also considers the paradoxes of theater and live performance that were central to shakespearean drama such as the duality of the player the boy actor and gender and the play audience relationship in the henriad hamlet as you like it twelfth night antony and cleopatra the winter s tale and the tempest in showing that shakespeare s plays create and are created by a culture of paradox platt offers an exciting and innovative investigation of shakespeare s cognitive and affective

crossing the boundaries between literature philosophy and theology shakespeare and the grace of words pioneers a reading strategy that approaches language as grounded in praise that is as affirmation and articulation of the goodness of being offering a metaphysically astute theology of language grounded in the thought of renaissance theologian nicholas of cusa as well as readings of shakespeare that instantiate and complement its approach this book shows that language in which the divine gift of being is received apprehended and expressed even amidst darkness and despair is language that can renew our relationship with one another and with the things and beings of the world shakespeare and the grace of words aims to engage the reader in detailed performative close readings while exploring the metaphysical and theological contours of shakespeare s art as a venture into a poetic illumination of the deep grammar of the real

blood invention language resistance world five ordinary words that do a great deal of conceptual work in everyday life and literature in this original experiment in critical semantics roland greene considers how these five words changed over the course of the sixteenth century and what their changes indicate about broader forces in science politics and other disciplines greene discusses a broad swath of renaissance and transatlantic literature including shakespeare cervantes camoes and milton in terms of the development of these words rather than works careers or histories he creates a method for describing and understanding the semantic changes that occur extending his argument to other words that operate in the same manner aiming to shift the conversation around renaissance literature from current approaches to riskier enterprises greene also challenges semantic historicist scholars proposing a method that takes advantage of digital resources like full text databases but still depends on the interpreter to fashion ideas out of ordinary language five words is an innovative and accessible book that points the field of literary studies in an exciting new direction page 4 of cover

this handbook scrutinises the links between english literature and religion specifically in the early modern period the interactions between the two fields are explored through an examination of the literary impact the british church had on published work in the sixteenth and seventeenth centuries

impossible desire and the limits of knowledge in renaissance poetry examines the limits of embodiment knowledge and representation at a disregarded nexus the erotic carpe diem poem in early modern england these macabre seductions offer no compliments or promises but instead focus on the lovers anticipated decline and quite stunningly given the reformation context humanity s relegation not to a christian afterlife but to a marvellian desert of vast eternity in this way a poetic trope whose classical form was an expression of pragmatic epicureanism became during the religious upheaval of the reformation an unlikely but effective vehicle for articulating religious doubt its ambitions were thus largely philosophical and came to incorporate investigations into the nature of matter time and poetic representation renaissance seduction poets invited their auditors to participate in a dangerous intellectual game one whose primary interest was expanding the limits of knowledge the book theorizes how renaissance lyric s own fragile relationship to materiality and time and its self conscious relationship to making positioned it to grapple with these impossible metaphysical and representational problems although attentive to poetics the book also challenges the commonplace view that the erotic invitation is exclusively a lyrical mode carpe diem s revival in post reformation europe portends its radicalization as debates between man and maid are dramatized in disputes between abstractions like chastity and material facts like death offered here is thus a theoretical reconsideration of the generic parameters and aspirations of the carpe diem trope wherein questions about embodiment and knowledge are also investigations into the potentialities of literary form

vocal music was at the heart of english renaissance poetry and drama virtuosic actor singers redefined the theatrical culture of william shakespeare and his peers composers including william byrd and henry lawes shaped the transmission of renaissance lyric verse poets from philip sidney to john milton were fascinated by the disorienting influx of musical performance into their works musical performance was a driving force behind the period s theatrical and poetic movements yet its importance to literary history has long been ignored or effaced this book reveals the impact of vocalists and composers upon the poetic culture of early modern england by studying the media through which and by whom its songs were made in a literary field that was never confined to writing media were not limited to material texts scott trudell argues that the media of renaissance poetry can be conceived as any node of transmission from singer s larynx to actor s body through his study of song trudell outlines a new approach to renaissance poetry and drama that is grounded not simply in performance history or book history but in a more synthetic media history

many writers in early modern england drew on the rhetorical tradition to explore affective experience in the imperfect friend wendy olmsted examines a broad range of renaissance and reformation sources all of which aim to cultivate emotional intelligence through rhetorical means with a view to understanding how emotion functions in these texts in the works of sir philip sidney 1554 1586 john milton 1608 1674 and many others characters are depicted conversing with one another about their emotions while counselors appeal to objective reasons for feeling a certain way their efforts to shape emotion often encounter resistance this volume demonstrates how in renaissance and reformation literature failures of persuasion arise from conflicts among competing rhetorical frameworks among characters multiple frameworks olmsted argues produce tensions and consequently an

interiorized conflicted self by situating emotional discourse within distinct historical and socio cultural perspectives the imperfect friend sheds new light on how the writings of sidney milton and others grappled with problems of personal identity from their innovations the study concludes friendship emerges as a favourite site of counseling the afflicted and perturbed

the elizabethan history play was one of the most prevalent dramatic genres of the 1590s and so was a major contribution to elizabethan historical culture the genre has been well served by critical studies that emphasize politics and ideology however there has been less interest in the way history is interrogated as an idea in these plays drawing in period sensitive ways on the field of contemporary performance theory this book looks at the shakespearean history play from a fresh angle by first analyzing the foundational work of the queen s men the playing company that invented the popular history play through innovative readings of their plays including the famous victories of henry v before moving on to shakespeare s 1 henry vi richard iii and henry v this book investigates how the queen s men s self consciousness about performance helped to shape shakespeare s dramatic and historical imagination

the tudor era 1485 1603 was one of the most culturally significant periods in history under three generations of tudor rulers the era witnessed the advent of humanism the birth of the reformation and the rise of the british empire the literature of the period is marked by complexity of thought and form and reflects the political religious and cultural changes of the era this reference book surveys the literature of tudor england included are alphabetically arranged entries for nearly 100 authors who wrote between 1485 and 1603 some figures covered are widely taught such as shakespeare donne and spenser others are less well known such as edward fairfax and abraham fraunce the work includes entries for notable women writers of the period many of whom have been neglected until recent years also included are entries for continental writers such as ariosto tasso calvin and erasmus whose writings were influential in england entries are written by expert contributors and contain valuable bibliographies of primary and secondary sources included are entries for nearly 100 people who wrote between 1485 and 1603 the entries are written by expert contributors and are arranged alphabetically to facilitate use some of the authors profiled are major canonical figures such as shakespeare spenser and donne but the volume also includes a significant number of entries for women writers whose work has been unjustly disregarded until recent years while most of the authors were from england the volume contains entries on figures such as erasmus who though born in another country wrote important works in england and on writers such as machiavelli calvin ariosto and tasso whose works were almost immediately adopted translated or otherwise made part of tudor culture each entry provides a brief biography which is followed by a discussion of major works and themes a review of the author's critical reception and a bibliography of primary and secondary sources

jennifer c vaught illustrates how architectural rhetoric in shakespeare and spenser provides a bridge between the human body and mind and the nonhuman world of stone and timber the recurring figure of the body as a besieged castle in shakespeare s drama and spenser s allegory reveals that their works are mutually based on medieval architectural allegories exemplified by the morality play the castle of perseverance intertextual and analogous connections between the generically hybrid works of shakespeare and spenser demonstrate how they conceived of individuals not in isolation from the physical environment but in profound relation to it this book approaches the interlacing of identity and place in terms of ecocriticism posthumanism cognitive theory and cicero s art of memory architectural rhetoric in shakespeare and spenser examines figures of the permeable body as a fortified yet vulnerable structure in shakespeare s comedies histories tragedies romances and sonnets and in spenser s faerie queene and complaints

renaissance humanism takes as one of its subjects for inquiry the category of the human itself as intricate movements experimental thinking and human analogies in sidney and spenser shows late sixteenth century english poets found some remarkably radical ways to interrogate and redefine the status of humans the recent vogue for posthumanist theory encourages a view of non human objects and animals in renaissance literature as pathways to essentially anti humanist thought on the contrary this book argues that sidney spenser and their contemporaries employ animals earth buildings and fictions as analogies employed toward a better understanding of what makes humans a special category both ontologically and ethically horses and riders are studied by sidney as a way to understand readers and writers the 1580 dover straits earthquake provides spenser and gabriel harvey an opportunity to explore human emotion liturgical spaces are represented by sidney and spenser in order to reassess human community and fictional persons are interrogated by spenser as models for human interpersonal epistemology this volume seeks to return critical assessments of the period s engagement with the non human back to human concerns focusing on several early modern analogies between human and non human entities intricate movements argues sidney s and spenser s thinking about the human is both radically experimental and ultimately humane

perry reveals shakespeare derived modes of tragic characterization previously seen as presciently modern via engagement with rome and senecan tragedy

english literary afterlives traces life narratives of early modern authors created for them after their deaths by readers or publishers who retrospectively tried to make sense of the author s life and works in a series of case studies of the reception history of major poets sidney spenser donne herbert as well as robert greene the first celebrity author within a generation of their deaths it shows how those authors were posthumously fashioned and refashioned it argues that during the early modern period there is a gradual movement towards biographical readings that attempt to find the author in the works which in turn led to the emergence of written lives that consider poets not in terms of their public lives but in terms of their poetic activity i e the beginnings of literary biography will be of interest to students and scholars of several canonical early modern authors

romance was criticized for its perceived immorality throughout the renaissance and even enthusiasts were often forced to acknowledge the shortcomings of its dated narrative conventions yet despite that general condemnation the striking growth in english fiction in the late sixteenth and early seventeenth centuries is marked by writers who persisted in using this much maligned narrative form in renaissance romance nandini das examines why the fears and expectations surrounding the old genre of romance resonated with successive new generations at this particular historical juncture across a range of texts in which romance was adopted by the court by popular print and by women das shows how the process of realignment and transformation through which the new prose fiction took shape was driven by a generational consciousness that was always inherent in romance in the fiction produced by writers such as sir philip sidney robert greene and lady mary wroth the transformative interaction of romance with other emergent forms from the court masque to cartography was determined by specific configurations of social groups drawn along the lines of generational difference what emerged as a result of that interaction radically changed the possibilities of fiction in the period

we have become used to looking at art from a stance of detachment in order to be objective we create a mental space between ourselves and the objects of our investigation separating internal and external worlds this detachment dates back to the early modern period when researchers in a wide variety of fields tried to describe material objects as things in themselves things that is without the admixture of imagination generations of scholars have heralded this shift as the renaissance discovery of the observable world in poetry in a world

of things rachel eisendrath explores how poetry responded to this new detachment by becoming a repository for a more complex experience of the world the book focuses on ekphrasis the elaborate literary description of a thing as a mode of resistance to this new empirical objectivity poets like petrarch spenser marlowe and shakespeare crafted highly artful descriptions that recovered the threatened subjective experience of the material world in so doing these poets reflected on the emergence of objectivity itself as a process that was often darker and more painful than otherwise acknowledged this highly original book reclaims subjectivity as a decidedly poetic and human way of experiencing the material world and at the same time makes a case for understanding art objects as fundamentally unlike any other kind of objects

the book also relates shakespeare s understanding of the narrative in the plays to the brilliant narrative poems that he wrote in the early 1590s it also examines the narrative conventions that are used in the embedded or inset narratives in the plays particular attention is paid to the way shakespeare creates fictional entities such as worlds and characters in the plays a great deal of emphasis is placed on shakespeare s innovative transformations of traditional narrative conventions

the last two decades have transformed the field of renaissance studies and reconceiving the renaissance a critical reader maps this difficult terrain attending to the breadth of fresh approaches the volume offers a theoretical overview of current thinking about the period collecting in one volume the classic and cutting edge statements which define early modern scholarship as it is now practised this book is a one stop indispensable resource for undergraduates and beginning postgraduates alike through a rich array of arguments by the world's leading experts the renaissance emerges wonderfully invigorated while the suggestive shorter extracts topical questions and engaged editorial introductions give students the wherewithal and encouragement to do some reconceiving themselves

an illuminating look at an understudied but critical period in buber s early career martin buber 1878 1965 has had a tremendous impact on the development of jewish thought as a highly influential figure in 20th century philosophy and theology however most of his key publications appeared during the last forty years of his life and little is known of the formative period in which he was searching for and finding the answers to crucial dilemmas affecting jews and germans alike now available in paperback martin buber s formative years illuminates this critical period in which the seeds were planted for all of his subsequent work during the period from 1897 to 1909 buber s keen sense of the crisis of humanity his intimate knowledge of german culture and jewish sources and his fearlessness in the face of possible ridicule challenged him to behave in a manner so outrageous and so contrary to german jewish tradition that he actually achieved a transformation of himself and those close to him calling on spiritual giants of great historical periods in german christian and jewish history such as nicolas of cusa jakob boehme israel baal shem tov rabbi nachman of brazlav johann wolfgang von goethe and friedrich nietzsche buber proceeded to subvert the existing order by turning his upside down world of slave morality right side up once more by examining the multitude of disparate sources that buber turned to for inspiration gilya gerda schmidt elucidates buber s creative genius and his contribution to turn of the century jewish renewal this comprehensive study concludes that buber was successful in creating the german jewish symbiosis that emancipation was to have created for the two peoples but that this synthesis was tragic because it came too late for practical application by jews in germany

though much has been written about connections between early modern utopia and nascent european imperialism the author brings a fresh perspective to the topic by exploring it through some of the sub genres that comprise early modern utopia identifying and discussing each specific form in the cultural and historical contexts that render it suitable

for the creation and promulgation of utopian programs whether imaginary or intended for actual implementation this study transforms scholarly understanding of early modern utopia by first complicating our notion of it as a single genre and secondly by fusing our paradoxically fragmented view of it as alternately a literary or social phenomenon her analysis shows early modern utopia to be not a single genre but rather a conglomeration of many forms or sub genres including travel writing ethnography dialogue pastoral and the sermon each with its own relationship to nascent imperialism these sub genres bring to utopian writing a variety of discourses anthropological theological philosophical legal and more not usually considered fictional presented in a humanist guise these discourses lend to early modern utopia an authority that serves to counteract the general contemporary distrust of fiction the author shows how early modern utopia in conjunction with the authoritative forms of its sub genres is not only able to impose its fictions upon the material world but in doing so contributes to the imperialistic agendas of its day this volume contains a bibliographical essay as well as a chronology of utopian publications and projects in europe and the new world

this study offers an approach toward renaissance literary production demonstrating that antipoetic sentiment previously dismissed as an unimportant aspect of tudor stuart literary culture constituted a significant shaping presence in sidney spenser and milton

reflecting varieties of theory and practice in both verse and prose from the middle ages to the twenty first century these essays by many of america's leading literary scholars call for a reinvigorated formalism that can enrich literary studies open productive routes of commerce with cultural studies and propel cultural theory out of its thematic ruts this book reprints modern language quarterly s highly acclaimed special issue reading for form along with new essays by marjorie perloff d vance smith and susan stewart and a revised introduction by susan wolfson with historical case studies and insightful explorations reading for form offers invaluable material for literary critics in all specializations

richard iii antony and cleopatra were significant figures before shakespeare revitalized them on stage when he did charnes argues he used these legendary figures to explore the emergence of a new kind of fame notorious identity
