the study of the international political economy ipe like the ipe itself is plural and unbounded despite what partisans sometimes say rather than there being one way of studying the ipe that is the right way we find across the world great variation in ipe scholarship in terms of focus questions and methods how then can we make sense of this and understand the field as a whole rather than simply learn one part of it this handbook is designed to address precisely this concern it maps the shifting boundaries and diverse theoretical commitments of ipe around the world it engages the geographical and theoretical diversity of the different versions of ipe found in north america the uk in asia and australia and notes the absences of distinctive versions of ipe in europe and latin america the volume groups together the essential attributes and positions of each school inviting the reader to engage with and learn about ipe in all of its guises through this evolving global conversation rather than adjudicate the one true version of ipe it argues that the intellectual diversity we see around the world is an essential and positive feature of the field with over twenty contributors from a wide range of countries routledge handbook of international

this book examines the evolution of international political economy ipe as a field of study in china detailing the evolving boundaries and the content of the field it surveys how the key themes in ipe such as the conceptualization of power at the global level the question of international order and international organization the state and globalization money and finance and the source of ideas and ideational innovation have been debated in chinese ipe in comparison to the foundational works of the west the contributions map the genesis of the field inside china and the core characteristics of chinese ipe consider the limits of the development of the field in china and identify the contributions which chinese ipe can make to the global development of ipe each piece in this collection is co authored by a prominent prc scholar residing in china and a distinguished foreign scholar the co authors together highlight what they think are the core chinese concerns of ipe in a particular area and suggest what this understanding adds to the global discussion this book was originally published as a special issue of the review of international political economy

this book argues that michael oakeshott s political philosophy contributes to current debates in normative international theory and international political theory on the historical social and moral dimension of international society davide orsi contends that the theory of civil association may be the ground for an understanding of international society as a rule based form of moral association constituted by customary international law the book also considers the role of evolving practices of morality in debates on international justice orsi grounds this work on a study of oakeshott s philosophical arguments and compares the oakeshottian perspective to recent constructivist literature in international relations

stefano guzzini s study offers an understanding of the evolution of the realist tradition within international relations and international political economy it sees the realist tradition not as a school of thought with a static set of fixed principles but as a repeatedly failed attempt to turn the rules of european diplomacy into the laws of a us social science realism in international relations and international political economy concentrates on the evolution of a leading school of thought its critiques and its institutional environment as such it will provide an invaluable basis to anyone studying international relations theory

this book offers a timely exploration of the still burgeoning field of international political theory ipt ipt is approached in this volume not merely as a subfield at the margins of the discipline of international relations ir but rather as a key dimension of theorising international relations that challenges disciplinary theoretical methodological and geographical boundaries and insemminates other theoretical ir traditions chapters in this volume approach ipt as a theoretical tradition that emphasises and interrogates the philosophical historical ethical normative institutional and

aesthetic dimensions of international relations and world politics in so doing they explore ipt as a european theoretical tradition to stress that paradoxically it is only by provincializing europe and its intellectual traditions that one may finally appreciate what is truly universal in them this is a refreshingly different take on ipt sure to be of interest to students and scholars of ipt ir and political theory

kristian coates ulrichsen documents the startling rise of the arab gulf states as regional powers with international reach and provides a definitive account of how they have become embedded in the global system of power politics and policy making

this book presents an overview and evaluation of contemporary research in international political sociology ips bringing together leading scholars from many disciplines and diverse geographical backgrounds it provides unprecedented coverage of the key concepts and research through which ips has opened up new ways of thinking about international relations it also considers some of the consequences of such innovations for established forms of social and political analysis it thus takes the reader on an intellectual journey engaging with questions about boundaries and limits among the many interrelated worlds in which we now live the ways we conceptualise them and how we continually reshape boundaries of identities spaces authorities and disciplinary knowledge the volume is organized three sections lines intersections and directions the first section examines some influences that led to the formation of the project of ips and how it has opened up avenues of research beyond the limits of an international relations discipline shaped within political science the second section explores some key concepts as well as a series of heated discussions about power and authority practices and governmentality performativity and reflexivity the third section explores some of the transversal topics of research that have been pursued within ips including inequality migration citizenship the effect of technology on practices of security the role of experts and expertise data driven surveillance and the relation between mobility power and inequality this book will be an essential source of reference for students and across the social sciences

this book seeks to offer a general interpretation and critique of both methodological and substantive aspects of international theory

since the field of international relations was established almost a century ago many different theoretical approaches have been developed each offering distinctive accounts of the world why it has come to be the way it is and how it might be made a better place in this illuminating textbook leading ir scholar stephanie lawson examines each of these theories in turn from political realism in its various forms to liberalism marxism critical theory and more recent contributions from social theory feminism postcolonialism and green theory taking as her focus the major practical issues facing scholars of international relations today lawson ably shows how each theory relates to situations on the ground each chapter features case studies questions for discussion to encourage reflection and classroom debate guides to further reading and web resources the study of ir is a profoundly normative enterprise and each theoretical school has its strengths and weaknesses theories of international relations encourages a critical reflective approach to the study of ir theory while emphasising the many important and interesting things it has to teach us about the complexities and challenges of international politics today

international relations theory is a diverse and constantly evolving area of scholarly research reflecting the fluctuations in world politics this volume brings together a number of the most important research papers published on this subject during the last sixty years divided into five thematic sections this work provides the reader with a comprehensive overview of developments and debates in this area of study topics covered include the history and development of

alternative approaches to international relations theory the importance of domestic politics in shaping a state's foreign policy the absence of a global government and the meaning and implications of this state of international anarchy power and its role as a variable in international relations theory and the challenges of state security war and peace the introduction anchors the collection putting the articles within the context of the evolution of this field to date

neoclassical realism is a major theoretical approach to the study of foreign policy in neoclassical realist theory of international relations norrin m ripsman jeffrey w taliaferro and steven e lobell argue that it can explain and predict a far broader range of political phenomena in international politics neoclassical realism challenges other approaches including structural realism liberalism and constructivism

since the 1980s the discipline of international relations has seen a series of disputes over its foundations however there has been one core concept that although addressed in various guises had never been explicitly and systematically engaged with in these debates the human this volume is the first to address comprehensively the topic of the human in world politics it comprises cutting edge accounts by leading scholars of how the human is or is not theorized across the entire range of ir theories old and new the authors provide a solid foundation for future debates about how why and to which ends the human has been or must not be built into our theories and systematically lay out the implications of such moves for how we come to see world politics and humanity's role within it

this exciting new textbook challenges the implicit notions inherent in most existing international relations ir scholarship and instead presents the subject as seen from different vantage points in the global south divided into four sections 1 the ir discipline 2 key concepts and categories 3 global issues and 4 ir futures it examines the ways in which world politics have been addressed by traditional core approaches and explores the limitations of these treatments for understanding

both southern and northern experiences of the international the book encourages readers to consider how key ideas have been developed in the discipline and through systematic interventions by contributors from around the globe aims at both transforming and enriching the dominant terms of scholarly debate this empowering critical and reflexive tool for thinking about the diversity of experiences of international relations and for placing them front and center in the classroom will help professors and students in both the global north and the global south envision the world differently in addition to general introductory ir courses at both the undergraduate and graduate levels it will appeal to courses on sociology and historiography of knowledge globalization neoliberalism security the state imperialism and international political economy

meant primarily for students studying international relations aspirants of civil services international relations today concepts and applications captures the drastic changes in international relations after the disintegration of the soviet union and the end of the cold war in 1991 it also examines the rise of china as a major military and economic power and the potential of russia india and germany as tomorrow s big powers it will also be useful for those interested in the discipline

reflexivity has become a common term in ir scholarship with a variety of uses and meanings yet for such an important concept and referent understandings of reflexivity have been more assumed rather than developed by those who use it from realists and constructivists to feminists and post structuralists this volume seeks to provide the first overview of reflexivity in international relations theory offering students and scholars a text that provides a comprehensive and systematic overview of the current reflexivity literature develops important insights into how reflexivity can play a broader role in ir theory pushes reflexivity in new productive directions and offers more nuanced and concrete specifications of reflexivity moves reflexivity beyond the scholar and the scholarly field to political practice formulates practices of reflexivity drawing together the work of many of the key scholars in the field into one volume this work will be essential reading for all students of international relations theory
