how do political authorities build support for themselves and their rule doing so is key to accruing power but it can be a complicated affair this book shows how social processes can legitimate new rulers and make their exercise of power seem natural historically political authorities have used carefully crafted symbols and practices to create a cultural infrastructure for rule most notably through nationalism and state building the european union eu as a new governance form faces a particularly acute set of challenges in naturalising itself

drawing on unique research and rich data on cross border practices this book offers an empirically based view on europeans interconnections in everyday life it looks at the ways in which eu residents have been getting closer across national frontiers in their everyday experiences of foreign countries work travel personal networks but also their knowledge consumption of foreign products and attitudes towards foreign culture these evolving european dimensions have been enabled by the eu backed legal opening to transnational economic and cultural transactions while also differing according to national contexts the book considers how people reconcile their increasing cross border interconnections and a politically separating europe of nation states and national interests

the collection of essays in secret agents and the memory of everyday collaboration in communist eastern europe addresses institutions that develop the concept of collaboration and examines the function social representation and history of secret police archives and institutes of national memory that create these histories of collaboration the essays provide a comparative account of collaboration participation across differing categories of collaborators and different social milieux throughout east central europe they also demonstrate how secret police files can be used to produce more subtle social and cultural histories of the socialist dictatorships by interrogating the ways in which post socialist cultures produce the idea of and knowledge about collaborators the contributing authors provide a nuanced historical conception of collaboration expanding the concept toward broader frameworks of cooperation and political participation to facilitate a better understanding of eastern european communist regimes

the importance of the daily experience of new information and communication technologies is highlighted by this timely volume the book is based on work carried out in the european media technology and everyday life network and is structured round a series of seven empirical case studies drawn from research within europe the application of this perspective draws attention not just to the significance of information and communication technologies for a mature understanding of the conduct of everyday life in contemporary europe but also for the significance of that understanding for the development of communication and information policy the research makes a significant contribution to our understanding of the dynamics and evolution of a core dimension of european society as well as informing on going and important debates on the nature of the relationship between the social and the technological in the information and communication arena

due to significant processes of transnationalization in the european context a considerable relevance of potential social and political conflicts or disagreements in everyday life linked to europe or the european union can be observed consequently the focus of this book is on the increasingly intertwined european citizens themselves and their everyday experiences with european and eu related issues the individual chapters provide fine tuned perspectives on the connection of social and political european integration processes in the context of the eu and the everyday life of europeans overall the book draws attention to both how contestations over europe and the eu figure in everyday life and on how european integration shapes individual social and political subjectivities and identities this book is intended for scholars and advanced students of european studies sociology and political science and international

lisa hellman offers the first study of european everyday life in canton and macao how foreigners could live communicate move around even whom they could interact with were all things strictly regulated by the chinese authorities the europeans sometimes adapted to and sometimes subverted these rules focusing on this conditional domesticity shows the importance of gender relations especially the construction of masculinity using the swedish east india company a minor european actor in an expanding asian empire as a point of entry highlights the multiplicity of actors taking part in local negotiations of power the european attempts at making a home in china contributes to a global turn in everyday history but also to an everyday turn in global history

volume ii examines the history of the european union from an inside out perspective focusing on the internal developments that shaped the european integration process split into three parts part i covers the principles that have defined european integration exploring the treaties and their changes through time with brexit being a core milestone part ii considers the different instruments within the architecture of european integration with special focus on the development of policies the euro and enlargement part iii concentrates on the various narratives surrounding european integration in particular the concepts goals and ideas that both spoke and failed to speak to the hearts and minds of europeans this includes the *longue durée* concept peace european culture the absence of religion prosperity and a lack of solidarity and democracy

scholars across the humanities and social sciences are increasingly examining the importance of consumption to changing notions of local regional national and supranational identity in europe as part of this interest anthropologists historians sociologists and others have paid particular attention to the roles which food and drink have played in the construction of local regional and national identity in europe this volume provides the first multidisciplinary look at the contributions which food and alcohol make to contemporary european identities including the part they play in processes of european integration and europeanization it provides theoretically informed ethnographic and historical case studies of transformations and continuity in social and cultural patterns in the production and consumption of european foods and drinks in order to explore how eating and drinking have helped to construct various local regional and national identities in europe of particular note in this volume is its attention to how food and drink intersect with recent

attempts to foster greater european integration in part through the recognition and support of common and diverse european cultures and identities

inter marriage both reflects and brings social change this book draws on a unique survey of randomly selected samples of national and european binational couples to demonstrate that the latter are core cells of a future european society unrestricted freedom of movement has enabled a rise in the number of lower class and middle class binational couples among europeans euro couples fully integrate in their host cities but secure less support in solving everyday problems than do national ones partly because of a relatively small network of relatives living close by embeddedness in a dense international network and a cosmopolitan outlook also distinguish them from national couples the book challenges the view of cosmopolitanism as exclusively middle class and highlights contrasts between lower class and middle class binational couples furthermore it shows that social cosmopolitanism among binational couples is not matched by a commensurate weaker national identification that would enhance support to a more federal europe this book is primarily addressed to the general public interested in contemporary european society and to academics interested in inter marriage since the chapters are quasi stand alone pieces devoted to specific topics it provides suitable reading material for social stratification social networks civil society popular culture and european integration undergraduate and graduate courses

europe is struggling its challenges include weak economic growth demographic trends that undermine the sustainability of social and other programs migration brexit the unfinished euro architecture and much more this volume of research in political sociology seeks to adopt a longer view to make sense of europe s current malaise

at the end of the twentieth century many believed the story of european political development had come to an end modern democracy began in europe but for hundreds of years it competed with various forms of dictatorship now though the entire continent was in the democratic camp for the first time in history but within a decade this story had already begun to unravel some of the continent s newer democracies slid back towards dictatorship while citizens in many of its older democracies began questioning democracy s functioning and even its legitimacy and of course it is not merely in europe where democracy is under siege across the globe the immense optimism accompanying the post cold war democratic wave has been replaced by pessimism many new

democracies in latin america africa and asia began backsliding while the arab spring quickly turned into the arab winter the victory of donald trump led many to wonder if it represented a threat to the future of liberal democracy in the united states indeed it is increasingly common today for leaders intellectuals commentators and others to claim that rather than democracy some form dictatorship or illiberal democracy is the wave of the future in democracy and dictatorship in europe sheri berman traces the long history of democracy in its cradle europe she explains that in fact just about every democratic wave in europe initially failed either collapsing in upon itself or succumbing to the forces of reaction yet even when democratic waves failed there were always some achievements that lasted even the most virulently reactionary regimes could not suppress every element of democratic progress panoramic in scope berman takes readers through two centuries of turmoil revolution fascism civil war and finally the emergence of liberal democratic europe in the postwar era a magisterial retelling of modern european political history democracy and dictatorship in europe not explains how democracy actually develops but how we should interpret the current wave of illiberalism sweeping europe and the rest of the world

this volume investigates the public opinion of the eu in the context of the present economic crisis and other significant challenges currently faced by the union the latest being the refugee crisis scholarly knowledge in the field of eu attitudes in general and euroscepticism in particular is thoroughly documented here and is followed by an analysis of public perceptions of the eu s crisis management capabilities proving that the eu s legitimacy and effectiveness are currently being challenged to the highest degree the research based contribution of this book is two fold focusing on eu attitudes at a macro level on one hand and the opinions of romanian experts on the other it provides insights into attitudes towards the eu in central and eastern europe a region which is still somewhat underexplored by social sciences scholars and in romania in particular on a larger scale significant differences between clusters of states are identified suggesting that not even increasing euroscepticism manages to create a common frame of reference for all europeans regarding eu related issues in terms of romanian expert opinion the book provides evidence for a gradual evolution from highly symbolic and sometimes even triumphalist representations of the eu towards mildly critical positions based on instrumental perceptions such changes mark a new stage of europeanization in which the eu s presence has become ordinary for the eastern european elite increased familiarity with the eu accommodates demitization and criticism without denouncing european integration as a doomed project

how does religion maintain or challenge discourses on national identity what are the roles that religion plays on all sides from Islamophobia of the radical right to the Christian alliances on both sides of the Atlantic to the Islamic beliefs and practices of European citizens as well as migrant communities in the constitution of fortress Europe are there any alliances shaping between belief and unbelief on either side of the battle for the future of Europe these questions and more motivate the chapters in this timely interdisciplinary collection with contributions focusing on diverse contexts throughout Europe involving a broad range of religious identifications and actors

states and banks have traditionally maintained close ties at various points in time states have used banks to manage their economies and soak up government debt while banks enjoyed regulatory forbearance restricted competition and implicit or explicit guarantees

from their home markets the political foundations of banks have thus been powerful and enduring with actors on both sides of the aisle reluctant to sever relations the central argument of this book however is that in the world's largest integrated market europe the traditional political ties between states and banks have been transformed specifically through a combination of post communist transition monetary union and economic crisis states in europe no longer wield preponderant influence over their banks banking on markets explains why we have witnessed the radical denationalization of this politically vital sector as well as the consequences for economic volatility and policy autonomy the findings in europe have implications for other world regions which to varying degrees have also experienced intensified pressure on their traditional models of domestic political control over finance through an investigation of foreign bank behavior in economic crises the developmental consequences of political control over banks and the emergence of european banking union in the eurozone the book advances three main findings first is that foreign bank ownership need not necessarily lead to economic vulnerability of host states second is that marketized bank state ties do however limit pathways to catching up in the global economy and third is that european banking union has strengthened the euro's credibility while cutting down substantially on eurozone member states economic policy discretion this book details the intense political struggles that have underpinned all three outcomes co winner of the 2018 ed a hewett book prize awarded by the association for slavic east european and eurasian studies

a study of the structure growth and future of transnational human travel and communication increasingly people travel and communicate across borders yet we still know little about the overall structure of this transnational world is it really a fully globalized world in which everything is linked as popular catchphrases like global village suggest through a sweeping comparative analysis of eight types of mobility and communication among countries worldwide from migration and tourism to facebook friendships and phone

calls mapping the transnational world demonstrates that our behavior is actually regionalized not globalized emanuel deutschmann shows that transnational activity within world regions is not so much the outcome of political cultural or economic factors but is driven primarily by geographic distance he explains that the spatial structure of transnational human activity follows a simple mathematical function the power law a pattern that also fits the movements of many other animal species on the planet moreover this pattern remained extremely stable during the five decades studied 1960 to 2010 unveiling proximity induced regionalism as a major feature of planet scale networks of transnational human activity deutschmann provides a crucial corrective to several fields of research revealing why a truly global society is unlikely to emerge mapping the transnational world highlights the essential role of interaction beyond borders on a planet that remains spatially fragmented

the euro crisis of 2009–2012 vividly demonstrated that European Union policies matter for the distribution of resources within and between European nation states throughout the crisis distributive conflicts between the EU's winners and losers worsened and are still reverberating in European politics today in *Unequal Europe* Jason Beckfield demonstrates that there is a direct connection between European integration and the increase in European income inequality over the past four decades he places the recent crisis into a broader sociological political and economic perspective by analyzing how European integration has reshaped the distribution of income across the households of Europe using individual and household level income survey data combined with macro level data on social policies and case studies of welfare reforms in EU and non-EU states Beckfield shows how European integration has re-stratified Europe by simultaneously drawing national economies closer together and increasing inequality among households explaining how where and why income inequality has changed in the EU *Unequal Europe* answers the question who wins and who loses from European integration
