a critical problem in resource scarce countries across the globe is the shortage of appropriately trained health care providers according to the world health organization the current global health workforce shortage of 7.2 million providers is estimated to increase to 12.9 million by 2035 this disproportionately affects resource scarce countries denying basic health care to millions and limiting access to life saving treatments due to limited resources

in these countries not enough health professionals receive training few have the opportunity for continuing education and the ability to develop or implement educational programs and curricula is constrained additionally many existing providers choose to emigrate in pursuit of professional advancement opportunities contributing to the overall shortage of qualified health care providers in these environments efforts to strengthen health workforce capacity not only increases access safety and availability of care but is critical to building resilient health systems capable of caring for the world s neediest populations this requires not only cultivating new health care providers but also providing ongoing professional development to retain and support current providers advancing the level of practice in accordance with current clinical science cultivating educators and enhancing training curricula it is critical also to contribute to the limited body of research documenting the effectiveness and impact of various models of collaborative education and partnership to improve health worker training and retention this research topic examines strategies for building health workforce capacity through the prism of educational partnerships offering significant examples of effective models of international collaborative education as well as insight and guidance on the structure and operation of successful global partnerships collectively the 31 articles accepted and included in this ebook represent a diversity of health professions and geographies across academic non governmental organizations and other global partnership forms the published manuscripts highlight various elements of partnerships with several consistent themes emerging capacity building local empowerment mutual trust and respect long term commitment equity collaboration and the importance of integrating theory and practice for a balance of academic and clinical development the manuscripts provide examples of partnership and educational programs that are in the formative early stages of implementation and others which have been sustained long term some for decades the following ebook is divided into two parts with each part broken down into sections part i of the ebook includes 18 manuscripts that showcase long term educational programs that strongly exemplify multiple foundational aspects of international partnerships in education including mutual collaboration and project management empowerment of host partners to lead and sustain programs and capacity building while individual manuscripts included in part i look broadly at multiple aspects of successful international partnerships in education part ii manuscripts focus intently on one two elements part ii includes 13 articles that highlight partnership through short rather than long term educational initiatives as well as

the famed reform debates at al azhar madrasa in nineteenth century cairo one of the most influential centres of religious study in sunni islam were enormously influential for twentieth century islamic thought here indira gesink offers a revisionist history of these debates over curricular and administrative reforms and challenges our understanding of the struggle between islamic reform and conservatism it has been assumed that famous islamic modernists such as muhammad abduh instigated the reform movement and the ideas of modern religious life that emanated from al azhar and permeated islamic society a development that religious conservatives opposed gesink draws on obscure but important archival sources legal manuals and ephemeral journals to tell the other side of the story and to illustrate the important contributions of conservative scholars to the evolution of twentieth century sunni islam conservative opponents of reform engaged many of the same issues as reformers and actively pursued alternative visions of reform in fact texts of enacted reforms

show greater attention to concerns of conservatives than to the original programmes of muhammad abduh and conservatives led ulama committees that generated and implemented reforms had religious conservatives not contributed to the reforms of the early twentieth century these reforms would have lacked the crucial cultural assonance that permitted them to become rooted in public life in an environment of rising nationalist anti british sentiment which saw abduh as a willing agent of colonialists the debates ultimately catalyzed public acceptance of secularism islamic modernism and radical islamism they also led to the practice of lay legal interpretation the proliferation of competing interpretations within sunni islam and the rise of militant sects by drawing on obscure archival sources and restoring conservative voices to the debate islamic reform and conservatism presents a more nuanced picture of the al azhar debates and the forces that shaped islamic religious life in the twentieth century than has become the norm its original scholarship and fresh analysis make this book indispensable for all those interested in the modern middle east religious history islamic studies radical islam and militancy secularism modernism and religious reform

to know her own history chronicles the evolution of writing programs at a landmark southern women s college during the postwar period kelly ritter finds that despite its conservative southern culture and vocational roots the woman s college of the university of north carolina was a unique setting where advanced writing programs and creativity flourished long before these trends emerged nationally ritter profiles the history of the woman s college first as a normal school where women trained as teachers with an emphasis on composition and analytical writing then as a liberal arts college she compares the burgeoning writing program here to those of the seven sisters wellesley smith radcliffe barnard vassar bryn mawr and mount holyoke and to elite all male universities to show the singular progressivism of the woman s college ritter presents lively student writing samples from the early postwar period to reveal a blurring of the boundaries between creative and expository styles by midcentury a quantum shift toward creative writing changed administrators valuation of composition courses and staff at the woman s college an intensive process of curricular revisions modeled after harvard s redbook plan was proposed and rejected in 1951 as the college stood by its unique curricula and singular values ritter follows the plight of individual instructors of creative writing and composition showing how their compensation and standing were made disproportionate by the shifting position of expository writing in relation to creative writing despite this unsettled period the woman s college continued to gain in stature and by 1964 it became a prize acquisition of the university of north carolina system ritter s study demonstrates the value of local histories to uncover undocumented advancements in writing education offering insights into the political cultural and social conditions that influenced
