ausgangspunkt dieses konferenzbands im open access ist die frage nach den bedingungen die dafür verantwortlich zeichnen dass überhaupt und in welcher form in der frühen neuzeit übersetzt wird anders formuliert geht es um die grundsätzliche frage danach warum bestimmte texte bilder zeichenkomplexe etc eine Übersetzung erfahren während andere unübersetzt bleiben müssen welche faktoren nehmen schließlich im positiven fall einfluss auf die konkrete ausgestaltung von Übersetzung im sinne des Übertragungsprozesses von einem semiotischen und kulturellen system in ein anderes in diesem zusammenhang kommt ein doppeltes politikverständnis zum tragen einerseits geraten Übersetzungspolitik en im sinne des konzepts der translation policy in den fokus und mit ihnen soziokulturelle ökonomische und interkulturelle einflussfaktoren andererseits geht es spezifischer um Übersetzungen im kontext politischer verhandlungs und aushandlungsprozesse und somit um den zusammenhang zwischen politics und translation the point of departure for this conference volume is the question of what conditions are responsible for whether a translation happens at all why are certain texts images and sign systems translated while others must remain untranslated and what factors influence the form a translation takes in the process of conveying words images or signs from one semiotic cultural system to another these questions concern both translation policy that is the socio cultural economic and intercultural factors that influence translation processes and the politics of translation in the specific context of political negotiation processes

this volume of the national political science review the official publication of the national political science association is anchored by a major symposium on the politics of the black nation the book authored by matthew holden in 1973 which is now considered one of the most influential books in the field of black politics twenty five years provide a sufficient timespan on which to base a retrospective of the book and simultaneously to reflect upon the evolution of the black liberation struggle more formally called african american politics in the present age there is not much talk about a black nation certainly not as was heard during the 1960s and mid 1970s yet there is a persistent sense of separateness in that there is constant thought and

talk of black america as a significantly separate communal entity black americans are seen as a racially and culturally distinct community holding to social political economic interests which have special significance and poignancy for them holden s perception of the nature of the times in the early seventies stands in sharp contrast to how contemporary analysts of african american politics tend to perceive the nature of african americans role in political life and their position in american society in the present age in this retrospective readers have the opportunity to get a sense of what holden argued of the seven essays that make up his seminal volume and to consider how well holden s observations have stood the tests of time in addition to the essays presented at the symposium which pointedly discuss holden s work there are essays dealing with african american politics in constancy and change by contributors including charles henry david covin robert c smith clyde lusane cheryl miller d linell finley and sekou franklin among others other features are a highly informative discussion of the literary digest magazine s straw vote presidential polls 1916 1936 and a review essay by peter ronaye in which he discusses america as new world power u s foreign policy in the post cold war era the volume concludes with fifteen book reviews by knowledgeable scholars the politics of the black nation is a timely thought provoking volume it will be of immense value to ethnic studies specialists african american studies scholars political scientists historians and sociologists georgia a persons is professor in the school of public policy at the georgia institute of technology and the current editor of the national political science review

dieser band ist alexander stephan gewidmet und spiegelt dessen wissenschaftliche interessengebiete und leistungen wider das buch enthält aufsätze von führenden wissenschaftlerinnen und wissenschaftlern zur politik und kultur deutsch amerikanischer beziehungen sowie zur tradition der kulturvermittlung die themen reichen von der aktuellen politik kulturdiplomatie und amerikanisierung bis zur historischen auseinandersetzung mit mitteleuropäischen künstlern und schriftstellern die als intellektuelle einen wesentlichen einfluss auf die kulturpolitik der 20er jahre und auf die zeit nach dem zweiten weltkrieg ausübten this volume reflects the scholarly interests and achievements of alexander stephan in whose honor it was conceived the book presents essays by leading international scholars on the contours of politics and culture in german american relations as well as broader traditions of cultural mediation topics range from current concerns about public policy and cultural diplomacy americanization and anti americanism to historical considerations of central european artists and writers who as public intellectuals had significant impact on the politics of culture after world war two and earlier

this last chapter is divided into two main parts the first part compares the key findings of the study cases of matalibaq and long bagun ulu chapter 5 and 6 respectively with the focus on conflict development political risks to act conflict motives indigenous resource mobilisation and public goods achievement in the conflict the second part will offer a conclusion of the entire work of this study as well as a classification of the underlying issues found in the rise of the forest conflict phenomenon this study refrains from trying to offer pragmatic remedies due to the complexity of the problems rather it focuses on a strategic key entry point to deal with

forest conflicts that has not received much attention by researchers i argue this key entry point can also be used as an underpinning for the consolidation of the newly born indonesian democracy at the local level which has been much neglected by the indonesian government and politicians

martin heidegger s ties to nazism have tarnished his stature as one of the towering figures of twentieth century philosophy the publication of the black notebooks in 2014 which revealed the full extent of heidegger s anti semitism and enduring sympathy for national socialism only inflamed the controversy richard wolfe s the politics of being the political thought of martin heidegger has played a seminal role in the international debate over the consequences of heidegger s nazism in this edition the author provides a new preface addressing the effect of the black notebooks on our understanding of the relationship between politics and philosophy in heidegger s work building on his pathbreaking interpretation of the philosopher s political thought wolfe demonstrates that philosophy and politics cannot be disentangled in heidegger s oeuvre völkisch ideological themes suffuse even his most sublime philosophical treatises therefore despite heidegger s profundity as a thinker his critique of civilization is saturated with disturbing anti democratic and anti semitic leitmotifs and claims

indicates the extent to which science knowledge and knowledge production have become fundamental phenomena in western societies and central concerns for the social sciences this book aims to investigate the political dimension of this production and validation of knowledge in studying the relationship between knowledge and politics this book provides a novel perspective on current debates about knowledge societies and offers an interdisciplinary agenda for future research it addresses four fundamental aspects of the relation between knowledge and politics the ways in which the nature of the knowledge we produce affects the nature of political activity how the production of knowledge calls into question fundamental political categories how the production of knowledge is governed and managed how the new technologies of knowledge produce new forms of political action this book will be of interest to students of sociology political science cultural studies and science and technology studies

the politics of aesthetics rethinks the relationship between art and politics reclaiming aesthetics from the narrow confines it is often reduced to jacques rancière reveals its intrinsic link to politics by analysing what they both have in common the delimitation of the visible and the invisible the audible and the inaudible the thinkable and the unthinkable the possible and the impossible presented as a set of inter linked interviews the politics of aesthetics provides the most comprehensive introduction to rancière s work to date ranging across the history of art and politics from the greek polis to the aesthetic revolution of the modern age available now in the bloomsbury revelations series 10 years after its original publication the politics of aesthetics includes an afterword by slavoj zizek an interview for the english edition a glossary of technical terms and an extensive bibliography

few challenges to the modern dream of democratic citizenship appear greater than the presence of severe ethnic religious and linguistic divisions in society with their diverse religions and ethnic communities the southeast asian countries of malaysia singapore and indonesia have grappled with this problem since achieving independence after world war ii each country has on occasion been torn by violence over the proper terms for accommodating pluralism until the asian economic crisis of 1997 however these nations also enjoyed one of the most sustained economic expansions the non western world has ever seen this timely volume brings together fifteen leading specialists of the region to consider the impact of two generations of nation building and market making on pluralism and citizenship in these deeply divided asian societies examining the new face of pluralism from the perspective of markets politics gender and religion the studies show that each country has developed a strikingly different response to the challenges of citizenship and diversity the contributors most of whom come southeast asia pay particular attention to the tension between state and societal approaches to citizenship they suggest that the achievement of an effectively participatory public sphere in these countries will depend not only on the presence of an independent civil society but on a synergy of state and society that nurtures a public culture capable of mediating ethnic religious and gender divides the politics of multiculturalism will be of special interest to students of southeast asian history and society anthropologists grappling with questions of citizenship and culture political scientists studying democracy across cultures and

all readers concerned with the prospects for civility and tolerance in a multicultural world

this book addresses two important matters of current concern to middle east scholars firstly the nature of the egyptian state and society and the interactive process between them and secondly how change which would finally lead to development can be initiated the book argues that the egyptian case represents a weak authoritarian state which through its coercive and repressive policies towards various societal forces political parties professional associations and organisations and individuals creates a weak society individual behaviour in urban and rural communities sometimes viewed as signs of the strength of societal forces is seen here as a symptom of a weak and fragmented society the existence of a weak society in turn impedes government objectives and hinders the implementation of developmental policies and programmes further weakening the state this being the case change has to be initiated externally in both the political and economic spheres

the politics of aristocratic empires is a study of a political order that prevailed throughout much of the world for many centuries without any major social conflict or change and with hardly any government in the modern sense although previously ignored by political science powerful remnants of this old order still persist in modern politics the historical literature on aristocratic empires typically is descriptive and treats each empire as unique by contrast this work adopts an analytical explanatory and comparative approach and clearly distinguishes aristocratic empires from both primitive and more modern commercialized societies it develops generalizations that are supported and richly illustrated by data from many empires and demonstrates that a pattern of politics prevailed across time space and cultures from ancient egypt five millennia ago to saudi arabia five decades ago from china and japan to europe from the incas and the aztecs to the tutsi kautsky argues that aristocrats because they live off the labor of peasants must perform the primary governmental functions of taxation and warfare their performance is linked to particular values and beliefs and both functions and ideologies in turn condition the stakes the forms and the arenas of intra aristocratic conflict the politics of the aristocracy the author also analyzes the roles of the peasantry and the townspeople in aristocratic politics and shows that peasant revolts on any large scale occur only after commercial modernization he concludes with chapters on the modernization of aristocratic empires and on the importance in modern politics of institutional and ideological remnants of the old aristocratic order

jacques derrida was one of most influential philosophers of the 20th century in the politics of friendship he explores the idea of friendship and its political consequences past and future in order to explore invention of a radically new friendship of a deeper and more inclusive democracy

this book provides an in depth exploration and analysis of marriages between japanese nationals and migrants from three broad ethnic cultural groups spouses from the former soviet union countries the philippines and western countries it reveals how the marriage migrants navigate the intricacies and trajectories of their marriages with japanese people while living in

japan seen from the lens of gendered geographies of power the book explores how state level politics and policies towards marriage migration and gender affect the personal power politics in operation within the relationships of these international couples overall the book discusses how ethnic identity intersects with gender in the negotiation of spaces and power relations between and amongst couples and the role states and structural inequalities play in these processes resulting in a reconfiguration of our notions of what international marriages are and how powerful gender and the state are in understanding the power relations in these unions

this innovative and theoretically sophisticated book investigates how aesthetic judgment forms the groundwork for understanding political identities it posits aesthetics as central to conceptions of politics that are based on how people understand the relationship between themselves and larger communities ferguson focuses not only on how different theoretical conceptions of political judgment relate to one another but also on their historical development and potential meaning for contemporary scholarship across the humanities and social sciences drawing on recent contributions to philosophy economics cultural studies feminism psychology and anthropology the politics of judgment demonstrates how modern political identities depend upon and are formed by aesthetic judgment political theorists social scientists philosophers and cultural critics will find this book especially useful though general readers will also be attracted by the author s keen insight into contemporary political questions

the land between the mediterranean sea and the jordan valley has been one of the most disputed territories in history since the establishment of the state of israel in 1948 palestinians and israelis have each sought claim to the national identity of the land through various martial social and scientific tactics but no method has offered as much legitimacy and national controversy as that of the map the politics of maps delves beneath the battlefield to unearth the cartographic strife behind the israel palestine conflict blending science and technology studies sociology and geography with a host of archival material in depth interviews and ethnographies this book explores how the geographical sciences came to be entangled with the politics territorial claim making and nation state building of israel palestine chapters chart the cartographic history of the region from the introduction of western scientific and legal paradigms that seemingly legitimized and depoliticized new land regimes to the rise of new mapping technologies and software that expanded access to cartography into the public sphere maps produced by various sectors like the peace camps or the jewish community enhanced national belonging while others like that of the green line served largely to divide the stories of israel s many boundaries reveal that there is no absolute technocratic solution to boundary making as boundaries continue to be controversial and the israeli palestinian conflict remains intractable and unresolved the politics of maps uses nationally based cartographic discourses to provide insight into the complexity fissures and frictions within internal political debates illuminating the persistent power of the nation state as a framework for forging identities citizens and alliances

this concise book explores the wide range of topics at the intersection of politics and the internet recognizing the changes in the internet over time klotz provides an innovative analysis

of online access activities advocacy government journalism and social capital the politics of the internet is considered along with politics on the internet a highlight is the in depth discussion of cyberlaw that provides an accessible framework for understanding the legal treatment of key issues such as music file sharing privacy terrorism spam pornography and domain names examples from the 2002 midterm elections and the early 2004 campaign fundraising success of howard dean add currency to the debate about the impact of the internet on democratic politics the author conveys the vitality and humor of internet politics in a way that readers will enjoy from impassioned debate about imaginary legislation to the animal rights group peta s lawsuit taking peta org from people eating tasty animals klotz brings the colorful history of the internet to life written from an interdisciplinary perspective the book is infused with original longitudinal data examples online resources and landmark events that reveal how the internet is enriching both public and private life

first published in 1992 the federal budget has attained unparalleled significance at the heart of american politics in the last quarter of the twentieth century the modern budget system has become the mechanism by which a distinctively american administrative state was put in place and made operative the growth of the administrative state has transformed politics in america but many americans are unaware of its existence this study looks at budget control within the realms of congress the presidency and the development of the administrative state

this collection asks what s at stake when a theatrical space is created and when a performance takes place under what circumstances the topology of theatre becomes political it visits a politics of inclusion and exclusion of distributions and placements and of spatial appropriation and utopian concepts in theatre history and contemporary performance

history is a powerful tool in the hands of politicians and can be a destructive weapon as power over the past is the power to decide who is a hero and who is a traitor tradition the remembrance of ancestors experiences of previous generations are keys that unlock the doors to citizens minds and allow certain ideas visions and political programs to flourish however can history be a proper political weapon during democratization processes when the past is decisively divided from the present are the new order and society founded on the basis of some interpretation of the past or rather are they founded only with reference to the imagined future of the nation this book explores such questions through a detailed description of the use of remembrance policies during political transformations it discusses how interpretations of the past served the realization of transitional objectives in countries as varied as chile estonia georgia poland south africa and spain the book is a unique journey through different parts of the world different cultures and different political systems investigating how history was remembered and forgotten by certain democratic leaders individual chapters discuss how governments remembrance policies were used to create a new citizen to change a political culture and to justify a vision of society promoted by new elites they explain why some sore topics were avoided by politicians and why sometimes there was no transitional justice or punishment of leaders of the authoritarian state the book will be of interest to anyone wishing to explore policies of remembrance democratization and the role of memory in contemporary

societies

while Spain is now a well established democracy closely integrated into the European Union it has suffered from a number of severe internal problems such as corruption discord between state and regional nationalism and separatist terrorism the politics of contemporary Spain charts the trajectory of Spanish politics from the transition to democracy through to the present day including the aftermath of the Madrid bombings of March 2004 and the elections that followed three days later it offers new insights on the main political parties and the political system on the monarchy corruption terrorism regional and conservative nationalism and on Spain's policies in the Mediterranean and the EU it challenges many existing assumptions about politics in Spain reaching beyond systems and practices to look at identities political cultures and mentalities it brings to bear on the analysis the latest empirical data and theoretical perspectives

Why have GM foods become so controversial comparing GM food politics in the US Britain and the European Union Toke draws on insights from discourse analysis to help explain this basic political struggle of our time by stressing the interplay between the material and discursive dimensions involved in the shaping of the conflict the work offers a detailed account that enriches our political understanding of these Frankenfoods on a variety of fronts in particular the interplay between scientific expertise and citizens politics those interested in the risk society both students and specialists will find much to learn from this perceptive analysis professor Frank Fischer Rutgers University USA the politics of GM food compares and explains how differing political outcomes have occurred regarding GM food and crops in the UK USA and the EU thus throwing light on the relationship between science and politics

Since Martin Luther vocations or callings have had a close relationship with daily work it is a give and take relationship in which the meaning of a vocation typically negotiates with the kinds of work available and vice versa at any given time while vocation language still has currency in Western culture today's predominant meaning of vocation has little to do with the actual work performed on a job Jeffrey Scholes contends that recent theological treatments of the Protestant concept of vocation both academic and popular often unwittingly collude with consumer culture to circulate a concept of vocation that is detached from the material conditions of work the result is a consumer friendly vocation that is rendered impotent to inform and if necessary challenge the political norms of the workplace for example he classifies Rick Warren's concept of purpose in his best selling book *The Purpose Driven Life* as a functional equivalent of vocation that acts in this way other popular uses of vocation along with insights culled from traditional theology and consumer culture studies help Scholes reveal the current state of vocations in the West using recent scholarship in the field of political theology he argues that resisting commodification is a possibility and a prerequisite for a political vocation if it is at all able to engage the norms that regulate and undermine the pursuit of justice in many modern workplaces

the traditional assumption today about race is that it is not political that it has no political

content and is a matter of individual beliefs and attitudes in race and the politics of the exception utz mcknight argues that race is in fact political and defines how it functions as a politics in the united states mcknight organizes his book into three sections beginning with a theoretical section about racial politics in the united states using theorists such as benjamin agamben and schmitt mcknight discusses how the idea of racial communities went from being constituted through the idea of racial sovereignty and a politics of the exception that defined blacks as the internal enemy to being constitutionally defined through the institutions of racial equal opportunity in the second section mcknight further develops his critical race theory by exploring in more detail the social use of race today the election of president obama has brought the politics of racial equality to a critical point in spite of a very powerful set of political tools to define it as a thing of the past race matters in the final section mcknight engages with important african american fiction from each of the three major periods of racial politics in the us earlier descriptions of political theory are used throughout these analyses to refine the argument for a new critical politics of race scholars of political theory identity politics african american studies and american studies will find this work ground breaking and relevant

with the ever increasing global significance of the olympic games it has never been more topical to address the political issues that surround influence and emanate from this quadrennial sporting mega event in terms of the most recent evidence of the politics of the olympics the 2008 beijing games were riddled with political messages and content from the outset and provided a global stage for protesters with numerous agendas these included to name but a few proposed boycotts potential terrorist attacks the question of open media access protests against china s political practices and attempts to interrupt the traditional torch rally essays in this collection focus on numerous political aspects of the olympics from a variety of different perspectives with a glossary that contains a range of politically relevant entries relating to famous and infamous olympic athletes olympic movement personnel and events and broader political issues and developments which have affected the modern games the purpose of this anthology is not to perpetuate hatred towards the concept and practices of olympism or to regurgitate a celebratory party line instead in addition to being informative the book offers critical engagement with the olympics by raising awareness of the movement s political significance consequently the essays in this anthology illustrate the strong but changing links between the modern olympic games and politics in general and address and discuss the key political aspects and issues with regard to the games themselves to national and international sport organisations and to specific countries attitudes to ab using the idea ideal of the olympics for their own political ends
