the development of ethics is a selective historical and critical study of moral philosophy in the socratic tradition with special attention to aristotelian naturalism its formation elaboration criticism and defence it discusses the main topics of moral philosophy as they have developed historically including the human good human nature justice friendship and morality the methods of moral inquiry the virtues and their connexions will freedom and responsibility reason and emotion relativism subjectivism and realism the theological aspect of morality this volume examines ancient and medieval philosophy up to the sixteenth century volumes 2 and 3 will continue the story up to rawls s theory of justice the present volume begins with socrates the cyrenaics and cynics and plato and then offers a fuller account of aristotle stressing the systematic naturalism of his position the stoic position is compared with the aristotelian at some length epicureans and sceptics are discussed more briefly chapters on early christianity and on augustine introduce a fuller examination of aquinas revision elaboration and defence of aristotelian naturalism the volume closes with an account of some criticisms of the aristotelian outlook by scotus ockham machiavelli and some sixteenth century reformers the emphasis of the book is not purely descriptive narrative or exegetical but also philosophical irwin discusses the comparative merits of different views the difficulties that they raise and how some of the difficulties might be resolved the book tries to present the leading moral philosophers of the past as participants in a rational discussion that is still being carried on and tries to help the reader to participate in this discussion

terence irwin s edition of the nicomachean ethics offers more aids to the reader than are found in any modern english translation it includes an introduction headings to help the reader follow the argument explanatory notes on difficult or important passages and a full glossary explaining aristotle s technical terms the third edition offers additional revisions of the translation as well as revised and expanded versions of the notes glossary and introduction also new is an appendix featuring translated selections from related texts of aristotle

this volume contains fourteen contributions to the topic of weakness of will in medieval philosophy it fills an important gap in current research by presenting aristotelian and non aristotelian medieval accounts of akrasia many of which have not yet been the object of scholarly writing they are not only of great intrinsic philosophical interest they also eminently document the transformation of ethical thought in the middle ages weakness of will is a test case for a wider range of problems in moral psychology and ethical theory the articles collected in this volume give insight into a variety of accounts of practical rationality that were directly or indirectly influential on modern thinkers the temporal framework of the volume exceeds the middle ages on both ends by including aristotle and authors from the renaissance and the reformation

what is the human good what are the primary virtues that make a good person what makes an action right must we try to maximize good consequences how can we know what is right and good can morality be rationally justified in ethics through history terence irwin addresses such fundamental questions making these central debates intelligible to readers without an extensive background in philosophy he provides an extended historical and philosophical discussion of the major questions and key philosophers in the history of ethics from socrates onwards irwin covers notable ancient medieval and modern moral philosophers whose engaging arguments have formed the agenda for contemporary ethical theory paying particular attention to both the strengths and weaknesses of their respective positions

this exceptional book examines and explains plato s answer to the normative question how ought we to live it discusses plato s conception of the virtues his views about the connection between the virtues and happiness and the account of reason desire and motivation that underlies his arguments about the virtues plato s answer to the epistemological question how can we know how we ought to live is also discussed his views on knowledge belief and inquiry and his theory of forms are examined insofar as they are relevant to his ethical view terence irwin traces the development of plato s moral philosophy from the socratic dialogues to its fullest exposition in the republic plato s ethics discusses plato s reasons for abandoning or modifying some aspects of socratic ethics and for believing that he preserves socrates essential insights a brief and selective discussion of the statesmen philebus and laws is included replacing irwin s earlier plato s moral theory oxford 1977 this book gives a clearer and fuller account of the main questions and discusses some recent controversies in the interpretation of plato s ethics it does not presuppose any knowledge of greek or any extensive knowledge of plato

ethics for rational animals brings to light a novel account of akrasia practical wisdom and character virtue through an original and comprehensive study of the moral psychology at the basis of aristotle s ethics it argues that practical wisdom is a persuasive rational excellence that virtue is a listening excellence and that the ignorance involved in akrasia is in fact a failure of persuasion aristotle s moral psychology emerges from this reconstruction as a qualified intellectualism the view is intellectualistic because it describes practical wisdom as the sort of knowledge that can govern desire and action and akrasia as involving a form of ignorance however aristotle s intellectualism is qualified because practical wisdom goes beyond grasping the truth about the human good for it must also be able to convey the truth persuasively to non rational cognition and desires through a study of aristotle s works on ethics psychology and biology elena cagnoli fieconi shows that there are unexplored ways in which rational and non rational cognition and desire cooperate and influence one another these include attention the capacity of the rational part of the soul to manipulate the non rational part of the soul and the capacity to exercise phantasia for speculation creativity and research she argues that despite being integrated with non rational cognition and desire rational cognition of value struggles to control human behaviour and motivation more specifically she defends the key thesis that grasping the truth about the human good is not sufficient for humans to regulate action and desire therefore practical wisdom does not merely grasp the truth about the human good but it controls action and desire because it conveys the truth effectively to the non rational part of the soul conversely akrasia does not merely involve a lack of epistemic access to the truth about the human good but a failure to persuade the non rational part of the soul about it this study of

practical wisdom and akrasia also sheds light on character virtue which emerges as a practical excellence whose task is to listen to reason

terence irwin presents a historical and critical study of the development of moral philosophy over two thousand years from ancient greece to the reformation starting with the seminal ideas of socrates plato and aristotle he guides the reader through the centuries that follow introducing each of the thinkers he discusses with generous quotations from their works he offers not only careful interpretation but critical evaluation of what they have to offer philosophically this is the first of three volumes which will examine the history of ethics in the socratic tradition up to the late 20th century

This edition also includes a new chapter on the latest social and political issues in American health care. DeVettere's engaging text relies on commonsense moral concepts and avoids academic jargon. It includes a glossary of legal, medical, and ethical terms, an index of cases, and thoroughly updated bibliographic essays at the end of each chapter that offer resources for further reading. It is a true classic, brilliantly conceived and executed, and is now even more valuable to undergraduates and graduate students, medical students, health care professionals, hospital ethics committees, and institutional review boards, and general readers interested in philosophy, medicine, and the rapidly changing field of health care ethics.

This volume presents a selection of Robert Stern's work on the theme of Kantian ethics. It begins by focusing on the relation between Kant's account of obligation and his view of autonomy, arguing that this leaves room for Kant to be a realist about value. Stern then considers where this places Kant in relation to the question of moral scepticism and in relation to the principle of ought implies can, and examines this principle in its own right. The papers then move beyond Kant himself to his wider influence and to critics of his work, including Hegel, the British idealists, and the Danish philosopher and theologian K. E. Løgstrup, while also offering a comparison with William James's arguments for freedom. The collection concludes with a consideration of a broadly Kantian critique of divine command ethics offered by Stephen Darwall, arguing that the critique does not succeed. General themes considered in this volume therefore include value, perfectionism, agency, autonomy, moral motivation, moral scepticism, and obligation, as well as the historical place of Kant's ethics and its influence on thinkers up to the present day.

The editors, working with a team of 325 renowned authorities in the field of ethics, have revised, expanded, and updated this classic encyclopedia along with the addition of 150 new entries. All of the original articles have been newly peer-reviewed, and revised bibliographies have been updated throughout. The overall design of the work has been enhanced for easier access to cross-references and other reference features. New entries include cheating, dirty hands, gay ethics, Holocaust, journalism, political correctness, and many more.

This book consolidates emerging research on Aristotle's science and ethics in order to explore the

extent to which the concepts methods and practices he developed for scientific inquiry and explanation are used to investigate moral phenomena each chapter shows in a different way that aristotle s ethics is much more like a science than it is typically represented the upshot of this is twofold first uncovering the links between aristotle s science and ethics promises to open up new and innovative directions for research into his moral philosophy second showing why aristotle thinks ethics can never be fully assimilated to the model of science will help shed new light on his views about the limits of science the volume thus promises to make a significant contribution to our understanding of the epistemological metaphysical and psychological foundations of aristotle s ethics

this book allows philosophers literary theorists and education specialists to come together to offer a series of readings on works of children s literature each of their readings is focused on pairing a particular popular picture book or a chapter book with philosophical texts or themes the book has three sections the first on picturebooks the second on chapter books and the third on two sets of paired readings of two very popular picturebooks by means of its three sections the book sets forth as its goal to show how philosophy can be helpful in reappraising books aimed at children from early childhood on particularly in the third section the book emphasizes how philosophy can help to multiply the type of interpretative stances that are possible when readers listen again to what they thought they knew so well the kinds of questions this book raises are the following how are children s books already anticipating or articulating philosophical problems and discussions how does children s literature work by means of philosophical puzzles or language games what do children s books reveal about the existential situation the child reader faces in posing and answering these kinds of questions the readings within the book thus intersect with recent developing scholarship in children s literature studies as well as in the psychology and philosophy of childhood

how pornography silences women and radical feminist politics complicity in racism among these insightful essays sandra bartky argues that women share guilt for racism when they benefit from it without protest susan brison reflects on uses of narrative in trauma recovery from such experiences as being targeted for rape or murder joan callahan examines fallout of derogatory speech directed at lesbians virginia held proposes carrying care into marketplaces and governments and in her introduction claudia card draws on primo levi's conception of gray zones in exploring dangers of character damage to victims of misogyny a fitting companion to card's highly regarded feminist ethics this volume interweaves observations on character political ethics violence and love into an accessible sourcebook for students it tackles some of feminism's most pressing issues and helps readers to identify and then overcome the real damage caused by oppression

philosophical tradition holds that character traits are global if you possess a particular character trait you will perform trait related behavior across a broad range of situations in situational traits of character dispositional foundations and implications for moral psychology and friendship a groundbreaking study at the intersection of ethics moral psychology and metaphysics candace l upton offers an intriguing alternative to this philosophical tradition by appealing to both normative considerations and the metaphysics of dispositions upton argues that character traits should be understood situationally after developing and defending her situational account of character traits upon uses this account to adjudicate the debate over the compatibility of the demands of consequentialism with those of genuine friendship in favor of the friendly consequentialist

in this first comprehensive treatment of plato's political thought in a long time john wallach offers a critical historicist interpretation of plato wallach shows how plato's theory while a radical critique of the conventional ethical and political practice of his own era can be seen as having the potential for contributing to democratic discourse about ethics and politics today the author argues that plato articulates and solves his socratic problem in his various dialogues in different but potentially complementary ways the book effectively extracts plato from the straightjacket of platonism and from the interpretive perspectives of the past fifty years principally those of karl popper leo strauss hannah arendt m i finley jacques derrida and gregory vlastos the author's distinctive approach for understanding plato and he argues for the history of political theory in general can inform contemporary theorizing about democracy opening pathways for criticizing democracy on behalf of virtue justice and democracy itself

creon's ghost examines the enduring problem of the relationship between man's law and a higher law from the perspective of core humanities texts and through discussion of hotly debated contemporary legal conundrums today such issues as intelligent design in school curricula same sex marriage and faith based government grants are all examples of the interaction between man's law and some other set of moral principles as these debates are considered in this book the author uses texts such as antigone and plato's republic and pairs them with the most important jurisprudence texts of the 20th century to explore different approaches to the contemporary

conflict or court ruling under consideration creon's ghost demonstrates that the humanities can both illuminate our understanding of contemporary problems and that classic texts can be read alongside jurisprudential texts thus enriching our understanding of and appreciation for law

the moral inquiry into the nature of justice is often marginalized as contemporary discussions focus primarily on political considerations yet the need to examine the moral framework of justice is fundamental what is the point of justice after all if not to establish a moral framework for political interactions the question resonates especially when recognizing that no monocultures exist over time and space in examining plato's thoughts on individual and social morality *dikaioσύνη* and aristotle's focus on individual virtue *arête* and the pursuit of well being *eudaimonia* the author proffers foundational resources for today's discussions of justice moreover he brings this nexus of thought into conversation with theories that have emerged over the centuries such as kant's concept of due concern and respect individual rights and responsibilities as in hobbes locke and j s mill thus he engages contemporary disputes of justice including distributive vs relational schemes choice vs chance considerations group rights theories value pluralism the right vs the good as well as international and future justice his inquiry concludes with the provision of a deontological framework set against a liberal political context justice as right actions for further examination of questions of justice

this book provides a comprehensive systematic theory of moral responsibility the authors explore the conditions under which individuals are morally responsible for actions omissions consequences and emotions the leading idea in the book is that moral responsibility is based on guidance control this control has two components the mechanism that issues in the relevant behavior must be the agent s own mechanism and it must be appropriately responsive to reasons the book develops an account of both components the authors go on to offer a sustained defense of the thesis that moral responsibility is compatible with causal determinism

this volume provides a comprehensive account of how scholarship on affect and scholarship on texts have come to inform one another over the past few decades the result has been that explorations of how texts address elicit shape and dramatize affect have become central to contemporary work in literary film and art criticism as well as in critical theory rhetoric performance studies and aesthetics guiding readers to the variety of topics themes interdisciplinary dialogues and sub disciplinary specialties that the study of interplay between affect and texts has either inaugurated or revitalized the handbook showcases and engages the diversity of scholarly topics approaches and projects that thinking of affect in relation to texts and related media open up or enable these include but are not limited to investigations of what attention to affect brings to established methods of studying texts in terms of period genre cultural contexts rhetoric and individual authorship
