conceptions and claims on these things in a versatile manner return claims according to the thesis appear as a magnifying lens which discloses diverging conceptions of things and ontologies

cultural heritage law and its response to human rights principles and practice has gained renewed prominence on the international agenda the recent conflicts in syria and mali china s use of shipwreck sites and underwater cultural heritage to make territorial claims and the cultural identities of nations post conflict highlight this field as an emerging global focus in addition it has become a forum for the configuration and contestation of cultural heritage rights and the broader politics of international law the manifestation of tensions between heritage and human rights are explored in this volume in particular in relation to heritage and rights in collaboration and in conflict and heritage as a tool for rights advocacy this volume also explores these issues from a distinctively legal standpoint considering the extent to which the legal tools of international human rights law facilitate or hinder heritage protection covering a range of issues across africa asia europe latin america and australia this volume will be of interest to people working in human rights heritage studies cultural heritage management and identity politics around the world this book fills an important gap in the literature on heritage and rights and in particular human rights law with articles from leading experts addressing the legal human rights dimensions of cultural heritage protection it makes a significant contribution to debates over issues such as why should we safeguard heritage and for whom and what is the relationship between heritage safeguarding and protecting human rights these are deep questions of profound significance to individuals communities and even nations around the world and are of increasing urgency today it critically analyses the

industrial capitalism is broken the signs which transcend national ideologies are everywhere climate change ecological overshoot financial exhaustion fraying social safety nets corporate fraud government deceit civic unrest terrorism and war but there is hope this

book tells how transformation is taking root in the corporate world the last place many of us would look for solutions the book tells the stories of seven exceptional companies their shared secret is a new mental model of the firm that is the virtual opposite of industrial capitalism each company if not already a household name is a significant player within their industry and crucially has outperformed their competitors lessons can be learned it works like this instead of modeling themselves on the assumed efficiency of machines a thought process that emerged during the industrial age these firms model themselves on living systems firms with open ethical inclusive traditions where employees have a voice and a stake in what happens have a distinct advantage over traditionally managed companies where most decisions are made at the top understanding that everything of value ultimately arises from life they place a higher value on living assets people and nature than they do on non living capital assets the energy they invest in stewarding those assets a practice described in the book as living asset stewardship las is transformative
