what values should form the foundation of music education and once we decide on those values how do we ensure we are acting on them in values and music education esteemed author estelle r jorgensen explores how values apply to the practice of music education we may declare values but they can be hard to see in action jorgensen examines nine quartets of related values and offers readers a roadmap for thinking constructively and critically about the values they hold in doing so she takes a broad view of both music and education while drawing on a wide sweep of multidisciplinary literature not only does jorgensen demonstrate an analytical and dialectical philosophical approach to examining values but she also seeks to show how theoretical and practical issues are interconnected an important addition to the field of music education values and music education highlights values that have been forgotten or marginalized underscores those that seem perennial and illustrates how values can be double edged swords

this handbook offers a global perspective on the historical development of educational institutions systems of schooling educational ideas and educational experiences its 36 chapters consider the field s changing scholarship while examining particular national and regional themes and offering a comparative perspective each also provides suggestions for further research and analysis

over recent decades national higher education sectors across the world have experienced a gradual process of marketisation this book offers a new interpretation on why and how marketisation has taken place within england it explores distinct assumptions on the nature of graduate work and how the graduate labour market drives

the argumentation for more market and choice demonstrating the flaws in these assumptions which are based on an idealised relationship between higher education and high skilled work this book fills an important need by questioning the current rationale for further marketisation

educational institutions are undergoing complex and sensitive changes in the context of immigration international mobility globalisation and shifting economic scenarios making highly challenging demands on educational leaders leadership is increasingly being perceived and theorised as pivotal to students achievement and institutional performance in this book saeeda shah considers educational leadership from an islamic perspective to debate theoretical positions underpinned by islamic texts and teachings and the resulting conceptualisations and interpretations while educational leadership literature and research have flourished in recent years this is predominantly informed by western ideologies concepts theories and practices education leadership and islam focuses on contemporary educational settings and practices drawing on research and empirical evidence from multicultural contexts in order to enrich theory and inform policy and practice in relevant frameworks particularly in relation to the growing muslim population in the west chapters also discuss gender in islam educational expectations and islamic faith schools to comprehensively explore education in relation to islamism situating muslims within contemporary societies this book extends debates regarding educational philosophy and leadership endorsing diversity and plurality through an appreciation of difference education leadership and islam will appeal to education researchers as well as social and political scientists attempting to understand muslim educational issues in contemporary life both in the east and in the west this book offers critical insight into educational theory and practice and as such will be key reading for policy makers and educational leaders

rights language is a fundamental feature of the modern world virtually all significant social and political struggles are waged and have been waged for over a century now in terms of rights claims in some ways it is precisely the birth of modern rights language that ushers in modernity in terms of moral and political thought and the struggle for a modern way of life seems for many synonymous with the fight for a universal recognition of equal individual human rights where did modern rights language come from what kinds of rights discourses is it rooted in what is the specific nature of modern rights discourse when and where were medieval and ancient notions of rights transformed into it can one in fact find any single such transformation of medieval into modern rights discourse the present volume brings together some of the most central scholars in the history of medieval and early modern rights discourse through the different angles taken by its authors the volume brings to light the multifaceted nature of rights languages in the medieval and early modern world

we offer in this book a collection of chapters that reflect a broad range of issues linking globalization to education in an accessible yet theoretically grounded and detailed form the authors analyze phenomena on the global plane in local spaces and in the connections between the global and the local new developments such as the growing impact of technology on education the emergence of new policy actors the growing expansion and segmentation of higher education the salience of human rights among others are emerging as powerful agendas shaping all levels of education in fundamental ways the forces of globalization challenge the previous approaches and theories of national development recognizing the areas of convergence dissonance and conflict should help us grasp with greater clarity the implications of globalization for education and knowledge in the xxi century the contributors to this book include both well known scholars in the field of comparative education as well as young scholars the chapters present a balanced geographical coverage in terms of authors and the countries regions examined the second edition has been thoroughly updated throughout and contains seven new chapters the expanding interest in the intersection of education and globalization has brought up several new topics including the salience of global education policies notably efa the expansion and differentiation of higher education the emphasis on work related training the increasing role of non state actors such as the transnational corporations and greater attention to human rights also in this new edition is a chapter on qualitative methodologies especially suitable to the understanding of the intersection of globalization and education

combining contributions from international academics and practitioners this new text develops students ability to philosophise as well as learn about philosophy and education it considers issues concerned with the interface between education and wider society but goes beyond this to explore education and philosophy at a micro level the teacher learner relationship it challenges and empowers students to use philosophy as a tool within education as a set of theories to understand education and as a potential

means to develop solutions to problems as they occur within practice assuming no pre existing philosophical background philosophy and the study of education explores complex topics including encouraging young people to criticise and challenge all authority the limits of a religious based education the desire for alternative facts or truths the second class status of vocational pursuits the inherent struggle in the teacher student relationship the relationship between emotion morality and autonomy in teaching including discussion questions and further recommended reading this thought providing book will support and inspire all those on education studies childhood studies and youth studies courses in developing a critical perspective and understanding the true value of philosophy within education

the teaching of culture and interculturality is today viewed as an integral part of foreign language education this book presents insights from recent research on the role of culture in second foreign and heritage language education it contains 14 chapters including an introductory chapter that discusses diachronically the evolving notion of culture and how the sociocultural view of culture as a complex and dynamic concept informs language teaching and language learning research the chapters following the introduction are organised in four parts focusing on 1 the teacher s role in integrated language and culture learning 2 the interrelationship between culture identity and language learning and use 3 the effect of culture on learner characteristics which impact language learning processes and outcomes and 4 curriculum development aimed at fostering language and culture learning the chapters in parts 1 to 3 present contributions from current research either in the form of the authors original studies or comprehensive reviews of relevant essential research which bears important implications for curricular practice in foreign language and language teacher education this close link between research theory and practice is also maintained in the two chapters in part 4 which present developmental projects based on well grounded theoretical frameworks

at a time of rapid social change and numerous policy initiatives there is a need to question the nature and function of school curricula and the purposes of formal public education comparing curriculum developments around the globe understanding the school curriculum draws on a range of educational philosophical and sociological theories to examine the question what is a curriculum for in considering different answers to this fundamental question it explores a range of topical issues and debates including tensions and dynamics within curriculum policy the implications of uncertainty and rapid social change for curriculum development the positive and negative influence of free market ideologies on public education the impact of globalization and digital technologies arguments for and against common core curricula and state control it examines the possibility of a school curriculum that is not shaped and monitored by dominant interests but that has as its founding principles the promotion of responsibility responsiveness a love of learning and a sense of wonder and respect for the natural and social world understanding the school curriculum is for all students following undergraduate and masters courses in curriculum public policy and education related

subjects it is also for all training and practising teachers who wish to combine a deeper understanding of major curriculum issues with a critical understanding of the ways in which ideologies impact on formal state education and to consider ways of producing school curricula that are appropriate to the times we live in

education liberal democracy and populism arguments from plato locke rousseau and mill provides a lucid and critical guide shedding light on the continuing relevance of earlier thinkers to the debates between populists and liberals about the nature of education in democratic societies the book discusses the relationship rousseau and plato posited between education and society and contrasts their work with the development of liberal thinking about education from john locke and john stuart mill s arguments for the importance of education to representative democracy it explores some of the roots of populism and offer a broader perspective from which to assess the questions which populists pose and the answers which liberals offer the book makes a substantial contribution to the current debate about democracy by emphasising the central importance of education to political thought and practice and suggests that only an education system based on liberal democratic principles can offer the possibility of a genuinely free society this book is ideal reading for researchers and post graduate students in education politics philosophy and history it will also be of great interest to educational practitioners and policy makers
