in the value of literature rafe mcgregor employs a unique approach the combination of philosophical work on value theory and critical work on the relationship between form and content to present a new argument for and defence of literary humanism he argues that literature has value for art for culture and for humanity in short that it matters unlike most contemporary defenders of literary value the author's strategy does not involve arguing that literature is good as a means to one of the various ends that matter to human beings it is not that literature necessarily makes us cleverer more sensitive more virtuous more creative or just generally better people nor is it true that there is a necessary relation between literature and edification clarification cultural critique catharsis or therapy rather than offer an argument that forges a tenuous link between literature and truth or literature and virtue or literature and the sacred this book analyses the non derivative sui generic value characteristic of literature and demonstrates why that matters as an end in itself

death and destruction are unavoidable effects of war and combat situations the fact that people have been killed or injured or property has been destroyed should not encourage anyone to rush to the conclusion that war crimes have been committed on the contrary before reaching such a conclusion it is necessary to carefully analyze the conduct of the person causing death injury or

damage in order to ascertain whether such conduct is consistent with international humanitarian law technology law and public opinion on what is acceptable has greatly evolved since world war ii the issue of civilian damage caused in combat operations has become an important topic in public opinion since operation desert storm in 1991 public pressure to limit incidental civilian damage has notably increased following the nato aerial campaign in kosovo in 1999 and the subsequent conflicts in afghanistan in 2001 iraq in 2003 and lebanon 2006 unlawful attacks in combat situations focuses on the manner in which unlawful attacks launched during the conduct of hostilities have been dealt with in the rome statute of the international criminal court the international treaty which to date deals most comprehensively with war crimes committed in international and non international armed conflicts and in the case law of the international criminal tribunal for the former yugoslavia the first international judicial body that has investigated and prosecuted crimes committed during the conduct of hostilities since world war ii

volume 39 sermons 2289 2341 charles spurgeon 19 june 1834 31 january 1892 is one of the church's most famous preachers and christianity's foremost prolific writers called the prince of preachers he was one of england's most notable ministers for most of the second half of the nineteenth century and he still remains highly influential among christians of different denominations today his sermons have spread all over the world and his many printed works have been cherished classics for decades in his lifetime spurgeon preached to more than 10 million people often up to ten times each week he was the pastor of the congregation of the new park street chapel later the metropolitan tabernacle in london for 38 years he was an inexhaustible author of various kinds of works including sermons commentaries an autobiography as well as books on prayer devotionals magazines poetry hymns and more spurgeon was known to produce powerful sermons of penetrating thought and divine inspiration and his oratory and writing skills held his audiences spellbound many christians have discovered spurgeon's messages to be among the best in christian literature edward walford wrote in old and new london volume 6 1878 quoting an article from the times regarding one of spurgeon's meetings at surrey fancy a congregation consisting of 10 000 souls streaming into the hall mounting the galleries humming buzzing and swarming a mighty hive of bees eager to secure at first the best places and at last any place at all after waiting more than half an hour

for if you wish to have a seat you must be there at least that space of time in advance mr spurgeon ascended his tribune to the hum and rush and trampling of men succeeded a low concentrated thrill and murmur of devotion which seemed to run at once like an electric current through the breast of every one present and by this magnetic chain the preacher held us fast bound for about two hours it is not my purpose to give a summary of his discourse it is enough to say of his voice that its power and volume are sufficient to reach every one in that vast assembly of his language that it is neither high flown nor homely of his style that it is at times familiar at times declamatory but always happy and often eloquent of his doctrine that neither the calvinist nor the baptist appears in the forefront of the battle which is waged by mr spurgeon with relentless animosity and with gospel weapons against irreligion cant hypocrisy pride and those secret bosom sins which so easily beset a man in daily life and to sum up all in a word it is enough to say of the man himself that he impresses you with a perfect conviction of his sincerity more than a hundred years after his death charles spurgeon s legacy continues to effectively inspire the church around the world for this reason delmarva publications has chosen to publish the complete works of charles spurgeon

this volume is the first to contain all of rosa luxemburg s eloquent writings on the 1917 russian and 1918 19 german revolutions also contained here are articles essays and manuscripts on the european socialist movement prior to world war i and on her efforts to rebuild the socialist movement on revolutionary foundations in its aftermath much of this material appears in english for the first time luxemburg s contributions on revolutionary strategy and the transition to socialism reveal a profound commitment to radical democracy which becomes evident as she elaborates on her lived experience with razor sharp conceptualizations of the mass strike her democratic commitment is also highlighted in her deepening conflict with the bureaucratic conservatism afflicting the german social democratic party she is horrified yet at the same time grimly analytical while surveying the unfolding violence and brutality of world war i deeply inspired by russia s 1917 upsurge she is nonetheless compelled to analyze and criticize fatal limitations of the russian revolution swept up in the revolutionary chaos sweeping through germany in 1918 19 which results in her own martyrdom she gives voice on the eve of her assassination to the revolution s final testament i was i am i shall be
