how do understandings of the relationships between gender violence security and the international inform policy and practice in which these notions are central what are the practical implications of basing policy on problematic discourses in this highly original poststructural feminist critique the author maps the discursive terrains of institutions both ngos and the un which formulate and implement resolutions and quides of practice that affect gender issues in the context of international policy practices the author investigates un security council resolution 1325 passed in 2000 to address gender issues in conflict areas in order to examine the discursive construction of security policy that takes gender seriously in doing so she argues that language is not merely descriptive of social political reality but rather constitutive of it moving from concept to discourse and in turn to practice the author analyses the ways in which the resolution s discursive construction had an enormous influence over the practicalities of its implementation and how the resulting tensions and inconsistencies in its construction contributed to its failures the book argues for a re conceptualisation of gendered violence in conjunction with security in order to avoid partial and highly problematic understandings of their practical relationship drawing together theoretical work on discourses of gender violence and international security sexualised violence in war gender and peace processes and the domestic international dichotomy with her own rigorous empirical investigation the author develops a compelling discourse theoretical analysis that promises to have far reaching impact in both academic and policy environments

taking an anthropological perspective this comprehensive book offers a highly readable and concise overview of what constitutes gender violence its social context and important directions in intervention and reform uses stories personal accounts case studies and a global perspective to provide a vivid and engaging portrait of forms of violence in gendered relationships extensively covers many forms of gender violence including domestic violence rape murder wartime sexual

assault prison and police violence female genital cutting dowry murders female infanticide honor killings and sex trafficking examines major approaches to diminishing gender violence such as criminalization batterer retraining programs and human rights interventions highlights the role of social movements in defining the problem and mobilizing reforms in the us and internationally

the nature of human security is changing globally interstate conflict and even intrastate conflict may be diminishing worldwide yet threats to individuals and communities persist large scale violence by formal and informal armed forces intersects with interpersonal and domestic forms of violence in mutually reinforcing ways gender violence and human security takes a critical look at notions of human security and violence through a feminist lens drawing on both theoretical perspectives and empirical examinations through case studies from a variety of contexts around the globe this fascinating volume goes beyond existing feminist international relations engagements with security studies to identify not only limitations of the human security approach but also possible synergies between feminist and human security approaches noted scholars aili mari tripp myra marx ferree and christina ewig along with their distinguished group of contributors analyze specific case studies from around the globe ranging from post conflict security in croatia to the relationship between state policy and gender based crime in the united states shifting the focus of the term human security from its defensive emphasis to a more proactive notion of peace the book ultimately calls for addressing the structural issues that give rise to violence a hard hitting critique of the ways in which global inequalities are often overlooked by human security theorists gender violence and human security presents a much needed intervention into the study of power relations throughout the world

gender violence and justice is a volume of collected essays by an expert in the field of violence against women and pastoral theology it represents over three decades of research advocacy and pastoral theological reflection on the subject of sexual and domestic violence topics include intimate partner violence sexual abuse and trauma and clergy sexual misconduct controversial

theological issues such as forgiveness and as well positive frameworks for fostering well being in families church and society framed by a foreword and an introduction that place this work in the context of new and contemporary challenges in theory and practice these essays show an evolution of issues and frameworks for theology care and activism arising over time from the movement to end violence against women both within and beyond religious communities while at the same time demonstrating an unchanging core commitment to gender justice

this is an exciting and innovative book which provides a thorough introduction to contemporary social theory by examining the way in which the widespread existence of violence against women is explored a wide range of theories from liberalism to evolutionary psychology are considered culminating in the development of a distinctive feminist realist position the theories discussed are tested against a large scale survey the findings of which challenge many conventional wisdoms as to the patterning of violence in contemporary society

this book critically examines gender based violence in india and interrogates the legal and policy discourse surrounding it it discusses various forms of violence faced by women such as sex selective abortion trafficking rape domestic violence as well as the violence faced by female sex workers and transgenders in india it draws on in depth interviews and case studies to highlight the socio economic conditions of the survivors who find themselves forced to contend with legal and policy framework that is inadequate to deal with these issues the author analyses the major laws against violence and the policies introduced to ameliorate the condition of survivors in order to understand the potential and challenges of these initiatives from a postmodern and feminist perspective the book also addresses the survivors realisation of agency and resistance which is seen to be expressed both sporadically and on day to day basis an important and timely contribution this book will be indispensable to students and researchers of gender and sexuality feminism minority studies sociology and social policy politics law human rights and south asian studies it will also be of interest to policymakers government agencies think tanks and ngos

working in the area

gender violence and attitudes explores the history of gender based violence in early modern europe particularly intimate partner violence and sexual violence it also investigates the legacy of gender based violence through the enlightenment to the present day and offers a historical background to highly topical human rights issues although the individual subjects of gender and the history of violence are not new topics the gendering of violence has received little examination within this book the history of attitudes and practices related to gender and power are analysed and the nature of violence justice and societal considerations of gender are explored as cultural constructs they have the capacity to change over time although there also is a tendency for continuity the study is based on a wide range of sources including marriage guides poems plays legal texts and court records exploring deep rooted violence phenomena in sweden including historical finland the german territories england and to some extent france offering a detailed analysis of gender and the culture of violence gender violence and attitudes is essential reading for students and general readers who wish to understand the history of violence and its continual association with gender from early modern europe to the present day

this book uses an interdisciplinary approach to chart how various forms of violence domestic military legal and political are not separate instances of violence but rather embedded in structural inequalities brought about by colonialism occupation and state violence the book explores both case studies of individuals and of groups to examine experiences of violence within the context of gender and structures of power in modern indonesian history and indonesia related diasporas it argues that gendered violence is particularly important to consider in this region because of its complex history of armed conflict and authoritarian rule the diversity of people that have been affected by violence as well as the complexity of the religious and cultural communities involved the book focuses in particular on textual narratives of violence visualisations of violence commemorations of violence and the politics of care

the democratic republic of congo drc has been called the worst place in the world for women with reports of widespread and horrific incidents of rape and sexual violence and almost complete impunity for the perpetrators of such violence however despite the high profile media reporting on sexual violence in the drc and the widely publicized responses of the international community there is still very little real analysis of the real situation of women in the country this book provides such detailed analysis of gender relations in the drc and goes beyond the usual explanations of sexual violence as a product of conflict to examine the complex and socially constructed gender norms and roles which underlie incidences of violence the book benefits from a comprehensive account of men s and women s roles in conflict violence peace building and reconstruction and evaluates the impacts of national and international political responses in doing so this book provides valuable new evidence and analysis of the complex and multilayered conflicts in the drc

feminist research on gender violence and abuse has been an area of academic study since the late 1970s and has increased exponentially over this time on a global scale although situated in a predominantly qualitative tradition research in the field has developed to include quantitative and mixed methodologies this book offers a compendium of research methods on gender and violence from the traditional to the innovative and showcases best practice in feminist research and international case studies researching gender violence and abuse covers the origins of feminist research ethical considerations relating to research on gender violence and abuse working in partnership with organisations such as the police or the voluntary sector a comprehensive range of research methods including interviews and focus groups surveys arts based research and ethnography the challenges and opportunities of working with existing data the influence of activism on research and the translation of research into policy and practice this book is perfect reading for students taking courses on violence against women domestic violence gender and crime as well as advanced students embarking on new research

the challenge of violence against women should be recognised as an issue for the state citizenship and the whole community this book examines how responses by the state sanction violence against women and shape a woman s citizenship long after she has escaped from a violent partner drawing from a long term study of women s lives in australia including before and after a relationship with a violent partner it investigates the effects of intimate partner violence on aspects of everyday life including housing employment mental health and social participation the book contributes to theoretical explanations of violence against women by reframing it through the lens of sexual politics finally it offers critical insights for the development of social policy and practice

gendered violence abuse and mental health in everyday lives beyond trauma offers new insights into the social dimensions of emotional distress in abuse related mental health problems and explores the many interconnections between gendered violence different forms of abuse and poor mental health looking at how individuals can overcome the impact of abuse over the course of their lives moulding maps a feminist informed recovery oriented approaches to therapy and prevention drawing on sociological perspectives and a wide range of international research as

well as original qualitative data presented here for the first time this book demonstrates how gender and other social power relations play out in the specific emotional dimensions of some of the mental health problems most strongly linked to abuse including post traumatic stress disorder anxiety depression and eating disorders critiques the way that mainstream psychological theory and research pathologises the effects of abuse through various mental illness diagnoses obscuring the nature of the individual emotional distress involved its social context and relational nature outlines a feminist informed recovery oriented approach that aims to reduce violence against women and children this innovative volume is an important contribution to the literature on the impact of violence and abuse on the lives and health of its survivors it will be of interest to students and researchers from a range of disciplines and professions including social work gender studies sociology social policy psychology counselling mental health public health medicine and nursing

violence constitutes a major form of oppressing women rooted in the practical experiences of rural indian women countering gender violence explores those facets of social cultural and economic life that otherwise appear to have little bearing on gender violence and hence are rarely examined this book studies the phenomenon of violence which while being meted out to individual women is systematically rooted in the social pattern of gender relations addressing gender violence requires challenging the means by which gender roles and power relations are defined and articulated in society the book focuses on ways through which these relations can be altered in favour of women the author concludes that strategies for countering gender violence must emerge from women s collective and shared experience of both subordination and empowerment

gender crime and victimisation is a thoughtful and thought provoking book exploring gender patterns in both offending and victimization it offers a thorough examination of how these patterns in society are variously established and represented researched explained and responded to by policy makers and criminal justice agencies bringing together key theory research and policy

these cases gender violence and criminal justice in the colonial pacific highlights the extent to which colonial bureaucracies engaged with and affected private lives as well as the varied ways in which individuals and communities responded to such intrusions and themselves reshaped legal practices and institutions in the pacific with bureaucratic institutions unable to deal with the complex realities of colonial lives stevens reveals how the courtroom often became a theatrical space in which authority was performed deliberately obscuring the more complex and violent practices that were central to both colonialism and colonial law making exploring the intersections of legal pluralism and local pragmatism across british and french colonialization in the pacific this book shows how island communities and early colonial administrators adopted diverse and flexible approaches towards criminal justice pursuing alternative forms of justice ranging from unofficial courts to punitive violence in order to deal with cases of sexual assault the ebook editions of this book are available open access under a cc by nc nd 4 0 licence on bloomsburycollections com open access was funded by university of waikato new zealand

despite changes to laws and policies across most western democracies intended to combat violence to women intimate partner violence and abuse ipva remains discouragingly commonplace domestic violence and psychology critical perspectives on intimate partner violence and abuse showcases women s harrowing stories of living with and leaving violent partners offering a psychological perspective on domestic violence and developing a theoretical framework for examining the context intentions and experiences in the lives of people who experience abuse and abuse themselves nicolson provides an analysis of survivors real life stories and thoughts about ipva the attitudes of the general public and health and social care professionals are also presented and discussed the theoretical perspective employs three levels of evidence the material context

discursive explanations and intrapsychic emotional domestic violence and psychology is divided into three parts accordingly engaging qualitative data from interviews and quantitative data from surveys to illustrate these theoretical perspectives although many pro feminist sociologists and activists firmly believe that any attempt to explain domestic violence potentially condones it this book takes up the challenge to make a compelling case demonstrating how we need to widen understanding of the psychology of survivors and their intimate relationships if we are to defeat ipva the new edition has been updated to include the latest developments in ipva research and practice and in particular examines the impact of a violent and abusive family life on all members including children this is essential reading for students academics and professionals interested in domestic abuse as well as professionals and practitioners including psychologists social workers the police prison officers probation staff policy makers and charity workers

this book aims to provide an up to date and comprehensive introduction to the subject of domestic violence and its interaction with the criminal justice system including agencies such as the police the crown prosecution service the probation service and children's services the courts and the prison service as well as voluntary agencies such as women's aid the book also looks at how these various agencies work together at a local level and the coordinating role of the home office and the direction provided at a central level domestic violence and criminal justice examines the phenomenon of domestic violence the various forms it takes and the theories that have been put forward to explain it it takes an historical approach to examine policy and legislative developments over the last forty years and how those developments make themselves manifest today the authors provide an authoritative and critical account of the different agencies and the work they carry out both independently and jointly they also consider the limits of a crime centred response to domestic violence the book provides a conceptual framework in which domestic violence and criminal justice might be better understood it covers all the current issues in this field and it will be a source book in directing readers to further reading it will be essential reading for both students and practitioners in the field

this book presents papers from an international symposium on contact disputes and allegations of domestic violence identifying best practices held in london in may 2017 the editors invited a group of international experts to explain the approaches taken in their jurisdictions to allegations of domestic violence in child contact cases with a view to identifying international best practices in such cases the book includes contributions from england and wales scotland ireland canada sweden and spain as well as information presented at the symposium from new zealand and australia the chapters include attention to particular issues such as specialist domestic violence courts judicial training and hearing children s voices collectively the chapters identify a set of common problems experienced across all of the jurisdictions including an overwhelming emphasis on the value of children s ongoing contact with non resident parents and the consequent minimisation of domestic violence and the muting of the voices of children who do not wish to have contact with abusive parents best practices in taking domestic violence seriously and providing adequate protection from further abuse for children and non abusive parents were less in evidence however the concluding chapter draws together details of several initiatives and approaches which offer promising ways forward the chapters in this book were originally published as a special issue of the journal of social welfare and family law
