one of a small group of feminist pioneers in the historical profession estelle b freedman teaches and writes about women s history with a passion informed by her feminist values over the past thirty years she has produced a body of work in which scholarship and politics have never been mutually exclusive this collection brings together eleven essays eight previously published and three new that document the evolving relationship between academic feminism and political feminism as freedman has studied and lived it following an introduction that presents a map of the personal and intellectual trajectory of freedman s work the first section of essays on the origins and strategies of women s activism in u s history reiterates the importance of valuing women in a society that has long devalued their contributions the second section on the maintenance of sexual boundaries explores the malleability of both sexual identities and sexual politics underlying the collection is an inquiry into the changing meanings of gender sexuality and politics during the nineteenth and twentieth centuries along with a concern for applying the insights of women s history broadly from the classroom to the courthouse

in contemporary feminist theory the problem of feminine subjectivity persistently appears and reappears as the site that grounds all discussion of feminism in feminism and the abyss of freedom linda m g zerilli argues that the persistence of this subject centered frame severely limits feminists capacity to think imaginatively about the central problem of feminist theory and practice a politics concerned with freedom offering both a discussion of feminism in its postmodern context and a critique of contemporary theory zerilli here

challenges feminists to move away from a theory based approach which focuses on securing or contesting women as an analytic category of feminism to one rooted in political action and judgment she revisits the democratic problem of exclusion from participation in common affairs and elaborates a freedom centered feminism as the political practice of beginning anew world building and judging in a series of case studies zerilli draws on the political thought of hannah arendt to articulate a nonsovereign conception of political freedom and to explore a variety of feminist understandings of freedom in the twentieth century including ones proposed by judith butler monique wittig and the milan women s bookstore collective in so doing zerilli hopes to retrieve what arendt called feminism s lost treasure the original and radical claim to political freedom

this work offers a new view of suffrage era feminism in australia located in rich cultural social and political context which also presents a new view of the decades around federation

with suffrage secured in 1920 feminists faced the challenge of how to keep their momentum going as the center of the movement shrank a small self appointed vanguard of modern women carried the cause forward in life and work feminism as life s work profiles four of these women the author inez haynes irwin the historian mary ritter beard the activist doris stevens and lorine pruette a psychologist their life stories told here in full for the first time embody the changes of the first four decades of the twentieth century and complicate what we know of the period through these women s intertwined stories mary trigg traces the changing nature of the women s movement across turbulent decades rent by world war revolution global depression and the rise of fascism criticizing the standard division of feminist activism as a series of historical waves trigg exposes how irwin beard stevens and pruette helped push the u s feminist movement to victory and continued to propel it forward from the 1920s to the 1960s decades not included in the wave model at a time widely viewed as the doldrums of feminism the women in this book were in fact taking the cause to new sites the national women s party sexuality and relations with men marriage and work and financial independence in their utopian efforts to reshape work sexual relations and marriage modern feminists ran headlong into the harsh realities of male power the sexual double standard the demands of motherhood and gendered social structures in feminism as life s work irwin beard stevens and pruette emerge as the heirs

of the suffrage movement guardians of a long feminist tradition and catalysts of the belief in equality and difference theirs is a story of courage application and perseverance a story that revisits the bleak and lonely years of the u s women s movement and emerges with a fresh perspective of the history of this pivotal era

elizabeth cady stanton 1815 1902 was not only one of the most important leaders of the 19th century women s rights movement but was also the movement s principal philosopher davis argues that stanton s work reflects the tapestry of american political culture in the second half of the 19th century

how the government enforced sex and gender conformity and relegated gays to second class citizenship the straight state is the most expansive study of the federal regulation of homosexuality yet written unearthing startling new evidence from the national archives margot canaday shows how the state systematically came to penalize homosexuality giving rise to a regime of second class citizenship that sexual minorities still live under today canaday looks at three key arenas of government control immigration the military and welfare and demonstrates how federal enforcement of sexual norms emerged with the rise of the modern bureaucratic state she begins at the turn of the twentieth century when the state first stumbled upon evidence of sex and gender nonconformity revealing how homosexuality was policed indirectly through the exclusion of sexually degenerate immigrants and other regulatory measures aimed at combating poverty violence and vice canaday argues that the state s gradual awareness of homosexuality intensified during the later new deal and through the postwar period as policies were enacted that explicitly used homosexuality to define who could enter the country serve in the military and collect state benefits midcentury repression was not a sudden response to newly visible gay subcultures canaday demonstrates but the culmination of a much longer and slower process of state building during which the state came to know and to care about homosexuality across many decades social political and legal history at their most compelling the straight state explores how regulation transformed the regulated in drawing boundaries around national citizenship the state helped to define the very meaning of homosexuality in america

this study seeks to fill a major gap in the fields of nineteenth century american and british studies by examining how nineteenth century intellectuals shaped and re shaped aesthetic

an essential examination of the woman suffrage movement in recent decades the woman suffrage movement has taken on new significance for women s history ellen carol dubois has been a central figure in spurring renewed interest in woman suffrage and in realigning the debates which surround it this volume gathers dubois most influential articles on woman suffrage and includes two new essays the collection traces the trajectory of the suffrage story against the backdrop of changing attitudes to politics citizenship and gender and the resultant tensions over such issues as slavery and abolitionism sexuality and religion and class and politics connecting the essays is dubois belief in the continuing importance of political and reform movements as an object of historical inquiry and a force in shaping gender the book which includes a highly original reconceptualization of women s rights from mary wollstonecraft to contemporary abortion and gay rights activists and a historiographical overview of suffrage scholarship provides an excellent overview of the movement including international as well as u s suffragism in the context of women s

this book focuses on the ways in which second wave feminism has been represented in american popular culture and on the effects that these representations have had on feminism as a political movement kim loudermilk provides close readings of four best selling novels and their film adaptations according to loudermilk each of these novels contains explicitly feminist characters and themes yet each presents a curiously

ambivalent picture of feminism these texts at once take feminism seriously and subtly undercut its most central tenets this book argues that these texts create a kind of fictional feminism that recuperates feminism's radical potential thereby lessening the threat it presents to the status quo

during the first half of the twentieth century out of wedlock pregnancy came to be seen as one of the most urgent and compelling problems of the day the effort to define its meaning fueled a struggle among three groups of women evangelical reformers who regarded unmarried mothers as fallen sisters to be saved a new generation of social workers who viewed them as problem girls to be treated and unmarried mothers themselves drawing on previously unexamined case records from maternity homes regina kunzel explores how women negotiated the crisis of single pregnancy and analyzes the different ways they understood and represented unmarried motherhood fallen women problem girls is a social and cultural history of out of wedlock pregnancy in the united states from 1890 to 1945 kunzel analyzes how evangelical women drew on a long tradition of female benevolence to create maternity homes that would redeem and reclaim unmarried mothers she shows how by the 1910s social workers struggling to achieve professional legitimacy tried to dissociate their own work from that earlier tradition replacing the reform rhetoric of sisterhood with the scientific language of professionalism by analyzing the important and unexplored transition from the conventions of nineteenth century reform to the professional imperatives of twentieth century social welfare kunzel offers a new interpretation of gender

and professionalization kunzel places shifting constructions of out of wedlock pregnancy within a broad history of gender sexuality class and race and argues that the contests among evangelical women social workers and unmarried mothers distilled larger generational and cross class conflicts among women in the first half of the twentieth century

in this beautifully illustrated and provocative study bridget elliott and jo ann wallace reappraise women s literary and artistic contribution to modernism through comparative case studies including natalie barney virginia woolf vanessa bell and gertrude stein the authors examine the ways in which women responded to modernism and created their artistic identity and how their work has been positioned in relation to that of men bringing together women s studies visual arts and literature women writers and artists makes an important contribution to 20th century cultural history it puts forward a powerful case against the academic division of cultural production into departments of art history and english studies which has served to marginalize the work of female modernists
