the legal pluriverse surrounding multinational military operations conceptualizes and examines the pluriverse the multiplicity of rules that apply to and regulate contemporary multinational missions and the array of actors involved these operations are further complicated by changes to the classification of the conflict and the asymmetry of obligations on participants structured into five parts this work seeks through the diversity of its authorship to set out the web of legal regimes

applicable to military operations including forces from more than one state it maps out the ways in which different regimes interact beginning with the laws of armed conflict and their relation to international humanitarian and human rights norms and extending through to areas like law of the sea and environmental law a variety of contributors systematically compile and take stock of the various legal regimes that make up the pluriverse assessing how these rules interact exposing norm conflicts areas of legal uncertainty or protective loopholes in this way they identify and evaluate approaches to better streamline the different applicable legal frameworks with a view to enhancing cooperation and thereby ensuring the long term success of multinational military operations

winner of the andrew f krepinevich writing award a 2022 choice reviews outstanding academic title selected for the irregular warfare initiative s inaugural reading list 2022 in today s complex international environment how do the united states china and russia manage the return of great power competition as well as the persistent threat of violent non state actors this book explores shaping the use of military power to construct a more favorable environment by influencing the characteristics of other militaries altering the relationships between them or managing the behavior of allies as opposed to traditional strategies of warfighting or coercion shaping relies less on threats demonstrations and uses of violence and more on attraction persuasion and legitimacy because shaping relies more on soft power than on hard power this approach contradicts the conventional wisdom of the purpose militaries serve kyle j wolfley explores the emergence of shaping in classical strategy and its increased frequency following the end of the cold war when threats and allies became more ambiguous he illustrates the four logics of shaping attraction socialization delegation and assurance through five case studies of recent major military exercise programs led by the united states china india the united kingdom and russia moreover the author reveals through sentiment analysis and statistics of over one thousand multinational exercises from 1980 to 2016 how major powers reacted to a complex international environment by expanding the number and scope of shaping

exercises illuminating an understudied but surprisingly common tool of military statecraft this book offers a fresh understanding of military power in today s competitive international system

nations have powerful reasons to get their military alliances right when security pacts go well they underpin regional and global order when they fail they spread wars across continents as states are dragged into conflict we would therefore expect states to carefully tailor their military partnerships to specific conditions this expectation raymond c kuo argues is wrong following the leader argues that most countries ignore their individual security interests in military pacts instead converging on a single dominant alliance strategy the book introduces a new social theory of strategic diffusion and emulation using case studies and advanced statistical analysis of alliances from 1815 to 2003 in the wake of each major war that shatters the international system a new hegemon creates a core military partnership to target its greatest enemy secondary and peripheral countries rush to emulate this alliance illustrating their credibility and prestige by mimicking the dominant form be it the nato model that seems so commonsense today or the realpolitik that reigned in europe of the late nineteenth century a lone alliance strategy has defined broad swaths of diplomatic history it is not states own security interests driving this phenomenon kuo shows but their jockeying for status in a world periodically remade by great powers

politics offers a comprehensive evaluation of the role of religion in international relations broadening the scope of investigation to such topics as the relationship between religion and cooperation religion and conflict and the relationship between religion and the quality of life religion is often manipulated by political elites to advance their principal goal of political survival zeev maoz and errol a henderson find that no specific religion is either consistently more bellicose or consistently more cooperative than other religions however religious similarity between states tends to reduce the propensity of conflict and increase the opportunity for security cooperation the authors find a significant relationship between secularism and human security

in his famous appeal against fascism german philosopher karl loewenstein warned that democracy may one day be destroyed from within to date the fear of this authoritarian virus has not subsided many worry that exposure to this virus may end in infection disease or possibly even the death of democracy they sound the alarm about the corrosion of democratic values the weakening of democratic institutions the rise of strongman politics and the resurgence of the far right in this dissertation i alleviate this pessimistic mood i argue that exposure also helps build immunity i test this claim by examining how citizens respond when they are exposed to a sample of the virus an image of what living under authoritarian rule would look like i use the term authoritarian framing effects to describe these

responses i develop empirical tests of authoritarian framing effects in 42 democracies the results shed new light on the nature and effects of the authoritarian virus some of my findings justify the pessimistic mood of earlier work exposure corrodes democratic values but only among some citizens in some countries and this is decreasingly so more importantly i find that the symptoms of immunity outweigh the symptoms of infection i show that exposure to the image of authoritarian rule reaffirms democratic values and strengthens support for strategies of democratic defense among a growing number of citizens these immune citizens constitute a valuable safeguard against future authoritarian revival

this title describes how civil war is defined and categorized and presents data and descriptions for nearly 300 civil wars waged from 1816 to the present analyzing trends over time and regions this work is the definitive source for understanding the phenomenon of civil war

the cold war security environment in order to meet these challenges this book updates conceptualizes applies and critically debates the concepts of unipolarity bipolarity multipolarity and non polarity in order to understand the current world order

is religion a factor in initiating interstate armed conflict and do different religions have different effects breaking new ground in political science this book explores these questions both qualitatively and quantitively concluding that the answer is yes previous studies have focused on conflict within states or interstate aggression with overtly religious motivations in contrast brown shows how religion affects states propensities to militarize even disputes that are not religious in nature different religions are shown to have different influences on those propensities and those influences are linked to the war ethics inculcated in those religions the book analyses and classifies war ethics contained in religious scripture and other religious classics teachings of religions contemporary epistemic communities and religions historical narratives using data from the new religious characteristics of states dataset project qualitative studies are combined with empirical measurements of governments institutional preferences and populations cultures this book will provide interesting insights to scholars and researchers in international security studies political science international law sociology and religious studies

a broad ranging study of the relationship between alliances and the conduct of grand strategy examined through historical case studies

when a repressive government violates the rights of its citizens the international community can respond by exerting moral pressure on that government from the outside shining the global spotlight condemning abuses and urging reform shaming is ubiquitous in world politics wielded by state and non state actors alike however recent events have sparked new interest in resistance and backlash to international human rights norms scholars now recognize the potential for shaming to backfire yet a robust theoretical account for such phenomena the dark side of human rights shaming remains lacking this book provides such an account investigating two closely related questions first why and how do states shame each other for human rights violations second when does shaming lead to an improvement in human rights conditions and when does it backfire terman argues that whether shaming works depends on the relationship between the country shaming and the country being shamed criticism exchanged between friends and allies is more effective she shows because it entails greater leverage and credibility shaming from rivals and adversaries in contrast is more likely to backfire terman provides evidence for her theory using cross national data original survey experiments and detailed case studies together her findings cast doubt on the power of international pressure to promote human rights while upending the received wisdom on the role of norms in world affairs by identifying the conditions under which shaming is effective the book offers practical guidance for

governments international organizations and civil society actors wanting to promote human rights abroad

when states die there are massive consequences for neighboring states and sometimes for the entire international system somalia s death in 1991 created a safe haven for criminal non state actors and has unsettled the horn of africa for decades when the iraqi state was dismantled in 2003 a similar set of consequences plagued the middle east and the international system more broadly in how states die douglas lemke provides a rigorous analysis of this phenomenon by reconceptualizing the definitions of the state and state death a state exists according to lemke whenever a set of state like political entities exercise control over a populated territory this includes both sovereign states and territorial contenders which lack formal diplomatic recognition conceiving statehood in this way vastly increases the population of states that have experienced state death which casts new light on the entire phenomenon this increased range not only expands the list of ways states can die it also provides insights into whether diplomatic recognition is associated with longer life and shows that state strength is not related to state death similarly in contrast to the conventional wisdom victories in conflict do not coincide with longer state survival state death is one of the central questions within international relations and lemke s reformulation of what a state is will transform our understanding of how and why these deaths happen

in piecing together the peaces alexander k antony and william r thompson provide a novel explanation for how peace took hold in the international system and why state behavior drastically changed according to the standard line of reasoning states need only democratize liberalize their trade modernize their economic culture or choose to forego territorial pursuits to reach peace with another state a bold challenge to the conventional wisdom that dominates interstate peace research antony and thompson make the case that industrialization provides the starting point from which we can begin to unpack the transformation in conflict propensities among certain states

the three main levels of analysis in international relations have been the systemic the national and the individual a fourth level that falls between the systemic and the national is the region it is woefully underdeveloped in comparison to the attention afforded the other three yet regions tend to be distinctive theaters for international politics otherwise we would not recognize that middle eastern interstate politics somehow does not resemble latin american interstate politics or interstate politics in southern africa although once the middle east and southern africa may have seemed more similar in their mutual fixation with opposition to domestic policies in israel and south africa respectively this book divided into three parts first makes a case for studying regional politics even though it must also

be appreciated that regional boundaries are also hazy and not always easy to pin down empirically the second part examines power distributions within regions as an important entry point to studying regional similarities and differences two emphases are stressed one is that regional power assessments need to be conditioned by controlling for weak states which are more common in some regions than they are in others the other emphasis is on regional power hierarchies some regions have strong regional hierarchies while others do not regions with strong hierarchies operate much differently from those without them in the sense that the former are more pacific than the latter the third part of the book focuses on regional differences in terms of conflict behavior order preferences rivalries and rivalry termination

this book offers new and cutting edge analyses of under explored subjects and issues in the realm of soft power it attempts to fill significant scholarly gaps in understanding the process by which soft power is created as well as gaps in demonstrating its impact soft power is one of the most influential ideas in the study of international politics over the past thirty years can nations attain their most vital foreign policy objectives in agreeable ways advocates of the concept of soft power have vociferously answered in the affirmative after many years of thinking in the field of international affairs that the only effective path to influence in international politics was military and economic power the idea of soft power offers new and exciting possibilities of gaining such influence through a more benign path one that elevates cooperation and esteem as preferred alternatives to violence threat and military capacity this book posits that the realization of the full potential of soft power as a foundation for international relations is a crucial goal for our present world one beset by war and planetary crises the book will be of special interest to researchers across political science international relations cultural studies and foreign policy it was originally published as a special issue of the journal of political power

china s mistreatment of its uyghur minority has drawn international condemnation and sanctions the repression gripping xinjiang is also hugely costly to china in renminbi personnel and stifled economic productivity despite this the chinese communist party persists in its policies why drawing on extensive original data potter and wang demonstrate insecurities about the stability of the regime and its claim to legitimacy motivate chinese policies these perceived threats to core interests drive the ferocity of the official response to uyghur nationalism the result is harsh repression sophisticated media control and selective international military cooperation china s growing economic and military power means that the country s policies in xinjiang and central asia have global implications zero tolerance sheds light on this problem informing policymakers scholars and students about an emerging global hotspot destined to play a central role in international politics in years to come

the varieties of democracy project v dem pioneered new ways to conceptualize and measure democracy producing a multidimensional and disaggregated data set

on democracy around the world that is now widely used by researchers activists and governments why democracies develop and decline draws on this data to present a comprehensive overview and rigorous empirical tests of the factors that contribute to democratization and democratic decline looking at economic social institutional geographic and international factors it is the most authoritative and encompassing empirical analysis of the causes of democratization and reversals the volume also proposes a comprehensive theoretical framework and presents an up to date description of global democratic developments from the french revolution to the present each chapter leverages the specialized expertise of its authors yet their sustained collaboration lends the book an unusually unified approach and a coherent theory and narrative
