a well established community of american scholars has long dominated the discipline of international relations recently however certain strands of continental theorizing are being introduced into the mainstream this is a critical examination of european approaches to international relations theory suggesting practical ways of challenging mainstream thought freidrichs presents a detailed sociological analysis of knowledge production in existing european ir communities namely france italy and scandinavia he also discusses a selection of european schools and approaches

whether inspired by the frankfurt school or antonio gramsci the impact of critical theory on the study of international relations has grown considerably since its advent in the early 1980s this book offers the first intellectual history of critical international theory richard devetak approaches this history by locating its emergence in the rising prestige of theory and the theoretical persona as theory's prestige rose in the discipline of international relations it opened the way for normative and metatheoretical reconsiderations of the discipline and the world the book traces the lines of intellectual inheritance through the frankfurt school to the enlightenment german idealism and historical materialism to reveal the construction of a particular kind of intellectual persona the critical international theorist who has mastered reflexive dialectical forms of social philosophy in addition to the extensive treatment of critical theory's reception and development in international relations the book recovers a rival form of theory that originates outside the usual inheritance of critical international theory in renaissance humanism and the civil enlightenment this historical mode of theorising was intended to combat metaphysical encroachments on politics and international relations and to prioritise the mundane demands of civil government over the self reflective demands of dialectical social philosophies by proposing contextualist intellectual history as a form of critical theory critical international theory defends a mode of historical critique that refuses the normative temptations to project present conceptions onto an alien past and to abstract from the offices of civil government

the global ir research programme promulgates a borderless ecology of cultures that has only an inside without an outside this borderless ecology of cultures reinvents the human condition including the condition of the international as perpetually interconnected at the level of consciousness while western centric ir theories depend on neo kantian philosophies to emphasize the time space bounded identities of human beings living in visibly divided phenomenal worlds the de kantian philosophies of the global ir research programme exemplified by the tianxia advaita and nishida kitaro s buddhism inspired theories recuperate the temporally spatially indivisible phenomenal noumenal flow of human life thereby facilitating back and forth movement between the westdominated one world and the non west embodied many worlds the central objective of the book is to demonstrate how this back and forth movement offers opportunities to conceive of and found a new world order that recognizes the temporally spatially indivisible human condition on earth the book delineates a set of guiding principles to promote an innovative practice of theory building and policy making that transcends the geo centric limitations of knowledge production and knowledge application thereby establishing the futuristic foundation of the global ir research programme

discusses the contribution of philosophers and thinkers whose ideas have recently begun to permeate international relations theory and seeks to integrate diverse ideas broadly concerned with the interpretive theory and methods of international relations

the central aim of this book is to foster connections between scholarly discussions of german foreign policy and broader theoretical debates in international relations and beyond while there has been a lively discussion about new german foreign policy this book argues that it has not engaged substantially with international and foreign policy theory especially with respect to its more recent developments reviewing the recent literature on german foreign policy this book posits that the most discussed works are still largely provided by the altmeister maull szabo bulmer and paterson who were already dominating the field a quarter of a century ago while there is a general decline in the academic study of german foreign policy the chapters in this edited volume show that a range of novel theoretically sophisticated but often disconnected scholarship has appeared on the margins this book contributes to this emerging work by providing conceptual interrogations which question the existing research and provide theoretically grounded alternatives initiating critical discussions and evaluations of the nature of germany s actorness and the environment in which it operates and proposing applications of less familiar perspectives on german foreign policy the chapters in this book were originally published as a special issue of german politics

this book examines the correspondence between international relations ir theories of structural realism and constructivism and paintings notably the artwork of mark rothko and jackson pollock in a game theory setting this interdisciplinary approach through the lens of game theory and semiotics permits different enriched interpretations of structural realism and constructivism these theories constitute an axis of debate between social and systemic approaches to international politics as well as an axis of differentiation between scientific realism and positivism as philosophies of science as such the interpretations explored in this book contribute to what we know about international relations how semiotics intersect with strategic uncertainty and explains these interactions in the proposed games model the book s use of game theory and semiotics generate visual semiotic games vsGs that shed light on the debate axes through strategic uncertainty interactions and players interactive belief systems vsGs
