inhaltsangabe einleitung spin offs und ähnliche umstrukturierungsformen haben seit den 80er jahren beständig an bedeutung gewonnen spin offs sind von großer relevanz für theorie und wirtschaftspraxis da sie die effizienz von unternehmungen erhöhen können ein möglicher grund hierfür ist die eliminierung der kosten von strategischem misfit und bürokratie in empirischen studien wurde bestätigt dass spin offs außerdem eine steigerung des shareholder value bewirken das kann daran liegen dass insbesondere unverbunden diversifizierte unternehmungen vor ihrer teilung durch den markt unterbewertet waren und diese unterbewertung nach der teilung korrigiert wurde bei einem spin off wird die unternehmung in zwei teile gespalten deren anteile unabhängig voneinander am markt gehandelt werden die eigentümer der ursprünglichen unternehmung bleiben die eigentümer der beiden getrennten unternehmungen indem die anteile des abgespaltenen unternehmungsteils verhältnismäßig an die altaktionäre verteilt werden die kontrolle über die unternehmungen wird durch den spin off geteilt so dass der abgespaltene unternehmungsteil über ein eigenes

entscheidungszenrum verfügt und strategien entwickelt die sich von denen der mutterunternehmung unterscheiden können es wird also eine unabhängige unternehmung gebildet und das vermögen der ursprünglichen unternehmung wird dementsprechend aufgeteilt ziel dieser arbeit ist es die hintergründe für die entscheidung und durchführung von spin offs herauszuarbeiten dabei finden die faktoren beachtung die desintegrationsprozesse im allgemeinen und spin offs im besonderen vorantreiben und somit die determinanten für die grenzen der unternehmung darstellen es soll veranschaulicht werden dass bei der durchführung von spin offs effizienzvorteile erzielt werden können die sowohl aus der perspektive der mutterunternehmung als auch des abzusplattenden unternehmungsteils für eine ausgliederung sprechen außerdem wird auf die mit spin offs verbundenen gewinne der anteilseigner eingegangen diese Überlegungen finden vor dem hintergrund verschiedener theoretischer ansätze statt die verknüpfung dieser forschungsansätze soll zu einer möglichst umfassenden begründung von spin offs beitragen die ausführungen der arbeit lassen sich in mehrere analysebereiche teilen der mit einer unternehmungsteilung verbundene Übergang von einer hierarchie zu mindestens zwei kleineren hierarchien verlangt die neugestaltung institutioneller

wenn sie geschehen ist niemand begeistert fehler sind nicht nur unbeliebt sondern haben oft unangenehme konsequenzen auch in der projektarbeit werden täglich fehler gemacht viele davon sind sogar im vorfeld bekannt und dennoch gibt es diese tückischen fallen des projektmanagements in die projektleiter und ihre mitarbeiter regelmäßig hineintappen diese ausgangslage hat das autorenteam des vorliegenden bandes fasziniert nach der maxime dass jeder fehler auch seine gute seite hat aus der sich etwas lernen lässt haben die autorinnen 17 fallbeispiele zusammengetragen die typische fehler in unterschiedlichen projektsituationen aufzeigen ihre methode ist dabei das story telling es werden geschichten erzählt die sich in der realen projektwelt genau so ereignet haben wobei die hier veröffentlichten fälle anonymisiert wurden die leser dürfen mitmachen an von den autorinnen festgelegten stellen können sie die entwicklung des projektes und das verhalten der protagonisten beurteilen und selbst lösungen entwickeln am ende jeder fallstudie finden sich dann die lösungsvorschläge des autorenteams sowie weitere nützliche hinweise zum einsatz praktischer methoden des projektmanagements das buch richtet sich sowohl an projektmanagement einsteiger mit wenig erfahrungen als auch an trainer personalentwickler und hochschuldozenten die nachwuchskräfte im projektmanagement ausbilden oder weiterentwickeln aber auch für den erfahrenen projektmanager sind die fallstudien lesenswert
