this systematic introduction to the concept of point of view in language explores the ways in which point of view intersects with and is shaped by ideology it specifically focuses on the way in which speakers and writers linguistically encode their beliefs interests and biases in a wide range of media the book draws on an extensive array of linguistic theories and frameworks and each chapter includes a self contained introduction to a particular topic in linguistics allowing easy reference the author uses examples from a variety of literary and non literary text types such as narrative fiction advertisements and newspaper reports

measured by its capacity to endure the prussian nobility was the most successful in the modern history of continental europe throughout the long vicissitudes of its history this class the junkers displayed a remarkable ability to adapt to new circumstances and maintain its own political power robert berdahl presents a comprehensive interpretation of the tenacity of the prussian nobles from the late eighteenth century until the revolution of 1848 at one level he provides a richly detailed economic social and political history the story of how the landowning nobility coped with changes in rural social relations after the emancipation of the serfs in 1807 and of how it survived the agrarian depression of the 1820s by the development of capitalist agriculture at another level he shows how the junkers developed an ideology of conservatism that justified their control of a society that was becoming increasingly bourgeois the domination of society by members of the nobility was traditionally supported by their experience in governing landed estates and particularly by the imagery of paternalism capitalist agriculture undermined the old landlord peasant relations but the nobility continued to exploit paternalistic images of domination originally published in 1988 the princeton legacy library uses the latest print on demand technology to again make available previously out of print books from the distinguished

this book based on new research sheds light on the history of the social democrat hinchakian party a major armenian revolutionary party that operated in the ottoman empire russia persia and throughout the global armenian diaspora divided into sections which cover the origins ideology and regional history of the sdhp the book situates the history of the hinchaks within debates around socialism populism and nationalism in the 19th and 20th centuries the sdhp was not only an armenian party but had a global marxist outlook and scholars in this volume bring to bear expertise in a wide range of histories and languages including russian turkish persian and latin american to trace the emergence and role this influential party played from their split with the armenian revolutionary federation and the events of the armenian genocide to the formation of the first armenian republic and then soviet armenia putting the hinchaks in context as one of many nationalist radical groups to emerge in eurasia in the late 19th century the book is an important contribution to armenian historiography as well as that of transnational revolutionary movements in general

paul de man s work is key to the american deconstruction movement and to the so called political turn in critical theory seventeen years after his death his works continue to arouse violent reactions among critics this book explains why de man is such an important voice detailing his critical position exploring his intellectual and historical contexts tracing the influence of his work and enabling readers to undertake independent study of his criticism

narratives are the concrete manifestation of an author s subjectivity they function as that person s voice and should be treated with the same respect that is granted to all voices in interpreting new testament narratives eric douglass develops this ethical perspective so that narratives are treated as communication and the author s voice is regarded as a valued perspective employing a cross disciplinary approach douglass shows how readers engage narratives as mental simulations creating a temporary possible world that readers enter and experience to recover communication readers locate the events of this world in the culture of the intended audience and translate this meaning into the modern reader s worldview using a staged reading design this initial reading is followed by readings of critique

according to the traditional view meaning presents itself under the form of some kind of identity to give the meaning of a sentence amounts to being capable of producing some substitute based on the identity of the terms of the sentence is then the meaning of a book or of any text the capacity of rewriting it instead of retaining a double standard theory of meaning one for sentences and another for texts that would allow for an ad hoc gap the author provides a unified conception called the question view of language he has developed known as problematology he pursues a systematic analysis of questioning in literature and shows how questioning makes the understanding process possible

the book provides a comprehensive and updated introduction to concept of territory in the study of democratic politics territory



plays a rather marginal role in the traditional conceptions of democracy that in many ways still prevail today democratic politics is often analysed from the point of view of its institutions citizens and voters while little is said about the territory through which it is expressed at most it provides a broader perimeter or context of political and institutional action the book offers instead an introductory theoretically oriented discussion of crucial issues such as the genesis of state nation the transformation of democratic citizenship the current borders policies the rising of territorial populism and the experience of 19 covid pandemic this is an open access book

networks to cause sufficient destruction or disruption to generate fear or to intimidate a society into an ideological goal but the cyber world is surely remote from what is recognized as terrorism the bloody attacks and ethnic conflicts or more precisely the politically motivated intention to cause death or serious bodily harm to civilians or non combatants with the purpose of intimidating a population or compelling a government un report freedom from fear 2005 it is hard to think of an instance when computer code has physically harmed anyone yet a number of contributors show that exactly such events potentially on a huge scale can be expected for example attacks on critical infrastructure in particular on scada supervisory control and data acquisition systems which control physical processes in places like chemical factories dams and power stations a part of the publication examines cyber terrorism in the proper sense of the term and how to respond in terms of technology awareness and legal political measures however there is also the related question of responding to the terrorist presence on the internet so called terrorist contents here the internet is not a weapon but an important tool for terrorists communications coordination training recruiting and information gathering on the targets of planned attacks

this book examines how critical approaches to security developed in europe can be used to investigate a chinese security issue the case of the falungong the past few decades have produced a rich field of theoretical approaches to security in europe in this book the security specific notions of securitization the politics of insecurity and emancipation are used as analytical approaches to investigate the anti falungong campaign in the people s republic of china this campaign launched in 1999 was the largest security related propaganda campaign since 1989 and was directed against a group of qigong practitioners who were presented as a grave threat to society the campaign had major impacts as new security legislation was established and human rights organizations reported severe mistreatment of practitioners this book approaches one empirical case with three approaches in order to transcend the tendency to pit one approach against another it shows how they highlight different aspects in investigation and how they can be combined to gain more comprehensive insights and thereby invigorate renewed debate in the field furthermore this is used as a vehicle to discuss more general philosophical issues of theory development and theory development and will assist students to comprehend the effects research framework selection has on a piece of research such discussions are necessary in order to apply the

frameworks in investigations that go beyond the socio political context they were originally developed in this book will be of interest to students of critical security studies chinese politics research methods and ir in general

this book presents a cutting edge analysis of the economic effects and challenges of russia s invasion of ukraine with a special focus on eu sanctions on russian energy and ukraine s political relationship with the european union in a global context welfens outlines key macroeconomic perspectives on the ongoing conflict between russia and ukraine highlighting in particular how sanctions posed by the international community will have a wider economic impact than what has so far been envisaged the book discusses the effects of russian gas supply boycotts against western countries as well as global effects of an eu energy import boycott on russia especially for china and the asian continent an innovative proposal to cut electricity prices is presented it also explores the challenges to relations between the eu china and russia caused by the invasion the effects of the unfolding refugee crisis within a post brexit eu military and humanitarian aid pledges to ukraine and the risks of reduced multilateralism within the world economy as a direct result of the war the book also analyses the risks and benefits of potential enlargement of the eu to integrate ukraine as a member state the topics covered by the book are all set within a long run view of diplomatic and economic relations between the west russia and ukraine the factors analysed here provide a new broader picture of the international effects of the conflict as well as its potential implications for policy design as we enter a new global order marked by the russo ukrainian war the book will be of interest to researchers and policy makers working in international economics new political economy european politics and integration and macroeconomics more broadly

cambridge florence and milan is presented and analyzed the papers collected in this volume propose several answers to the following question to what do we refer when we speak of central european philosophy interpretations of central european philosophy have developed in at least two broad directions an interpretation fashionable during the 1970s lumps specific philosophical achievements especially those of mach and wittgenstein characterized by research into and development of new languages of new philosophical scientific and artistic grammars in this situation literature was seen as the exploration of meanings moving towards frontiers in which reality and possibility science and metaphor meet and merge on the other hands the theme of a central european philosophy connected with but independent of literature has recently been given more thorough development the two outstanding figures to have emerged from this inquiry are those of bernard bolzano and franz brentano with reference to brentano in particular it is almost as if the collapse of the empire also erased awareness of the common origin of many diverse components of central european philosophical and scientific thought the polish logical school logical neopositivism phenomenology the prague school of linguistics analytic philosophy gestalt psychology the vienna economics school as well as a number of individual thinkers are all movements and groups connected in some manner with brentano s work and teaching although in some respects these are movements still at the centre of interest the overall effect the pattern of their common and unifying aspects have been neglected if they have not entirely disappeared it seems that the unity of this philosophical tradition was lost with the end of the geographical and political unity of the danubian empire and with the events that accompanied its downfall after 1918 the centres of that tradition vienna prague lvov graz belonged to different states and its rich network of exchanges contacts and relationships was dismantled forever however there still remained something of its philosophical style in each individual school traits which enable us to speak as the authors have done in this volume of central european philosophy

introduces key aspects of narrative interpretation to offer a richly rewarding approach to reading the bible

hamas is designated a terrorist organization by israel the eu the usa and the un it has made itself notorious for its violent radicalism and uncompromising rejection of the jewish state so after its victory in the 2006 elections the world was watching how would hamas govern could an islamist group without any experience of power and with an unwavering ideology manage to deal with day to day realities on the ground bjorn brenner investigates what happened after the elections and puts the spotlight on the people over whom hamas rules rather than on its ideas lodging with palestinian families and experiencing their daily encounters with hamas he offers an intimate perspective of the group as seen through local eyes the book is based on hard to secure interviews with a wide range of key political and security figures in the hamas administration as well as with military commanders and members of the feared qassam brigades brenner has also sought out those that hamas identifies as local trouble makers the extreme salafi jihadis and members of the now more quiescent mainstream fatah party led by mahmoud abbas the book provides a new interpretation of one of the most powerful forces in the israel palestine arena arguing that the gazan islamists carry a potential to be much more flexible and pragmatic than anticipated if they would think they stand to gain from it gaza under hamas investigates the key challenges to hamas s authority and reveals why and in what ways ideology comes second to power consolidation
