Discussions about abstraction are so important and so profound that this topic can hardly be neglected. It has inevitably cropped up again in various periods of philosophical enquiry despite these ancient roots, and after the great debate that characterised the empirical and rationalistic tradition, interest in the problem has unfortunately been absent in large measure from the mainstream of mathematical logic and analytic philosophy. It seems that there is a gap between the epistemological theorization in which it is difficult to find new insights on the problem of abstraction and the historical studies concerning the development of philosophical thought. Such studies, however, present a more fertile ground for such insights. Here the reader will find presented for the first time a collection of papers about the topic considered from an historical point of view, together with an awareness of the need for building a bridge between historical research and theoretical speculation. of the concept exploring what it means for a nation to protect human rights and what a citizen needs in order to pursue them he explains how free speech distinguishes human rights from other ideas about justice past and present

the induction of dōgen into the modern academic world or perhaps more accurately the academic world's first real engagement with dōgen came about 1924 when Watsuji Tetsurō (1889–1960) published a provocative essay entitled *Shaman Dōgen*. It was this essay that to many of Watsuji's contemporaries seemed to rescue dōgen from what they considered to be his entrapment for nearly seven centuries in the sectarian embrace of the Soto school. Watsuji insisted that dōgen no longer should be thought of as belonging exclusively to the monastic community, claiming instead that dōgen belongs to mankind. Watsuji with this declaration initiated the non-sectarian study of this thirteenth-century figure and in effect commenced what are called dōgen studies (*dōgen kenkyū*) in modern times as one way of exploring what it might possibly mean to say that dōgen belongs to mankind. The Kuroda Institute held a conference on dōgen at Tassajara Springs, California, from October 8 to 10, 1981. The essays of this volume are a part of its result.
