alan gewirth s reason and morality in which he set forth the principle of generic consistency is a major work of modern ethical theory that though much debated and highly respected has yet to gain full acceptance deryck beyleveld contends that this resistance stems from misunderstanding of the method and logical operations of gewirth s central argument in this book beyleveld seeks to remedy this deficiency his rigorous reconstruction of gewirth s argument gives its various parts their most compelling formulation and clarifies its essential logical structure beyleveld then classifies all the criticisms that gewirth s argument has received and measures them against his reconstruction of the argument the overall result is an immensely rich picture of the argument in which all of its complex issues and key moves are clearly displayed and its validity can finally be discerned the comprehensiveness of beyleveld s treatment provides ready access to the entire debate surrounding the foundational argument of reason and morality it will be required reading for all who are interested in gewirth s theory and deontological ethics and will be of central importance to moral and legal theorists

levinas s ethical metaphysics is essentially a meditation on what makes ethical agency possible that which enables us to act in the interest of another to put the well being of another before our own this line of questioning found its inception in and drew its inspiration from the mass atrocities that occurred during the second world war the holocaust like the cambodian genocide or those in rwanda and srebrenica exemplifies what have come to be known as the never again situations after these events we looked back each time with varying degrees of incomprehension horror anger and shame asking ourselves how we could possibly have let it all happen again and yet atrocity crimes are still rampant after rwanda 1994 and bosnia herzegovina 1992 1995 came kosovo 1999 and darfur 2003 in our present day world hate crimes motivated by racial sexual or other prejudice and mass hate such as genocide and terror are on the rise think for example of burma zimbabwe sri lanka and north korea a critical revaluation of the conditions of possibility of ethical agency is therefore more necessary than ever this volume is committed to the possibility of never again it is dedicated to all the victims living and dead of what levinas calls the sober cain like coldness at the root of all crime against humanity as much as every singular crime against another human being

this book investigates the way in which the actualistic ontology i.e the fact that god and human agents are beings in act in a covenant relationship that underlies the church dogmatics of karl barth affects his conception of ethical agency it analyses this effect along three paths of inquiry knowing what is right the noetic dimension doing what is right the ontic dimension and achieving what is right the telic dimension the first section of the book explores the discipline of theological ethics as barth construes it both in its theoretical status and in its actual practice in the second section the ontological import of ethical agency for barth is considered in relation to the divine action and the divine command the final section of the book examines the teleological purpose envisaged in this theological ethics in terms of participation witness and glorification at each stage of the book the strong interconnectedness of theological ethics and actualistic ontology in the church dogmatics is drawn out the resultant appreciation of the actualistic dimension which underlies the theological ethics of karl barth feeds into a fruitful engagement with a variety of critiques of barth's conception of ethical agency it is demonstrated that resources can be found within this actualistic ontology to answer some of the diverse criticisms and that attempts to revise barth's theological ethics at the margins would have catastrophic and irreversible consequences for his whole theological project

the first five editions of this well established book were written by colin turpin this new edition has been prepared jointly by colin turpin and adam tomkins this edition sees a major restructuring of the material as well as a complete updating new developments such as the constitutional reform act 2005 and recent case law concerning the sovereignty of parliament the human rights act counter terrorism and protests against the iraq war among other matters are extracted and analysed while it includes extensive material and commentary on contemporary constitutional reform turpin and tomkins is a book that covers the historical traditions and the continuity of the british constitution as well as the current tide of change all the chapters contain detailed suggestions for further reading designed principally for law students the book includes substantial extracts from parliamentary and other political sources as well as from legislation and case law as such it is essential reading also for politics and government students much of the material has been reworked and with its fresh design the book provides a detailed yet accessible account of the british constitution at a fascinating moment in its ongoing development

winner of the pulitzer prize in history an important deeply affecting and regrettably relevant new york times chronicle of a sinister idea of freedom white americans freedom to oppress others and their fight against the government that got in their way american freedom is typically associated with the fight of the oppressed for a better world but for centuries whenever the federal government intervened on behalf of nonwhite people many white americans fought back in the name of freedom their freedom to dominate others in freedom s dominion historian jefferson cowie traces this complex saga by focusing on a quintessentially american place barbour county alabama the ancestral home of political firebrand george wallace in a land shaped by settler colonialism and chattel slavery white people weaponized freedom to seize native lands champion secession overthrow reconstruction question the new deal and fight against the civil rights movement a riveting history of the long running clash between white people and federal authority this book radically shifts our understanding of what freedom means in america

this book is a study of modern politics from a socialist and left wing perspective as a collection of essays on political ideas it presents an analysis of the crisis of our times through examining the various crises and problems which define modern society it considers individual political aspects of the contemporary problems of capitalist politics ranging from economic crisis to social crisis from imperialism to the environmental crisis as such it serves to outline a solid argument for a better politics today the politics of socialism and democratic socialism

election atonement and the holy spirit is an examination of the doctrines of election and atonement in karl barth s church dogmatics taking up barth s own challenge to his reader to surpass his argument and offer a better typological interpretation of the cultic texts barth s radical re working of calvin s doctrine of election is one of the most important developments in twentieth century theology christ synthesizes for barth a particular dialectic the binary structure of god s yes of election and god s no of rejection the book s central question how can jesus simultaneously be both the elected and the rejected cd ii 2 acting as both the judge and the judged cd iv 1 is followed by an exploration of the roles of the holy spirit and human freedom in god s electing and saving action although commentators acknowledge barth s innovation in this area but also identify problems with his approach few have offered what david ford has called a correction from within barth using barth s own method using the concept of existenzstellvertretung this critique of barth s exegetical justification for the doctrines offers an alternative exegesis that not only provides this much needed correction but also immerses the reader in a fresh engagement with scripture itself

prophetically almost thirty years ago jean françois lyotard forecast the end of the modern research university based on enlightenment principles he envisaged the emergence of technical institutes in the service of the information rich global multinationals this book reflects on the post war western university and its discourses charting the crisis of the concept of the modern university first it examines the university within a global networked economy second it adopts poststructuralist perspectives in epistemology politics and ethics to appraise the role of the contemporary university third it introduces the notion of development in a critical fashion as a way of explaining its potentially new regional and international learning roles fourth it analyzes the rise of global science and the disciplines in the context of the global economy and finally it raises lyotard s logic of performativity and the assessment of research quality within a neoliberal economy linking it firmly to the question of freedom and the republic of science

katerina deligiorgi interprets kant s conception of enlightenment within the broader philosophical project of his critique of reason analyzing a broad range of kant s works including his critique of pure reason the critique of judgment his lectures on anthropology and logic as well as his shorter essays she identifies the theoretical and practical commitments that show the achievement of rational autonomy as an ongoing project for the realization of a culture of enlightenment deligiorgi also considers kant s ideas in relation to the work of diderot rousseau mendelssohn reinhold hamann schiller and herder the perspective opened by this historical dialogue challenges twentieth century revisionist interpretations of the enlightenment to show that the culture of enlightenment is not simply a fragment of our intellectual history but rather a live project

the charter of fundamental rights of the european union enshrines the key political social and economic rights of eu citizens and residents in eu law in its present form it was approved in 2000 by the european parliament the council of ministers and the european commission however its legal status remained uncertain until the entry into force of the treaty of lisbon in december 2009 the charter obliges the eu to act and legislate consistently with the charter and enables the eu s courts to strike down eu legislation which contravenes it the charter applies to eu member states when they are implementing eu law but does not extend the competences of the eu beyond the competences given to it in the treaties this commentary on the charter the first in english written by experts from several eu member states provides an authoritative but succinct statement of how the charter impacts upon eu domestic and international law following the conventional article by article approach each commentator offers an expert view of how each article is either already being interpreted in the courts or is likely to be interpreted each commentary is referenced to the case law and is augmented with extensive references to further reading six cross cutting introductory chapters explain the charter s institutional anchorage its relationship to the fundamental rights agency its interaction with other parts of international human rights law the enforcement mechanisms extraterritorial scope and the all important explanations

philosophy society and the cunning of history in eastern europe charts the intellectual landscape of twentieth century east central europe under the unifying theme of precariousness as a mode of historical existence caught between empires often marked by catastrophic historic events and grand political failures the countries of east central europe have for a long time developed a certain intellectual self representation a culture that not only helps them make some sense of such misfortunes but also protects them somehow from a collapse into nihilism an interdisciplinary study of this sophisticated culture of survival and endurance has been long overdue not only is it charming and worth studying in its own right but with the re integration of the new europe into the old one and the emergence on the western european intellectual scene of many authors from the east such a culture will also shape the european mind of the 21st century this volume decodes and explores this culture of precariousness from the complementary angles of philosophy political theory intellectual history and literary studies expert contributors look at a wide range of topics from philosophical martyrdom to collective suffering to geographical fatalism and explore the works of key authors in the field including cioran kołakowski kertész bauman and Žižek this book was originally published as a special issue of angelaki the journal of the theoretical

a welcome addition to palgrave s global media policy and business series internet governance and the global south documents the role of the global south in internet policymaking and challenges the globalization theories that declared the death of the state in global decision making abu bhuiyan argues that the global internet politics is primarily a conflict between the states the united states of america and the states of the global south because the former controls internet policymaking the states of the global south have been both oppositional and acquiescing to the sponsored policies of the united states on internet issues such as digital divide multilingualism intellectual property rights and cyber security they do not oppose the neoliberal underpinnings of the policies promoted by the united states but ask for an international framework to govern the internet so that they can work as equal partners in setting norms for the global internet

christians of all theological and political backgrounds ought to be ardent advocates of advancing not curbing freedom of speech within their own ranks and in the increasingly secular societies in which they live christians free expression and the common good presents the concept of free expression and its opposite of censorship as a tool for the western church and the u s church in particular to respond more wisely and effectively to controversy in their most severe form these controversies lead to both formal and informal limitations on free expression as christians seek to silence those with whom they most stridently disagree this study is timely given the western church s current state of flux as it tries to determine its identity and mission in a post christian setting christians free expression and the common good will appeal to a wide range of thoughtful religious scholars and others who would welcome ideas on how the church should refine and live out its mission in the early twenty first century

anthems are symbolic means through which nations present themselves to the world accordingly creating seven new nation states out of the bones of yugoslavia required new anthems why did these new states opt for century old national songs or failing this for the anthems without words what are the images and symbols that each of these states chose as their national signatures and how were these chosen this book explores a variety of images of nationhood or the absence of them in the lyrics of the official anthems and of competing national songs and traces their historical trajectory from the time of their conception to their legal entrenchment this is the first full length study into the symbolic representations of nationhood in the recently created nation states of the balkans

from the late 1970s to the late 1980s rock music in yugoslavia had an important social and political purpose of providing a popular cultural outlet for the unique forms of socio cultural critique that engaged with the realities and problems of life in yugoslav society the three music movements that emerged in this period new wave new primitives and new partisans employed the understanding of rock music as the music of commitment i e as socio cultural praxis premised on committed social engagement to articulate the critiques of
