this interdisciplinary research agenda contains state of the art surveys of the field of corruption and points towards an agenda for future research this comprehensive work covers the main approaches to diagnosing analysing and measuring corruption as well as the ways to tackle it chapters explore top political and grassroots corruption buying and stealing votes corruption in relation to gender and the media digital anti corruption and an examination of whistleblowing and market based tools

this book argues that the mainstream definitions of corruption and the key expectations they embed concerning the relationship between corruption democracy and the process of democratization require reexamination even critics who did not consider stable institutions and legal clarity of veteran democracies as a cure all assumed that the process of widening the influence on government decision making and implementation allows non elites to defend their interests define the acceptable sources and uses of wealth and demand government accountability this had proved correct especially insofar as petty corruption is involved but the assumption that corruption necessarily involves the evasion of democratic principles and a market approach in which the corrupt seek to maximize profit does not exhaust the possible incentives for corruption the types of behaviors involved for obvious reasons the tendency in the literature is to focus on bribery or the range of situations that permit corruption in democracies in the effort to identify some of the problems that require recognition and to offer a more exhaustive alternative the chapters in this book focus on corruption in democratic settings including ngos and the united nations which were largely so far ignored while focusing mainly on behaviors other than bribery

this book seeks to enrich and in some cases reverse current ideas on corruption and its prevention it is a long held belief that sanctions are the best guard against corrupt practice this innovative work argues that in some cases sanctions paradoxically increase corruption and that controls provide opportunities for corrupt transactions instead it suggests that better regulation and responsive enforcement not sanctions offer the most effective response to corruption taking

both a theoretical and applied approach it examines the question from a global perspective drawing on in particular a regulatory perspective to provide a model for tackling corrupt practices

public private partnerships ppp or 3ps allow the public sector to seek alternative funding and expertise from the private sector during procurement processes such partnerships if executed with due diligence often benefit the public immensely unfortunately public private partnerships can be vulnerable to corruption this book looks at what measures we can put in place to check corruption during procurement and what good governance strategies the public sector can adopt to improve the performance of 3ps the book applies mathematical models to analyze 3ps it uses game theory to study the interaction and dynamics between the stakeholders and suggests strategies to reduce corruption risks in various 3ps stages the authors explain through game theory based simulation how governments can adopt a evaluating process at the start of each procurement to weed out undesirable private partners and why the government should take a more proactive approach using a methodological framework rooted in mathematical models to illustrate how we can combat institutional corruption this book is a helpful reference for anyone interested in public policymaking and public infrastructure management

this book examines corruption as a collective behavior problem for entrepreneurs in particular it considers azjen s theory of planned behavior tpb to explain perceived corruption and its effects on entrepreneurship heydari argues that behavioral intentions are shaped by variables such as attitude subjective norms and perceived behavioral control he proposes the novel heydari behavioral synthesis theory hbst model and applies it to two case studies to highlight the institutional individual and societal factors that may inhibit entrepreneurial behavior he concludes that corruption may persist not just because of difficulties in monitoring and prosecuting but because it is systemically pervasive and discourages individual countermeasures he closes by looking at anti corruption policies and outlining future research directions arguing that widespread corruption may be theoretically mischaracterized in the literature this book is of interest to policy makers researchers and postgraduate students in the fields of management science industrial and organizational psychology entrepreneurship and corruption studies

the volume demonstrates the suitability of the theory of social constructivism in portraying and analyzing the diversity of the phenomenon of corruption the approach of social constructivism taken in this volume is able to reconstruct the construction of corruption both from a societal perspective by assessing it as generally accepted or tolerated behaviour in more or less standardized rule governed social situations and from the perspective of actors who perceive corrupt behaviour as problem solving in everyday life the volume proves the usefulness of a social construction perspective for empirical research it contains case studies of social definitions of

corruption in eleven european countries that contribute in different ways to establishing a grounded theory of the phenomenon of corruption

corruption is increasingly placed on top of the agenda of national governments and supra national institutions such as the oecd un or the world bank a necessary condition for promoting sustainable economic growth is the pre existence of a stable political system which is able to control corruption corruption however is a very complex issue associated with institutional and cultural specificities personality traits related to individualistic values and criminal personalities in this book the social political and economic realities that prevail in particular settings are viewed from an interdisciplinary multidimensional and a multi country perspective this book is divided into three parts the first part presents a comprehensive theoretical and empirical framework of corruption with an overview of literature on economic growth and corruption part two encompasses the in depth analysis of several countries ranging from middle corrupted contexts like portugal to highly corrupted countries including serbia russia thailand and china the latter viewed from the perspective of firms from a very low corruption country such as finland the final part explores the prevention and control of corruption looking at the public sector in thailand and fighting corruption with different strategies this volume is of the interest of those who study international economics development economics or organised crime

corruption is usually understood as hampering political development economic growth and democratic participation of citizens but comparing the effects of corruption for different political regimes presents astonishingly complex findings the ongoing persistence of corruption underlines that it is not only dysfunctional but can be highly functional as well this special issue brings together contributions from comparative politics political science and economics which precisely focus on these dys functionalities of corruption in political regimes across various world regions the question of methodological pluralism is especially important for studying corruption comparatively while on an international level a trend towards an increased use of quantitative methods in political science as well as in economics can be observed the special issue underlines the importance of having a pluralistic approach for grasping the complex and multi layered effects of the phenomenon of similar importance is the adoption of a comparative perspective that includes

the problem of corruption however described dates back thousands of years professionals working in areas such as development studies economics and political studies were the first to most actively analyse and publish on the topic of corruption and its negative impacts on economies societies and politics there was at that time minimal literature available on corruption and the law the literature and discussion on bribery and corruption as well as on the negative impact of each and what is required to address them particularly in the legal context are now considerable corruption and anti corruption are multifaceted and multi disciplinary the focus now on the law and compliance and perhaps commercial incentives is relatively easy however corruption anti corruption and the motivations for them are complex if we continue to discuss debate engage address corruption and anti corruption in our own disciplinary silos we are unlikely to significantly progress the fight against corruption what do terms such as culture of integrity demand accountability transparency and accountability and ethical corporate culture dominating the anti corruption discourse mean if anything in other disciplines if they are meaningless what approach would practitioners in those other disciplines suggest be adopted to address corruption what has their experience been in the field how can the work of each discipline contribute to the work of whole and as such improve our work in and understanding of anti corruption this book seeks to answer these questions and to understand the phenomenon more comprehensively it will be of value to researchers academics lawyers legislators and students in the fields of law anthropology sociology international affairs and business

this book aims to gather the insight of leading experts on corruption and anti corruption studies working at the scientific frontier of this phenomenon using the multidisciplinary tools of data and network science in order to present current theoretical empirical and operational efforts being performed in order to curb this problem the research results strengthen the importance of evidence based approaches in the fight against corruption in all its forms and foster the discussion about the best ways to convert the obtained knowledge into public policy the contributed chapters provide comprehensive and multidisciplinary approaches to handle the non trivial structural and dynamical aspects that characterize the modern social economic political and technological systems where corruption takes place this book will serve a broad multi disciplinary audience from natural to social scientists applied mathematicians including law and
