from de gaulle onwards france s strategic independence has been predicated on self sufficiency in modern weapons to achieve and maintain the requisite defence industrial base in the context of limited domestic orders paris sought to promote the export of its arms during the cold war this underpinned but was also an expression of france s determination to resist bipolar domination france offered customers around the world an alternative to reliance on one superpower or the other and in doing so it generated the revenue to support an extensive domestic arms industry the end of the cold war ushered in fundamental changes however western defence spending shrank and the global market was turned upside down while france s arms export policy was

less affected by human rights concerns than other democracies it was not immune to pressures stemming from the consolidation of europe s defence industrial base and the increased interest of the eu in regulating the arms trade this adelphi book considers how france has responded to changing political and market circumstances in the way that it promotes and controls the export of weapons it examines the rationale for considering a liberal arms export policy as essential to french independence and the institutional arrangements that underpinned this it tracks the dramatic changes in the global arms market since 1990 in terms of demand and market competition and charts the response of the french government to these changes the book underlines how the french machinery of government as a directing force behind the defence industry has been resistant to the notion of export restraint even in the case of sales to authoritarian regimes however it argues that france now faces a dilemma over whether to continue with a long successful course or to moderate its independence through greater collaboration to bolster european integration and better compete globally

georgia is recovering from an adverse external shock a decline in trading partners growth since late 2014 although at a slower pace than previously envisaged the economy has shown resilience to the external shock with real gdp growth averaging 2 8 percent in 2015 16 the highest among its main trading partners except for china and turkey the exchange rate was allowed to adjust and the dollarized banking sector has weathered the significant depreciation vis à vis the dollar with depreciation of major trading partner currencies external competitiveness has not improved however hence external imbalances remain elevated and reserves below adequate levels following the october 2016 parliamentary elections that gave the ruling party a constitutional majority the new government has united around a policy agenda centered on bolstering growth

seventy percent of our planet is covered by water and even in today s world of instant communication the global community is still heavily reliant on sea based transport the maritime domain has always been one of nato s key strengths but concerns about maritime security have taken on renewed importance in recent years and nato has been forced to re examine some of its fundamental assumptions about the post cold war security environment this book shares some of the research debates and findings from a nato advanced research workshop arw building trust to enhance maritime security held in geneva switzerland in november 2014 the chapters in the book deal extensively with lessons learned by nato from a wide range of policies operations and situations this maritime experience has been amassed from the atlantic and mediterranean to the baltic and the black sea and even into the indian ocean as well as from the four decades spent defending nato allies on the high seas during the cold war the single most profound lesson learned over the years has concerned the importance of efficient coordination structures and mechanisms have been created not least in recent counter piracy operations which enable a vast array of actors to work together in an efficient way and which could prove invaluable in future efforts to counter terrorism and aggression worldwide the safety of the maritime domain is essential to the freedom and security of all nations and this book will be of interest to all those whose work involves maintaining that freedom and security

this book is the first to provide comprehensive and comparative analyses to conceptualise the interaction between hegemonic structures and those actors resisting them using the iranian nuclear case as an illustration it analyses the foreign policies of china russia and turkey towards the iranian nuclear programme and thereby answers the question to what extent these policies are indicative of a security culture that resists hegemony based on 70 elite interviews with experts and decision makers closely involved with the iranian nuclear file it analyses resistance to hegemony across its ideational material and institutional framework conditions

this book provides a critical understanding of the challenges that exist in protecting the local and global environment through compliance efforts using existing environmental regulations the best compliance measures with the most useful regulations from over 50 countries are surveyed and are combined with science based quantitative analysis of geology hydrogeology and the chemistry of contaminants from anthropogenic sources the results are presented as a model that establishes a means by which protection of the environment can be greatly improved this is accomplished through a deeper understanding of our natural world and how anthropogenic activities and their management affect our planet features the first book that examines the successes of environmental regulation worldwide and highlights the areas that need improvement presents a tested and verified scientific model for enhanced environmental protection with scalability from local parcels to global levels describes and integrates the importance of understanding the geologic and hydrogeologic environment of urban and developed areas explains the importance of understanding the different types of pollution and their behavior in the

the rohingya of myanmar are one of the world's most persecuted minority populations without citizenship after the latest exodus from myanmar in 2017 there are now more than half a million rohingya in bangladesh living in camps often in conditions of abject poverty malnutrition and without proper access to shelter or work permits some of them are now compelled to take to the seas in perilous journeys to the southeast asian countries in search of a better life they are now asked to go back to myanmar but without any promise of citizenship or an end to discrimination this book looks at the rohingya in the south asian region primarily india and bangladesh it explores the broader picture of the historical and political dimensions of the rohingya crisis and examines subjects of statelessness human rights and humanitarian protection of these victims of forced migration further it chronicles the actual process of emergence of a stateless community the transformation of a national group into a stateless existence without basic rights
