the relationship between science law and justice has become a pressing issue with us supreme court decisions beginning with *Daubert v Merrell Dow Pharmaceutical* how courts review scientific testimony and its foundation before trial can substantially affect the possibility of justice for persons wrongfully injured by exposure to toxic substances if courts do not review scientific testimony they will deny one of the parties the possibility of justice even if courts review evidence well the fact and perception of greater judicial scrutiny increases litigation costs and attorney screening of clients mistaken review of scientific evidence can decrease citizen access to the law increase unfortunate incentives for firms not to test their products lower deterrence for wrongful conduct and harmful products and decrease the possibility of justice for citizens injured by toxic substances this book introduces these issues reveals the relationships that pose problems and shows how justice can be denied

this book is designed to introduce law students legal actors and human rights activists particularly participants in human rights dialogues with china to the process and reality of a newly confident china s participation in the international human rights system albeit with inherent challenges from an international and comparative perspective one of the key findings of the author s research is that progress towards human rights depends more on judges than on legislators chinese legislators have enacted a series of reforms in order to better protect human rights unfortunately these reforms have not led to greater adherence to china s international human rights

obligations in practice the reforms failed because they have generally been misunderstood by chinese judges who often have a limited understanding of international human rights norms specifically this book will examine how judicial misunderstandings have blocked reforms in one specific area the use of severe punishments based on international human rights theory and case studies and data analyses this examination has several purposes the first is to suggest that china ratify the iccpr as the next step for its substantive progress in human rights and as a good preparation for its re applying to be a member of the un human right council in the future the second is to explain how judges could be better educated in international human rights norms so as to greatly reduce the use of severe punishments and better comply with china s human rights obligations the third is to demonstrate how the international community could better engage with china in a manner that is more conducive to human rights improvements the author s ultimate goal is to enhance dialogue on human rights in china between judges and the chinese government between chinese judges and their foreign counterparts and between china s government and the international community another significant aim of this book is to clarify the controversial question of what obligations china should undertake before its ratification of the iccpr and to re examine trends in its developing human rights policy after standing down from the council in late 2012 the tortuous progress of china s criminal law and criminal justice reforms has confirmed that chinese judges need further instruction on how to apply severe punishments in a manner consistent with international standards judges should be encouraged to exercise more discretion when sentencing so that penalties reflect the intent of relevant domestic laws as well as the international human rights standards enumerated in the iccpr in order to better educate and train judges this book contains introductory chapters that examine the severe punishments currently available to chinese judges from an international human rights perspective to illustrate how chinese justice currently falls short of international norms this paper also examines several cases that are considered to be indicative of china s progress towards greater respect for human rights and the rule of law these cases demonstrate that china still has a long way to go to achieve its goals at least before abolishing the death penalty forced labor and torture

ago to hugo von munsterberg's on the witness stand published in 1908 these early roots can mislead the casual observer about the history of psychology and law vigorous and sustained research in the field is a recent phenomenon it is only 15 years since the first review of psychology and law appeared in the annual review of psychology tapp 1976 the following year saw the first issue of law and human behavior the official publication of the american psychology law society and now the journal of the american psychological association's division of psychology and law few psychology departments offered even a single course in psychology and law before 1973 while by 1982 14 of psychology graduate programs had at least one course and a number had begun to offer forensic minors and or joint j d ph d programs freeman roesch see chapter 28 yet this short period of less than 20 years has seen a dramatic level of activity its strengths and weaknesses excitements and disappointments are all captured in the collection of chapters published in this first handbook of psychology and law in describing what we have learned about psychology and law the works included here also reveal the questions we have yet to answer and thus offer a blueprint for activities in the next 20 years

conditions that differ from the norms of rationality typically applied to conclusions of reasoning the resulting abstract framework reveals deep structural similarities among such varied intellectual pursuits as determining the significance of a historical artefact deciding on a person s guilt in court deliberating about a philosophical problem or searching for a mathematical proof it can help us make progress on difficult philosophical questions such as how we should respond to misleading higher order evidence how we should formally model logical learning and how confident we can rationally be in our own philosophical positions in this book julia staffel makes a novel contribution to the study of reasoning and rationality most of the theorizing in these areas either studies the nature of simple inferences or the conditions under which we can reach justified conclusions unfinished business examines how we should theorize about the attitudes we have towards possible answers to a question of interest while our reasoning is ongoing it focuses on complex reasoning processes that don t necessarily progress towards an answer in a linear way based on both philosophical arguments and empirical research staffel argues that there is a previously unrecognized attitude type transitional attitudes that play a key role in carrying out complex deliberations
