race relations in britain since 1945 provides a critical overview of the origins development and present state of race relations in britain highly contentious the field of race relations is closely related to a number of issues which are regarded to be at the very heart of contemporary british life professor goulbourne draws on a variety of historical sociological anthropological and political analyses to construct and advance a convincing and persuasive argument about differential incorporation into british society or inequality based on colour in the imperial and colonial era as well as the contemporary period

this is the second edition of the textbook on race and ethnic relations which has been adopted by academic and vocational courses and which is designed to be a straightforward introduction to this field of study it retains all the original features but reflects on events over the years since its original publication incorporating accounts of developments in the uk and usa suggestions for further readings are revised in the light of the latest research

an authoritative and cutting edge collection of theoretically grounded and empirically informed essays exploring the contemporary terrain of race and racism

imperialism race and resistance marks an important new development in the study of british and imperial interwar history focusing on britain west africa and south africa imperialism race and resistance charts the growth of anti colonial resistance and opposition to racism in the prelude to the post colonial era the complex nature of imperial power in explored as well as its impact on the lives and struggles of black men and women in africa and the african diaspora barbara bush argues that tensions between white dreams of power and black dreams of freedom were seminal in transofrming britain s

relationship with africa in an era bounded by global war and shaped by ideological conflict

tracing developments in the sociology of race relations from the 1920s to the 1960s mckee maintains that sociologists assumed the united states would move unimpeded toward modernization and assimilation aided by industrialization and urbanization the fatal flaw in their perspective was the notion that blacks were culturally inferior backward and pre modern a people who had lost their own culture and couldn't grasp that of their new society designed to detail a failure the author says is widely acknowledged but little examined this book will be of interest to both specialists and general readers masterful mckee transports the reader back to the intellectual world in which the early sociologists worked and does not simply treat them as evil racists his approach is informed by the sociology of knowledge lewis m killian author of the impossible revolution phase 2 black power and the american dream

in a post 9 11 sea of social and political discord one state stands apart as an increasingly powerful anti islamic social movement rises in the west canada alone remains a viable multicultural state employing survey and statistical data as well as a series of interviews conducted with religious leaders and policy officials protecting multiculturalism explores public safety and security concerns while pointing out the successes pitfalls and sometimes countervailing effects of government measures on muslims in canada engaging with debates surrounding the cultural accommodation of diverse communities john mccoy focuses on two inter related themes at the heart of the crisis of multiculturalism social integration and national security even in canada mccoy argues muslims can face acute xenophobia and racism problematic national security practices inimical politicians and other troubling warning signs yet despite these challenges these diverse communities continue to display remarkable resilience an open minded and substantive reflection on the day to day realities for muslim communities protecting multiculturalism seeks a way forward for the canadian multicultural experiment a future that is marked by dignity and diversity in an increasingly fraught era

changes to assess the impact of the lawrence inquiry and the macpherson report and to trace the growing emphasis on policing as an antiracist activity proactively confronting racism in both crime and non crime situations whilst this change has not been wholly or consistently applied it does represent an important change in the discourse that surrounds police relations with the public since it changes the traditional role of the police as neutral arbiters of the law this book shows why race has become the most significant issue facing the british police and argues that the police response to race has led to a consideration of fundamental issues about the relation of the police to society as a whole and not just minority groups who might be most directly affected

is a racial structure still firmly in place in the united states white supremacy and racism answers that question with an unequivocal yes describing a contemporary system that operates in a covert subtle institutional and superficially nonracial fash on assessing the major perspectives that social analysts have relied on to explain race and racial relations bonilla silva labels the post civil rights ideology as color blind racism a system of social arrangements that maintain white privilege at all levels his analysis of racial politics in the united states makes a compelling argument for a new civil rights movement rooted in the race class needs of minority masses multiracial in character and focused on attaining substantive rather than formal equality

this book develops the concept of racialisation it argues that a full understanding of racialized discourse must pay attention to both the particular local circumstances in which they appear and well established themes which have unfolded over time an important aspect of the study is the examination of other discourses with which racialized ideas have co joined reflecting the way in which notions of race are socially constructed the final part of the thesis returns to debates of the 1980 s and argues that the racialisation of unrest in that decade was closely intertwined with conservative perspectives which sought to deny socio economic causes in favour of explanations based upon the supposed cultural or personal proclivities of those involved

in this dramatic history of race relations during the vietnam war james e westheider illustrates how american soldiers in vietnam grappled with many of the same racial conflicts that were roiling their homeland thousands of miles away over seven years in the making fighting on two fronts draws on interviews with dozens of vietnam veterans black and white and official pentagon documents to paint the first complete picture of the african american experience in vietnam
