this collection of essays and interviews provides a frank look at the nature and purposes of prisons in the united states from the perspective of the prisoners written by native american african american latino asian and european american prisoners the book examines captivity and democracy the racial other gender and violence and the stigma of a suspect humanity contributors include those incarcerated for social and political acts such as conscientious objection antiwar activism black liberation and gang activities among those interviewed are philip berrigan marilyn buck angela y davis george jackson and laura whitehorn

most accounts date the birth of american abolitionism to 1831 when william lloyd garrison began publishing his radical antislavery newspaper the liberator in fact however the abolition movement had been born with the american republic in the decades following the revolution abolitionists worked steadily to eliminate slavery and racial injustice and their tactics and strategies constantly evolved tracing the development of the abolitionist movement from the 1770s to the 1830s richard newman focuses particularly on its transformation from a conservative lobbying effort into a fiery grassroots reform cause what began in late eighteenth century pennsylvania as an elite movement espousing gradual legal reform began to change in the 1820s as black activists female reformers and nonelite whites pushed their way into the antislavery movement located primarily in massachusetts these new reformers demanded immediate emancipation and they revolutionized abolitionist strategies and tactics lecturing extensively publishing gripping accounts of life in bondage and organizing on a grassroots level their attitudes and actions made the abolition movement the radical cause we view it as today

have tried to reform the police from community policing initiatives to increasing diversity none of it has stopped the police from killing about three people a day millions of people continue to protest police violence because these solutions do not match the problem the police cannot be reformed in becoming abolitionists purnell draws from her experiences as a lawyer writer and organizer initially skeptical about police abolition she saw too much sexual violence and buried too many friends to consider getting rid of police in her hometown of st louis let alone the nation but the police were a placebo calling them felt like something and something feels like everything when the other option seems like nothing purnell details how multi racial social movements rooted in rebellion risk taking and revolutionary love pushed her and a generation of activists toward abolition the book travels across geography and time and offers lessons that activists have learned from ferguson to south africa from reconstruction to contemporary protests against police shootings here purnell argues that police can not be reformed and invites readers to envision new systems that work to address the root causes of violence becoming abolitionists shows that abolition is not solely about getting rid of police but a commitment to create and support different answers to the problem of harm in society and most excitingly an opportunity to reduce and eliminate harm in the first place

providing a unique critical perspective to debates on slavery this book brings the literature on transatlantic slavery into dialogue with research on informal sector labour child labour migration debt prisoners and sex work in the contemporary world in order to challenge popular and policy discourse on modern slavery

when slavery was a routine part of life in america s south a secret network of activists and escape routes enabled slaves to make their way to freedom in what is now canada the underground railroad has become part of folklore but one part of the story is only now coming to light in new york a city whose banks business and politics were deeply enmeshed in the slave economy three men played a remarkable part at huge personal risk in gateway to freedom pulitzer prize winning historian eric foner tells the story of sydney howard gay an abolitionist newspaper editor louis napoleon furniture polisher and charles b ray a black minister between 1830 and 1860 with the secret help of black dockworkers the network led by these three men helped no fewer than 3 000 fugitives to liberty the previously unexamined records compiled by gay offer a portrait of fugitive slaves who passed through new york city where they originated how they escaped who helped them in both north and south and how they were forwarded to freedom in canada

why have so many radical thinkers advocated for the abolition of prisons and punishment and why have their ideas been so difficult to popularize or garner the political will for change this book outlines several different approaches to penal abolitionism and showcases their calls for the ending of legal coercion domination and repression this exciting and innovative edited collection shows how abolitionist ideas have continued topicality and relevance in the present day and how they can collectively help with devising new ways of thinking about social problems as well as suggesting alternatives to existing penal policies practices and institutions

despite growing popular and policy interest in new slavery with contemporary abolitionists calling for action to free an estimated 40 million modern slaves interdisciplinary and theoretical dialogue has been largely missing from scholarship on modern slavery this edited volume will provide a space to reinvigorate the theory and practice of representing slavery and related systems of domination in particular our understandings of the binary between slavery and freedom in different historical and political contexts the book takes a critical approach interrogating the concept of modern slavery by exploring where it has come from and its potential for obscuring and foreclosing new understandings including contributions from philosophers political theorists sociologists anthropologists and english literature scholars it adds to the emerging critique of the concept of modern slavery through its focus on the connections between the past of atlantic world slavery the present of contemporary groups whose freedoms are heavily restricted prisoners child labourers in the global south migrant domestic workers and migrant wives and the futures envisaged by activists struggling against different elements of the systems of domination that atlantic world slavery relied upon and spawned revisiting slavery antislavery will be of indispensable value to scholars students policy makers and activists in the fields of human rights modern history international politics social policy sociology and global inequality

the essays in this book stemming from a national conference of the same name focus on the single subject required of nearly all college students composition despite its pervasiveness and its significance composition has an unstable status within the curriculum writing programs and writing faculty are besieged by academic political and financial concerns that have not been well understood or addressed at many institutions composition functions paradoxically as both the gateway to academic success and as the gatekeeper reducing access to academic work and opportunity for those with limited facility in english although writing programs are expected to provide services that range from instruction in correct grammar to assisting or resisting political correctness expanding programs and shrinking faculty get caught in the crossfire the bottom line becomes the firing line as forces outside the classroom determine funding and seek to define what composition should do in search of that definition the contributors ask and answer a series of specific and salient questions what implications intellectual political and institutional will forces outside the classroom have on the quality and delivery of composition in the twenty first century how will faculty and administrators identify and address these issues what policies and practices ought we propose for the century to come this book features sixteen position papers by distinguished scholars and researchers in composition and rhetoric most of the papers are followed by invited responses by other notable compositionists in all twenty five contributors approach composition from a wide variety of contemporary perspectives rhetorical historical social cultural political intellectual economic structural administrative and developmental they propose solutions applicable to pedagogy research graduate training of composition teachers academic administration and public and social policy in a very real sense then this is the only book to offer a map to the future of composition

textbook for composition pedagogy courses focuses on scholarship in rhetoric and composition that has influenced classroom teaching in order to foster reflection on how theory impacts practice

the greatest problem in historical scholarship theoretically and practically is the relation between historians and their subject matter the past is gone and historians can only study its remnants on what basis do scholars select certain facts from the mass of data left from the past how do they explain the interrelationship of the facts they select what criteria do they use to evaluate their subject the 35 volumes in this set originally published between 1926 and 1990 discuss and answer these essential questions faced by historians the development of historical understanding during the 18th and 19th centuries was one of the most striking features of western culture both historiography and historical thinking advanced as never before the historial movment of the 19th century was perhaps second only to the scientific revolution of the seventeenth century in transforming western thought one consequence was extensive organisation and professionalization of research which the volumes in this set reflect

long before today's culture wars the third great awakening rocked america during the late nineteenth and early twentieth centuries evangelists such as dwight I moody and billy sunday roused citizens to renounce sin as it manifested in popular culture moral ambiguity and the changing role of women sin in the city examines three urban revivals in turn of the century chicago to show how revivalists negotiated that era's perceived racial sexual and class threats while most studies of this movement have focused on its male leaders and their interactions with society thekla ellen joiner raises new questions about gender and race by exploring third awakening revivalism as the ritualized performance of an evangelical social system defined by middle class protestant moral aspirations for urban america rather than approaching these events merely as the achievements of persuasive men she views them as choreographed collective rituals reinforcing a moral order defined by ideals of femininity masculinity and racial purity joiner reveals how revivalist rhetoric and ritual shifted from sentimentalist identification of sin with males to a more hard nosed focus on females castigating loose women whose economic and sexual independence defied revivalist ideals and its civic culture she focuses on dwight I moody s 1893 world's fair revival the 1910 chapman alexander campaign and the 1918 billy sunday revival comparing the locations organization messages and leaders of these three events to depict the shift from masculinized to feminized sin she identifies the central role women played in the third awakening as the revivalists promoted feminine virtue as the corrective to america's urban decline she also shows that even as its definition of sin became more feminized billy sunday s revivalism began to conform to chicago's emerging color line enraged by rapid social change in cities like chicago these preachers spurred protestant evangelicals to formulate a gendered and racialized moral regime for urban america yet as joiner shows ev

entertainment they used many of the modern cultural practices popularized in theaters and nickelodeons to boost the success of their mass conversions sin in the city shows that the legacy of the third awakening lives on today in the religious right's sociopolitical activism crusade for family values disparagement of feminism and promotion of spirituality in middle class racial and cultural terms providing cultural and gender analysis too often lacking in the study of american religious history it offers a new model for understanding the development of a gendered theology and set of religious practices that influenced protestantism in a period of enormous social change

provides unique insight into reconstruction s downfall and jim crow s emergence in the years and decades following the american civil war veteran abolitionists actively thought and wrote about the campaign to end enslavement immediately this study explores the late in life reflections of several antislavery memorial and historical writers evaluating the stable and shifting meanings of antebellum abolitionism amidst dramatic changes in postbellum race relations by investigating veteran abolitionists as movement chroniclers and commemorators and situating their texts within various contexts raymond james krohn further assesses the humanitarian commitments of activists who had valued themselves as the enslaved people s steadfast friends never solely against slavery post 1830 abolitionism challenged widely held anti-black prejudices as well dedicated to emancipating the enslaved and elevating people of color it equipped adherents with the necessary linguistic resources to wage a valiant sustained philanthropic fight abolitionist twilights focuses on how the status and condition of the freedpeople and their descendants affected book length representations of antislavery persons and events in probing veteran abolitionist engagement in or disengagement from an ongoing african american freedom struggle this ambitious volume ultimately problematizes scholarly understandings of abolitionisms racial justice history and legacy

to a degree unknown in practically any other discipline the pedagogical space afforded composition is the institutional engine that makes possible all other theoretical and research efforts in the field of rhetoric and writing but composition has recently come under attack from many within the field as fundamentally misguided some of these critics have been labelled new abolitionists for their insistence that compulsory first year writing should be abandoned not limiting itself to first year writing courses this book extends and modifies calls for abolition by taking a closer look at current theoretical and empirical understandings of what contributors call general writing skills instruction gwsi the curriculum which an overwhelming majority of writing instructors is paid to teach that practically every composition textbook is written to support and the instruction for which english departments are given resources to deliver the vulnerability of gwsi is hardly a secret among writing professionals and its intellectual fragility has been felt for years and manifested in several ways in persistently low status of composition as a study both within and

outside of english departments in professional journal articles and conference presentations that are growing both in theoretical sophistication and irrelevance to the composition classroom and in the rhetoric and writing field s ever increasing attention to nontraditional sites of writing behavior but to date there has been relatively little concerted discussion within the writing field that focuses specifically on the fundamentally awkward relationship of writing theory and writing instruction this volume is the first to explicitly focus on the gap in the theory and practice that has emerged as a result of the field s growing professionalization the essays anthologized offer critiques of gwsi in light of the discipline s growing understanding of the contexts for writing and their rhetorical nature writing from a wide range of cognitivist critical theoretical historical linguistic and philosophical perspectives contributors call into serious question basic tenets of contemporary writing instruction and provide a forum for articulating a sort of zeitgeist that seems to permeate many writing conferences but which has until recently not found a voice or a name

reflecting a prodigious amount of research in primary and secondary sources this book examines the efforts of american abolitionists to bring northern religious institutions to the forefront of the antislavery movement john r mekivigan employs both conventional and quantitative historical techniques to assess the positions adopted by various churches in the north during the growing conflict over slavery and to analyze the stratagems adopted by american abolitionists during the 1840s and 1850s to persuade northern churches to condemn slavery and to endorse emancipation working for three decades to gain church support for their crusade the abolitionists were the first to use many of the tactics of later generations of radicals and reformers who were also attempting to enlist conservative institutions in the struggle for social change to correct what he regards to be significant misperceptions concerning church oriented abolitionism mekivigan concentrates on the effects of the abolitionists frequent failures the division of their movement and the changes in their attitudes and tactics in dealing with the churches by examining the pre civil war schisms in the presbyterian baptist and methodist denominations he shows why northern religious bodies refused to embrace abolitionism even after the defection of most southern members he concludes that despite significant antislavery action by a few small denominations most american churches resisted committing themselves to abolitionist principles and programs before the civil war in a period when attention is again being focused on the role of religious bodies in influencing efforts to solve america s social problems this book is

especially timely
