seeking adam smith provides a fascinating insider s explanation for why business school faculty members including the author bear some responsibility for the highly destructive corporate practices evident throughout the first sixteen years of the 21st century since the great recession substantial resources and effort have been expended to incorporate ethics and corporate social responsibility into business curricula the effectiveness of these efforts has been limited because they have little impact on the technical and core business courses serving as the gateway to the highest paying jobs students and practitioners may be led to conclude falsely that the business world is an ethics free zone seeking adam smith demonstrates that greed is highly destructive motive for conducting business and the notion that greed is good is nowhere to be found in the wealth of nations despite claims by some of the world s leading economists cox offers alternative economic perspectives that are more realistic and less prone to misuse than those permeating the current business curricula seeking adam smith also contains a forward written by thomas j ward who served as senior managing partner of bear stearns during its demise and an afterward by sherron watkins enron whistle blower and time person of the year 2002

from small law offices to federal agencies all entities within the justice system are governed by complicated economic factors and face daily financial decision making a complement to strategic finance for criminal justice organizations this volume considers the justice system from a variety of economic and financial perspectives and introduces quantitative methods designed to improve the efficiency and effectiveness of organizations in both the non profit and for profit sectors using only a minimum of theory economic and financial analysis for criminal justice organizations

demonstrates how to make decisions in the justice system using multiple financial and economic models designed for readers with little knowledge of advanced mathematics quantitative analysis or spreadsheets the book presents examples using straightforward step by step processes with excel and linux calc spreadsheet software a variety of different types of decisions are considered ranging from municipal bond issuance and valuation necessary for public revenues pension planning capital investment determining the best use of monies toward construction projects and other resource planning allocation and forecasting issues from municipalities and police departments to for profit prisons and security firms the quantitative methods presented are designed to improve the efficiency and effectiveness of all organizations in the justice domain
