THE CONVERSION PROCESS: 171 LBS TO KG

THE CONVERSION FROM POUNDS TO KILOGRAMS IS A STRAIGHTFORWARD CALCULATION INVOLVING A SIMPLE MULTIPLICATION. THE CONVERSION FACTOR IS APPROXIMATELY 2.20462 LBS PER 1 KG.
