many communities across the nation still lack affordable housing and many officials continue to claim that affordable housing is an oxymoron building inexpensively is impossible they say because there are too many regulations required environmental impact statements and habitat protection laws they contend drive up the costs of construction but is this actually true in a comprehensive study of the question the authors of this eye opening book separate fact from myth with admirable clarity they describe the policy debate from its beginning review the economic theory trace the evolution of development regulation and summarize the major research on the topic in addition they offer their own research accompanied by a case study of two strikingly different washington d c suburbs they also include results of focus groups conducted in dallas denver and tucson the authors find that environmental regulatory costs as a share of total costs and processes are about the same now as they were thirty years ago even though there are far more regulations today they find too that environmental regulations may actually create benefits that could improve the value of housing although they conclude that regulations do not appear to drive up housing costs more now than in the past they do offer recommendations of ways in which the processes associated with regulations including review procedures could be improved and could result in cost savings intended primarily for professionals who are involved in or impacted by regulations from public officials planners and engineers to housing developers and community activists this book will provide useful insights and data to anyone who wants to know if and how american housing can actually be made affordable

this collection engages environmental ethical and cultural values perspectives to show how design and technology d t education actively contributes to the significant educational goal of attaining sustainable global futures an international collection of authors representing all levels of education articulate how d t research curriculum theory policy and classroom practices can synergise to contribute positively to the education of children for sustainable global futures the book offers a spectrum of theorised curriculum positions political and policy analysis and case studies of successful school practice a key word in the title is that of contribution which is construed in several senses first of d t as a vehicle for understanding the range of political and social values that arise with such a major educational challenge second of d t as an agent of critical and practical action for students as global citizens third by taking global and multiple perspectives rather than say western or mono cultural positions and fourth by demonstrating d t s capacities for working in holistic and integrative cross curricular ways the authors show how students can not only learn about their potential as humans as designers but can also develop designerly capacities that enable them to contribute meaningfully in practical ways to their communities and to wider society that is as global citizens who can apply design capability in ethical ways that are respectful of peoples cultures and environments alike

from the parking lot to the exam room doctors can improve the physical surroundings for their patients yet often they do not given the numerous and varied duties doctors must perform it may fall to the design profession to implement changes many based on research to improve healthcare experiences from location and layout to furnishings and positive distractions this book provides evidence based information about the physical environment to help doctors and those who design medical workspaces improve the experience of health care along with its research base a special aspect of this book is the integration of relevant historical material about the office practice of physicians at the beginning of the twentieth century many of their design solutions are viable today in addition to improving the physical design of healthcare facilities author ann sloan devlin is the granddaughter daughter and niece of physicians as well as the granddaughter and daughter of

nurses she worked in a hospital during college and has visited a good many practitioners offices in medical office buildings and ambulatory care settings this book addresses an overlooked location of care the doctor s office suite

in infertile environments janelle lamoreaux investigates how epigenetic research into the effects of toxic exposure conceptualizes and configures environments drawing on fieldwork in a nanjing china toxicology lab that studies the influence of pesticides and other pollutants on male reproductive and developmental health lamoreaux shows how the lab s everyday research practices bring national hormonal dietary maternal and laboratory environments into being she situates the lab s work within broader chinese history as well as the contemporary cultural and political moment in which declining fertility rates and reproductive governance and technology are growing concerns she also points to how toxicology in china is a transnational endeavor tied to both local conditions and international research agendas and infrastructures which highlights the myriad scales and scope of epigenetic environments at a moment of growing concerns about toxins endocrine disrupting chemicals and climate change lamoreaux demonstrates that epigenetic research s proliferation of environments produces new kinds of toxic relations that impact multiple generations of humans
