peter linebaugh s groundbreaking history has become an inescapable part of any understanding of the rise of capitalism in eighteenth century london the spectacle of a hanging was not simply a form of punishing transgressors rather it evidently served the most sinister purpose for a prvileged ruling class of forcing the poor population of london to accept the criminalization of customary rights and the new forms of private property necessity drove the city s poor into inevitable conflict with the changing property laws such that all the working class men and women of london had good reason to fear the example of tyburn s triple tree in this new edition peter linebaugh reinforces his original arguments with responses to his critics based on an impressive array of historical sources as the trend of capital punishment intensifies with the spread of global capitalism the london hanged also gains in contemporary relevance

artisans played a central role in the european town as it developed from the middles ages onwards their workshops were at the heart of productive activity their guilds were often central to the political and legal order of towns and their culture helped shape civic ritual

and the urban order these essays which have all been specially written for this collection explore the relationships between artisans and their towns across europe between the beginning of the early modern period and the end of the 19th century they pay special attention to the processes of economic juridicial and political change that have made the 18th and early 19th centuries a period of such significance written by leading historians of european artisans the essays question the myths about artisans that have long pervaded research in the field the leading myth was that shared by the artisans themselves the myth of decline and the belief in each generation that artisans in the past had inhabited a better age these essays open up for debate the nature of artisanship the way economic change affected craft production the political role of artisans the cultural identification of the artisans with work and masculinity and the way changing urban society and changing urban structure posed threats to which the artisans had to respond

first published in 1983 mourning dress chronicles the development of european and american mourning dress and etiquette from the middle ages to the present day highlighting similarities and differences in practices between the different social strata the result is a book which is not only of major importance to students of the history of dress but also to anyone who enjoys social history

levels of employment wage rates welfare relief sexual divisions of labor apprenticeship patterns and seasonal economic fluctuations are included in this reassessment of the standard of living of rural labor during this period of england s industrialization

medieval and renaissance drama in england is an international volume published every year in hardcover containing essays and studies as well as book reviews of the many significant books and essays dealing with the cultural history of medieval and early modern england as expressed by and realized in its drama exclusive of shakespeare

between the twelfth and seventeenth centuries gilds were the basis of industrial and commercial organization in england surprisingly however the disappearance of gilds has been neglected by historians in the most necessary luxuries ronald berger uses the mercers company of coventry to follow the eclipse of an entire trading community in one of england s premier medieval cities and manufacturing centers berger charts the difficulties faced by mercers and grocers in a growing capitalist economy and discusses their

unsuccessful efforts to maintain their prosperity the book helps to explain both the development of a new urban system and the rise of shops in midland england it shows how shops replaced markets and fairs and uses the economics of the fashion trades to explain why provincial shops could not overcome the competition put forward by the metropolis the most necessary luxuries unites the fields of social urban and economic history to explain the decline of a medieval city the evolution of the english urban middle class and the transformation from an amalgam of wealthy wholesalers and distributors of luxury goods to an association of mere shopkeepers it demonstrates that the rise of commercial capitalism between 1550 and 1700 in england undermined the medieval economy that was based on protected markets restrictive trading practices and entrenched oligarchies that dominated towns

first published in 2005 silver is unique among the decorative arts in that its raw material is both inherently valuable and infinitely reusable its ownership has been a social bench mark and its form has exercised the skills of sculptors designers chasers and engravers but ultimately it could be and normally was melted down and refashioned quite without sentiment because of this constant recycling the survival of any individual object is quite random and unrelated to its uniqueness or otherwise in its period hitherto plate historians have focused on individual objects almost to the exclusion of the context social or economic from which they came but now that context is seen as crucial in understanding historic plate so in the first section of this book each chapter considers contemporary attitudes and usage

this collection of original essays written by friends colleagues and former students is a tribute to charles wilson running through the essays is the theme of enterprise in history and especially in the two fields in which charles wilson has been pre eminent business history and the economic relations of england and the netherlands this volume presents a comprehensive set of studies of diverse examples of the forms consequences and interpretations of economic enterprise in history

this study examines the darker side of england s culture of economic improvement between 1640 and 1720 it is often suggested that england in this period grew strikingly confident of its prospect for unlimited growth indeed merchants inventors and others promised to achieve immense profit and abundance such flowery promises were then as now prone to perversion however this volume is concerned with the taming of incipient capitalism how a society in the past responded when promises of wealth creation went badly wrong it reveals a history of numerous visible hands taming incipient capitalism a story that adam smith and his admirers have long set aside the notion of projecting played a key role in this process thriving theatre literature and popular culture in the age of ben jonson began elaborating on predominantly negative images of entrepreneurs or projectors as people who pursued crown s and their

own profits at the public s expense this study examines how the ensuing public distrust came to shape the negotiation in the subsequent decades over the nature of embryonic capitalism the result is a set of fascinating discoveries by scrutinising greedy projectors the incipient public sphere helped reorient the practices and priorities of entrepreneurs and statesmen away from the most damaging of rent seeking behaviours far from being a recent response to mainstream capitalism ideas about socially responsible business have long shaped the pursuit of wealth power and profit taming capitalism before its triumph unravels the rich history of broken promises of public service and ensuing public suspicion a story that throws fresh light on england s transition to capitalism especially the emergence of consumer society and the financial revolution towards the end of the seventeenth century

this book is about the objects people owned and how they used them twenty three specially written essays investigate the type of things that might have been considered everyday objects in the medieval and early modern periods and how they help us to understand the daily lives of those individuals for whom few other types of evidence survive for instance people of lower status and women of all status groups everyday objects presents new research by specialists from a range of disciplines to assess what the study of material culture can contribute to our understanding of medieval and early modern societies extending and developing key debates in the study of the everyday the chapters provide analysis of such things as ceramics illustrated manuscripts pins handbells carved chimneypieces clothing drinking vessels bagpipes paintings shoes religious icons and the built fabric of domestic houses and guild halls these things are examined in relation to central themes of pre modern history for instance gender identity space morality skill value ritual use belief public and private behaviour continental influence materiality emotion technical innovation status competition and social mobility this book offers both a collection of new research by a diverse range of specialists and a source book of current methodological approaches for the study of pre modern material culture the multi disciplinary analysis of these everyday objects by archaeologists art historians literary scholars historians conservators and museum practitioners provides a snapshot of current methodological approaches within the humanities although analysis of material culture has become an increasingly important aspect of the study of the past previous research in this area has often remained confined to subject specific boundaries this book will therefore be an invaluable resource for researchers and students interested in learning about important new work which demonstrates the potential of material culture study to cut across traditional historiographies and disciplinary boundaries and access the lived experience of individuals in the past

unforgettable story of illicit romance in a time of enlightenment and social upheaval 1760 spitalfields anna butterfield s life is about to change forever as she moves from her idyllic suffolk home to be introduced into london society a chance encounter with a french silk weaver henri draws her in to the volatile world of the city s burgeoning silk trade henri is working on his master piece to become a master weaver and freeman anna longs to become an artist while struggling against pressure from her uncle s family to marry a wealthy young lawyer as their lives become ever more intertwined henri realizes that anna s designs could give them both an opportunity for freedom but his world becomes more dangerous by the day as riots threaten to tear them apart forever

in the early modern period the term enthusiasm was a smear word used to discredit the dissenters of the radical reformation as dangerous religious fanatics in england the term gained prominence from the civil war period and throughout the eighteenth century anglican ministers and the proponents of the enlightenment used it more widely against paracelsian chemists experimental philosophers religious dissenters and divines astrologers or anyone claiming superior knowledge but who exactly were these enthusiasts what did they believe in and what impact did they have on their contemporaries this book concentrates on the notorious case of the french prophets as the epitome of religious enthusiasm in early enlightenment england based on new archival research it retraces the formation development and evolution of their movement and sheds new light on key contemporary issues such as millenarianism censorship and the press blasphemy dissent and toleration and madness

analyses the effects of the industrial revolution on london s working population

one cannot conceive of capitalism without labor yet many of the current debates about economic development leading to industrialization fail to directly engage with labor at all this collection of essays strives to correct this oversight and to reintroduce labor into the great debates about capitalist development and economic growth before the industrial revolution by attending to the effects of specific regulatory technological social and physical environments on producers and production in a set of specific industries these essays use an ecological approach that demonstrates how productivity knowledge and regime changed between 1400 and 1800 this book will be of interest to researchers in history especially labor history and european economic development

drawing upon archival material as well as the drama popular verse and pamphlets this book reads representations of masters and servants in relation to key renaissance preoccupations apprentices journeymen male domestic servants maidservants and stewards burnett argues were deployed in literary texts to address questions about the exercise of power social change and the threat of economic upheaval in this way writers were instrumental in creating servant cultures and spaces within which forms of political resistance could be realized

this is a much revised version of professor cottret's acclaimed study of the huguenot communities in england first published in french by aubier in 1985 the huguenots in england presents a detailed sympathetic assessment of one of the great migrations of early modern europe examining the social origins aspirations and eventual destiny of the refugees and their responses to their new found home a protestant terre dexil bernard cottret shows how for the poor weavers carders and craftsmen who constituted the majority of the exiles the experience of religious persecution was at once personal calamity disruptive of home and family and heaven sent economic opportunity which many were quick to exploit the individual testimonies contained in consistory registers contain a wealth of personal narrative reflection and reaction enabling professor cottret to build a fully rounded picture of the huguenot experience in early modern england in an extended afterword professor emmanuel le roy ladurie considers the huguenot phenomenon in the wider context of the contrasting british and french attitudes to religious minorities in the early modern period

stratford made the man but london made the phenomenon that is shakespeare this volume takes an historical approach to shakespeare s connections with london it explores stratford s various links with the capital significant locations for shakespeare s work people with whom he associated his resistance to pressure from the city authorities and the cultural diversity of early modern london among many aspects of his life in the city and its environs it covers the playhouses in shoreditch his associations with bishopsgate his brother edmund s residence on bankside and elements of london life that went into the making of falstaff being forest born he was always an outsider and could never have been or felt accepted as a citizen we find him repeatedly a sojourner in

the city on the move his home and family lay in stratford despite his success in the capital we might almost imagine him to have been a reluctant londoner shakespeare and london draws on a range of documentary sources including city parish registers county sessions records and the archives of london s bridewell hospital it sets out details about those who inhabited shakespeare s milieu or played some part in shaping his writing and acting career this volume is ideal reading for undergraduates graduates and specialists of shakespeare studies

cities and solidarities charts the ways in which the study of individuals and places can revitalise our understanding of urban communities as dynamic interconnections of solidarities in medieval and early modern europe this volume sheds new light on the socio economic conditions the formal and informal institutions and the strategies of individual town dwellers that explain the similarities and differences in the organisation and functioning of urban communities in pre modern europe it considers how communities within cities and towns are constructed and reconstructed how interactions amongst members of differing groups created social and economic institutions and how urban communities reflected a sense of social cohesion in answering these questions the contributions combine theoretical frameworks with new digital methodologies in order to provoke further discussion into the fundamental nature of urban society in this key period of change the essays in this collection demonstrate the complexities of urban societies in pre modern europe and will make fascinating reading for students and scholars of medieval and early modern urban history

the book offers an analysis of joachim jungius texturæ contemplatio a hitherto unpublished manuscript written in german and latin that deals with weaving knitting and other textile practices attempting to present as well various fabrics and textile techniques in a scientifical and even mathematical framework the book aims to provide the epistemological technical and historic framework for jungius manuscript inspecting fabrics weaving techniques as well as looms and other textile machines in holy roman empire during the early modern period it also offers a unique investigation of the notion and metaphor of texture during this period and explores within the wider context of the meeting or trading zones thesis the relations between artisans and natural philosophers during the 17th century the book is of interest to historians of philosophy and mathematics as well as historians of technology

working subjects in early modern english drama investigates the ways in which work became a subject of inquiry on the early modern stage and the processes by which the drama began to forge new connections between labor and subjectivity in the period the essays assembled here address fascinating and hitherto unexplored questions raised by the subject of labor as it was taken up in the drama

of the period how were laboring bodies and the goods they produced marketed and consumed represented onstage through speech action gesture costumes and properties how did plays participate in shaping the identities that situated laboring subjects within the social hierarchy in what ways did the drama engage with contemporary discourses social political economic religious etc that defined the cultural meanings of work how did players and playwrights define their own status with respect to the shifting boundaries between high status low status legitimate illegitimate profitable unprofitable skilled unskilled formal informal male female free bound paid unpaid forms of work merchants usurers clothworkers cooks confectioners shopkeepers shoemakers sheepshearers shipbuilders sailors perfumers players magicians servants and slaves are among the many workers examined in this collection offering compelling new readings of both canonical and lesser known plays in a broad range of genres including history plays comedies tragedies tragic comedies travel plays and civic pageants this collection considers how early modern drama actively participated in a burgeoning proto capitalist economy by staging england s newly diverse workforce and exploring the subject of work itself

the first comprehensive history of seventeenth century london told through the lives of those who experienced it the gunpowder plot the civil wars charles is execution the plague the great fire the restoration and then the glorious revolution the seventeenth century was one of the most momentous times in the history of britain and londoners took center stage in this fascinating account margarette lincoln charts the impact of national events on an ever growing citizenry with its love of pageantry spectacle and enterprise lincoln looks at how religious political and financial tensions were fomented by commercial ambition expansion and hardship in addition to events at court and parliament she evokes the remarkable figures of the period including shakespeare bacon pepys and newton and draws on diaries letters and wills to trace the untold stories of ordinary londoners through their eyes we see how the nation emerged from a turbulent century poised to become a great maritime power with london at its heart the greatest city of its time

the great fire of london was the greatest catastrophe of its kind in western europe although detailed fire precautions and fire fighting arrangements were in place the fire raged for four days and destroyed 13 200 houses 87 churches and 44 of the city of london s great livery halls the great fire of 1666 closely followed by the great plague of 1665 as the antiquary anthony wood wrote left london much impoverished discontented afflicted cast downe in this comprehensive account stephen porter examines the background to 1666 events leading up to and during the fire the proposals to rebuild the city and the progress of the five year programme which followed he places the fire firmly in context revealing not only its destructive impact on london but also its implications for town planning building styles and fire precautions both in the capital and provincial towns

all men and both sexes explores the use of such universal terms as people man or human in early modern england from the civil war through the enlightenment such language falsely implies inclusion of both men and women when actually it excludes women recent scholarship has focused on the rights of man doctrine from the enlightenment and the french revolution as explanation for women s exclusion from citizenship according to hilda smith we need to go back further to the english revolution and the more grounded but equally restricted values tied to the free born englishman citing educational treatises advice literature to young people guild records popular periodicals and parliamentary debates she demonstrates how the male maturation process came to define the qualities attached to citizenship and responsible adulthood which in turn became the basis for modern individualism and liberalism by the eighteenth century a new discourse of sensibility was describing women as dependent beings outside the state in a separate sphere and in need of protection this excluded women from reform debates forcing them to seek not an extension of a democratic franchise but a specific women s suffrage focused on gender difference

immigration is not only a modern day debate major change in europe in the sixteenth and seventeenth centuries led to a surge of political and religious refugees moving across the continent estimates suggest that from 1550 to 1585 around 50 000 dutch and walloons from the southern netherlands settled in england and in the late seventeenth century 50 000 huguenots from france followed suit the majority gravitated towards london which already a magnet for merchants and artisans across the centuries began a process of major transformation new skills capital technical know how and social networks came with these migrants and helped to spark london s cosmopolitan flair and diversity but the early experience of many of these immigrants in london was one of hostility serving to slow down the adoption and expansion of new crafts and technologies immigrants and the industries of london 1500 1700 examines the origins and the changing face and shape of many trades crafts and skills in the capital in this transformative period it focuses on three crafts in particular silk weaving beer brewing and the silver trade crafts which had relied heavily on foreign skills in the 16th century and had become major industries in the capital by the 18th century each craft was established by a different group of immigrants distinguished not only by their social backgrounds social organisation identity motives migration pattern and experience

and links with their home country but also by the nature of their reception assimilation and economic contribution change was a protracted process in the london of the day immigrants endured inferior status discrimination and sometimes exclusion and this affected both their ability to integrate and their willingness to share trade secrets and resistance by the english population meant that the adoption of new skills often took a long time in some cases more than three centuries to complete the book places the adoption of new crafts and technologies in london within a broader european context and relates it to the phenomenal growth of the metropolis and technological developments within these specific trades it throws new perspectives on the movement of skills from europe and the transmission of know how from the immigrant population to english artisans the book explores how through enterprise and persistence the immigrants contribution helped transform london from a peripheral and backward european city to become the workshop of the world by the nineteenth century by way of conclusion the book brings the current immigration debate full circle to examine the lessons we can draw from this early modern experience

from jewish clothing merchants to bangladeshi curry houses ancient docks to the 2012 olympics the area east of the city has always played a crucial role in london s history the east end as it has been known was the home to shakespeare s first theater and to the early stirrings of a mass labor movement it has also traditionally been seen as a place of darkness and despair where jack the ripper committed his gruesome murders and cholera and poverty stalked the victorian streets in this beautifully illustrated history of this

iconic district john marriott draws on twenty five years of research into the subject to present an authoritative and endlessly fascinating account with the aid of copious maps archive prints and photographs and the words of east londoners from seventeenth century silk weavers to cockneys during the blitz he explores the relationship between the east end and the rest of london and challenges many of the myths that surround the area
