writer f scott fitzgerald s career itself is a metaphor for the vagaries of book publishing if fitzgerald would have had his way we would today refer to the great gatsby as either gold hatted gatsby trimalchio in west egg or the high bouncing lover a few years before gatsby fitzgerald had become a literary sensation at the age of 23 helen hooven santmyer a contemporary of fitzgerald s would not have a successful novel published until she was 88 and living in a nursing home in this book the author explores that mysterious place in publishing where art and commerce can either clash mesh or both along the way a wide range of authors from the literary greats to today s commercial superstars editors agents and publishers share their thoughts insights and experiences what inspires writers john steinbeck for example wrote every novel as if it were his last as if death were imminent why are some books successful and appreciated while others fall into oblivion the answers are often elusive never absolute but the stories and anecdotes are always fascinating

this book analyses the founding years of consumer law and consumer policy in europe it combines two dimensions the making of national consumer law and the making of european consumer law and how both are intertwined the chapters on germany italy the nordic countries and the united kingdom serve to explain the economic and the political background which led to different legal and policy approaches in the then old member states from the 1960s onwards the chapter on poland adds a different layer the one of a former socialist country with its own consumer law and how joining the eu affected consumer law at the national level the making of

european consumer law started in the 1970s rather cautiously but gradually the european commission took an ever stronger position in promoting not only european consumer law but also in supporting the building of the european consumer organisation beut the umbrella organisation of the national consumer bodies the book unites the early protagonists who were involved in the making of consumer law in europe guido alpa ludwig krämer ewa letowska hans w micklitz klaus tonner iain ramsay and thomas wilhelmsson supported by the younger generation aneta wiewiórowska domagalska mateusz grochowski and koen docter who reconstructs the history of beut niklas olsen and thomas roethe analyse the construction of this policy field from a historical and sociological perspective this book offers a unique opportunity to understand a legal and political field that of consumer law and policy which plays a fundamental role in our contemporary societies

this 1991 study deals with a specific set of institutions in nineteenth century athens relying on matrimonial contracts travellers accounts memoirs and popular literature the authors show how distinctive forms of marriage kinship and property transmission evolved in athens in the nineteenth century these forms then became a feature of wider greek society which continued into the twentieth century greece was the first post colonial modern nation state in europe whose national identity was created largely by peasants who had migrated to the city as athenian society became less agrarian a new mercantile group superseded and incorporated previous elites and went on to dominate and control the new resources of the nation state such groups developed their own more mobile systems of property transmission mostly in response to external pressures of a political and economic character this is a persuasive piece of detective work which has advanced our knowledge of modern greece it is a model for scholarship on the development of family and other intimate ideologies where nation states encroach upon local consciousness

in the middle east and the making of the modern world cyrus schayegh takes up a fundamental problem historians face how to make sense of the spatial layeredness of the past he argues that the modern world s ultimate socio spatial feature was not the oft studied processes of globalization or state formation or urbanization rather it was fast paced mutually transformative intertwinements of cities regions states and global circuits a bundle of processes he calls transpatialization to make this case schayegh s study pivots around greater syria bilad all sham in arabic which is roughly coextensive with present day syria jordan lebanon and israel palestine from this region schayegh looks beyond to imperial and global connections diaspora communities and neighboring egypt iraq and turkey and he peers deeply into bilad all sham at cities and their ties and at global economic forces the ottoman and european empire states and the post ottoman nation states at work within the region he shows how diverse socio spatial intertwinements unfolded in tandem during a transformative stretch of time the mid nineteenth to mid twentieth centuries and concludes with a postscript covering the 1940s to 2010s

the twisting and weaving of nature s materials grasses twigs rushes and vines into useful and beautiful forms seems almost instinctive in man perhaps it came to him as the nest weaving instinct comes to birds for at first he used it as they do in the building of his house later shields and boats were formed of wicker work but how long ago the first basket was made no one is wise enough to tell us to day indian tribes in south america weave baskets from their native palms south african negroes use reeds and roots while the chinese and japanese are wonderful workmen in this as in other arts and industries but basketry has come down to us more directly

through the american indian generations of these weavers have produced masterpieces many of which are preserved in our museums and the young basket maker need not go on long pilgrimages to study the old masters of his craft here at last as in england the value of manual training is being realized and basketry is taking an important place following the kindergarten and enabling the child to apply the principles he has learned there he still works from the centre out and weaves as he wove his paper mats but permanent materials have replaced the perishable ones and what he makes has an actual value

the making of new world slavery argues that independent commerce geared to burgeoning consumer markets was the driving force behind the rise of plantation slavery the baroque state sought successfully to feed upon this commerce and with markedly less success to regulate slavery and racial relations to illustrate this thesis blackburn examines the deployment of slaves in the colonial possessions of the portuguese the spanish the dutch the english and the french plantation slavery is shown to have emerged from the impulses of civil society not from the strategies of individual states robin blackburn argues that the organization of slave plantations placed the west on a destructive path to modernity and that greatly preferable alternatives were both proposed and rejected finally he shows that the surge of atlantic trade predicated on the murderous toil of the plantations made a decisive contribution to both the industrial revolution and the rise of the west

in this history of japanese involvement in northeast china the author argues that japan s military seizure of manchuria in september 1931 was founded on three decades of infiltration of the area this incremental empire building and its effect on japan are the focuses of this book the principal agency in the piecemeal growth of japanese colonization was the south manchurian railway company and by the mid 1920s japan had a deeply entrenched presence in manchuria and exercised a dominant economic and political influence over the area japanese colonial expansion in manchuria also loomed large in japanese politics military policy economic development and foreign relations and deeply influenced many aspects of japan s interwar

history

this book provides a new approach to the historical treatment of indigenous peoples sovereignty and property rights in australia and new zealand by shifting attention from the original european claims of possession to a comparison of the ways in which british players treated these matters later bain attwood not only reveals some startling similarities between the australian and new zealand cases but revises the long held explanations of the differences he argues that the treatment of the sovereignty and property rights of first nations was seldom determined by the workings of moral principle legal doctrine political thought or government policy instead it was the highly particular historical circumstances in which the first encounters between natives and europeans occurred and colonisation began that largely dictated whether treaties of cession were negotiated just as a bitter political struggle determined the significance of the treaty of waitangi and ensured that native title was made in new zealand
