norbert wunner presents an analysis of the main factors which have contributed to the slow and painful structural adjustment process and to the delay of economic reforms in transition countries from a political economy perspective

this book analyzes the political economic implications of system transformation as experienced now in central and eastern europe and in china the whole societal organization being in motion and economic activity being in a deep recession political leaders will find it extremely difficult to secure consensus and support for redesigning institutions and stabilizing and restructuring activity the ensuing process is certainly not one of optimal control but has rather evolutionary characteristics leading constantly to paradoxes and dilemmas the first part of the book discusses different paradigms within which the complex process of transformation could fruitfully be analyzed democratic theory bargaining theory efficiency theory institutionalism all contribute to the understanding of the complex phenomena key topics of the second part are among others policy aspects of privatization adjustment of fiscal system and policy industrial restructuring the different case of china the book illustrates that the first euphoria of planning the transition to markets was rather naive analytically and politically transformation is not only an economic puzzle not even in the first place it is very much of a sociopolitical problem and has to be treated as such the book can be used as a reader or as background literature in corresponding course

the idea for this volume was conceived by frederick praeger founder of westview press who asked roland vaubel if he would put together a collection of chapters on the public choice approach to the study of international organizations vaubel felt it would be useful to have a coeditor from the united states and thomas d willett enthusiastically agreed to take on these duties

ilchman and uphoff believe that political science has failed in the past to meet its own standards of rigor and cogency and does not meet standards of usefulness and relevance set by others the political economy of change attempts to remedy these shortcomings by expanding the limits of social science analysis to deal with problems of allocation and productivity in all spheres of public choice not just the economic sphere

this theoretical and practical book builds on the knowledge that sustainability s value pluralism cannot be reconciled with the value monism of classical neoclassical nationalist or socialist political economy developing the concept of sustainability value sv which requires integrating economic exchange social labour environmental intrinsic and cultural use values in all processes of extraction manufacturing trade consumption and disposal the book reformulates our understanding of key political economy topics such as trade investment preference formation corporate governance and the role of the state the book illustrates how sv is being realised via multi stakeholder networks which forming at the community national and global levels enable the required cross value deliberation

the political economy of regionalism the case of southern africa challenges prevailing wisdom showing how ruling political elites and big business join forces with certain external actors in order to promote market integration and economic globalization boost regimes and to satisfy group specific and even personal interests only rarely do these forms of regionalism contribute to the poor and disadvantaged who instead opt out and survive through informal economic regionalisms or seek to create regionalisms rooted in civil society
