seeing like a city means recognizing that cities are living things made up of a tangle of networks built up from the agency of countless actors cities must not be considered as expressions of larger paradigms or sites of human effort and organization alone within their density size and sprawl can be found a world of symbols bodies buildings technologies and infrastructures it is the machine like combination interaction and confrontation of these different elements that make a city such a view

locates urban outcomes and influences in the character of these networks which together power urban life allocating resources shaping social opportunities maintaining order and simply enabling life more than the silent stage on which other powers perform such networks represent the essence of the city they also form an important political project a politics of small interventions with large effects the increasing evidence for an anthropocene bears out the way in which humanity has stamped its footprint on the planet by constructing urban forms that act as systems for directing life in ways that create both immense power and immense constraint

encountering the city provides a new and sustained engagement with the concept of encounter drawing on cutting edge theoretical work classic writings on the city and rich empirical examples this volume demonstrates why encounters are significant to urban studies politically philosophically and analytically bringing together a range of interests from urban multiculture systems of economic regulation security and suspicion to more than human geographies soundscapes and spiritual experience encountering the city argues for a more nuanced understanding of how the concept of encounter is used this interdisciplinary collection thus provides an insight into how scholars writing on and in the city mobilise theorise and challenge the concept of encounter through empirical cases taken from africa asia australia europe north america and south america these cases go beyond conventional accounts of urban conviviality to demonstrate how encounters destabilise rework and produce difference fold together complex temporalities materialise power and transform political relations in doing so the collection retains a critical eye on the forms of regulation containment and inequality that shape the taking place of urban encounter encountering the city is a valuable resource for students and researchers alike

cities beyond the west and embraces the global south as the epicentre of urbanism this handbook engages the complex ways in which cities of the global south and the global north are rapidly shifting the imperative for multiple genealogies of knowledge production as well as a diversity of empirical entry points to understand contemporary urban dynamics the handbook works towards a geographical realignment in urban studies bringing into conversation a wide array of cities across the global south the ordinary mega global and peripheral with interdisciplinary contributions from a range of leading international experts it profiles an emergent and geographically diverse body of work the contributions draw on conflicting and divergent debates to open up discussion on the meaning of the city in or of the global south arguments that are fluid and increasingly contested geographically and conceptually it reflects on critical urbanism the macro and micro scale forces that shape cities including ideological demographic and technological shifts and constantly changing global and regional economic dynamics working with southern reference points the chapters present themes in urban politics identity and environment in ways that re frame our thinking about cities the handbook engages the twenty first century city through a southern urban lens to stimulate scholarly professional and activist engagements with the city

in an innovative contribution to the challenging of disciplinary boundaries edward j ahearn juxtaposes works of literature with the writings of social scientists to discover how together they illuminate city life in ways that neither can accomplish separately ahearn s argument spans from the second half of the nineteenth century in western europe to the present day united states and encompasses a wide range of literary genres and sociological schools for example charles baudelaire s essays on the city are viewed alongside the work of emile durkheim and georg simmel bertolt brecht s jungle of cities heightens the arguments of louis wirth and robert park richard wright s native son and saul bellow s the adventures of augie march are re visioned in tandem with works by william julius wilson and others herman melville s bartleby the scrivener poses a challenge to james q wilson s bureaucracy toni morrison s historical novel jazz is buttressed by the career of robert moses and the revisionist work of historians hilary ballon and kenneth t jackson and don delillos s cosmopolis

comes into brilliant focus in the light of arguments on world cybercities by david harvey saskia sassen and manuel cassels resisting the temptation to ignore contradictions for the sake of interpretation ahearn instead offers the reader a view of the modern city as complex as his subject matter here the methodologies and knowledge generated by the social sciences are both complemented and subverted by the experience of city life as portrayed in literature with its diverse narrative tactics and shifting points of view which can be as disorienting to the reader as a foreign city is to an arriving immigrant literature reinforces the importance of method and outlook in the social sciences ultimately ahearn suggests neither literature nor the social sciences can capture the experience of urban misery

ecologies of affect offers a synthetic introduction to the felt dynamics of cities and the character of places the contributors capture the significance of affects including desire nostalgia memory and hope in forming the identity and tone of places the critical intervention this collection of essays makes is an active consistent engagement with the virtualities that produce and refract our idealized attachments to place contributors show how place images and attempts to build communities are rather than abstractions fundamentally tied to and revolve around such intangibles we understand nostalgia desire and hope as virtual that is even though they are not material they are nevertheless real and must be accounted for in this book the authors take up affect emotion and emplacement and consider them in relation to one another and how they work to produce and are produced by certain temporal and spatial dimensions the aim of the book is to inspire readers to consider space and place beyond their material properties and attend to the imaginary places and ideals that underpin and produce material places and social spaces this collection will be useful to practitioners and students seeking to understand the power of affect and the importance of virtualities within contemporary societies where intangible goods have taken on an increasing value

the concept of governance has evolved into one of the most important but also controversial concepts in urban politics while it encourages co operation participation and collective construction at the same time it has brought about new forms of public demission oligarchic regimes and less local democracy the dilemmas accompanying these changes are particularly relevant when observing the cities of southern europe whose socio cultural specificities very much structure local political and policy materialisations bringing together a team of leading scholars from across the social sciences this volume examines the issues of urban governance in the southern european context illustrated by case studies of several main cities and metropoles on the north mediterranean coast it introduces and critically analyses the latest theories and approaches to urban governance it questions how the real

or socio cultural notion of city seems to have been separated from that of the political city and explores how more integrated socio political forms might be developed it looks at current structures dynamics and cultures of governance in urban development and questions whether they are well adapted to new realities and challenges or whether there are significant imbalances causing limited or fragmented political administrative visions by considering both the long mediterranean history along with the recent but enduring global economic and political developments this book argues that southern european cities will have to depend greatly upon its own socio cultural networks dynamics and cosmopolitan evolution making the most of the region s characteristic urban strengths as trading hubs with rich hinterlands and large and varied population

this professional book introduces an analytical framework of urban informality perspectives in the middle east that is aligned with the global south the context of egypt lebanon and jordan in the middle east is the transregional focus of this book in these contexts the book opens a new arena of academic discussion on the theory and practice of urban informality urban informality experiences and urban sustainability transitions in middle east cities questions urban informality as a site of transitions interrelated and interlinked with urban sustainability transitions in speedy changes in a given environment the book presents urban informality sustainability transitions regarding resilience and adaptability that require shifts in urban systems shifts from a static process to a dynamic process that eradicates the fragmentation between the tensions anxieties and pressures of four modes of production reproduction consumptions and distribution of goods and services in the city and its practices finally through eleven chapters the concluding remarks explore to what extent and how can urban informality transitions be sustainable

this book straddles two worlds and attempts to bring them together that of lefebvre s marxism on the one hand and that of real estate development on the other lefebvre has now become a household name amongst many contemporary marxists especially those with an interest in urban planning and certain quarters of the architectural profession however his work is far less well known by real estate
