this book engages in a critical reading of cultural knowledge by cultural knowledge i refer to cultural dimensions as introduced by geert hofstede edward t hall and fons trompenaars their research has manifold been taught to individuals who will face an intercultural setting in their business career at some point in the future it aims to create understanding for cultural differences in order to decrease emotional discomfort and enhance business success of those who acquire the knowledge at the same time it claims to present a foundation for respect for cultural differences since it gives an imaginative room to them if one studies the knowledge s he will be aware of cultural differences and therefore treat them with respect the book is composed of two perspectives on cultural knowledge in a first step the book turns to post colonial theory post colonialism argues how a western perspective has framed cultural identities and how these representations are flawed by colonial thinking in a second step a levinasian perspective is taken on cultural knowledge the french philosopher emmanuel levinas was deeply concerned with our way of approaching the other he understood the other to be incomprehensible to our understanding the other s otherness cannot be grasped by

framing her him into categories he argued that every encounter is of ethical nature and encouraged each individual to show infinite responsibility towards the other that is not confined by any pre knowledge the book concludes that cultural knowledge has been exposed to significant limitations these limitations are mainly a product of control interests individuals who acquire cultural knowledge and are not made aware of its limitations face consequences that may compromise their respect for cultural differences even though cultural knowledge presents itself as foundation for respect it prioritizes understanding for the sake of control as a consequence respectful representations are not given and respect for cultural differences is only supported as long as it does not threaten control ultimately this book shall present a plea for trainers and teachers of cultural knowledge to become acquainted with the limitations reflect on them and forward this knowledge to their students it shall also encourage researchers of cultural differences and other scholars to reflect and perhaps improve on it

narrative perspective is the faculty through which humans understand structure and explore the world that confronts them this is the first volume to bring together the theoretical study of perspective with the rigor of experimental studies combining work in narratology with that in linguistics philosophy film studies literary theory and cognitive psychology the chapters are grouped thematically and drawn together by the editors who provide guidance through this new and fascinating interdisciplinary territory

the trauma of the holocaust at the personal individual level these were soon followed by a considerable number of books dealing with the moral and religious questions revolving around the role of the lay and spiritual leaders of the doomed jewish communities especially those involved in the jewish councils as well as god's responsibility toward the chosen people

a buddhist perspective on the fault of eating meat each year around 120 billion land animals and 1.5 trillion sea animals are killed for human consumption this book provides compelling arguments on the wisdom of giving up meat and adopting a vegetarian diet lama phurba tashi rinpoche draws on buddhist teachings both sutra and tantra to support his case while matthieu ricard refers to scientific evidence on the environmental damage caused by the industrial farming of animals and commercial fishing both authors invite us to extend our compassion to reduce the vast number of animals raised and slaughtered for human consumption

behaviour ecosystemic focusing on positive and negative interactions between teachers and students within the school and those that externally affect the school these interactions are seen as accounting for behaviour ecological focusing on the influence of systems and the environment in accounting for behaviour the aim of the book is to enable the reader to develop a structured approach to emotional and behavioural problems by drawing on one or more of the above perspectives

this book reassesses av dicey s legacy in political and legal thought through the reflections of leading scholars who consider his importance not only in today s british constitutional and legal culture but also in other foreign constitutional cultures every student in law and in politics every law faculty and most legal practitioners in the world are aware of who albert venn dicey 1835 1922 was and what he wrote yet this fame does not mean that dicey s legacy is not controversial and debated in the present world this book considers why dicey s late victorian constitutional and political thinking is still alive in spite of all the transformations that have taken place in public law in the uk in the last hundred years the book argues that dicey managed to grasp and to crystallise something of the british political identity and culture hence the long lasting fire power of his constitutional and political thinking the book also considers that there is something even more prescient in dicey s writings for the uk but also for countries that have adopted his understanding of the rule of law and or of parliamentary government dicey identified one of the most fundamental political issues at stake the nature of the relationship between public law and democracy the book looks closely at the alliance between public law and democratic spirit this alliance needs to be reassessed from a legal historical and comparative perspective this edited collection gathering authors from different countries from various legal systems and from diverse backgrounds tackles this task

this book approaches the arctic from a postcolonial perspective taking into account both its historical status as a colonised region and new economically driven forms of colonialism one catchphrase currently being used to describe these new colonialisms is the scramble for the arctic this cross disciplinary study featuring contributions from an international team of experts in the field offers a set of broadly postcolonial perspectives on the european arctic which is taken here as ranging from greenland and iceland in the north atlantic to the upper regions of norway and sweden in the

European high north while the contributors acknowledge the renewed scramble for resources that characterises the region it also argues the need to unscramble the Arctic wresting it away from its persistent status as a fixed object of western control and knowledge instead the book encourages a reassertion of micro histories of Arctic space and territory that complicate western grand narratives of technological progress politico economic development and ecological state change it will be of interest to scholars of Arctic studies across all disciplines

what does a one hour contemporary orchestral piece by georg friedrich haas have in common with a series of glitch noise electronic tracks by pan sonic this book proposes that despite their differences they share a particular understanding of sound that is found across several quite distinct genres of contemporary art music the ecstatic materialist perspective sound in the ecstatic materialist perspective is considered as a material mass or element unfolding in time encountered by a listener for whom the experience of that sound exceeds the purely sonic without becoming entirely divorced from its materiality it is material by virtue of the focus on the texture consistency and density of sound it is ecstatic in the etymological sense that is to say that the experience of this sound involves an instability an inclination to depart from material appearance an ephemeral and transitory impulse in the very perception of sound to something beyond but still related to it by examining musical pieces from spectralism to electroacoustic domains from minimalism to glitch electronica and dubstep this book identifies the key intrinsic characteristics of this musical perspective to fully account for this perspective on sonic experience listener feedback and interviews with composers

and performers are also incorporated sound in the ecstatic materialist perspective is the common territory where composers sound artists performers and listeners converge

this thesis approaches the phenomenon of open source software oss from a managerial and organisational point of view in a slightly narrower sense this thesis studies commercialisation aspects around community driven open source the term community driven signifies open source projects that are managed steered and controlled by communities of volunteers as opposed to those that are managed steered and controlled by single corporate sponsors by adopting a business ecology perspective this thesis places emphasis on the larger context within which the commercialisation of oss is embedded e g global and collaborative production regimes ideological foundations market characteristics and diffuse boundary conditions because many business benefits arise as a consequence of the activities taking place in the communities and ecosystems around open source projects a business ecology perspective may be a useful analytical guide for understanding the opportunities challenges and risks that firms face in commercializing oss there are two overarching themes guiding this thesis the first theme concerns the challenges that firms face in commercialising community driven open source there is a tendency in the literature on business ecosystems and open source to emphasise the benefits opportunities and positive aspects of behaviour at the expense of the challenges that firms face however business ecosystems are not only spaces of
